Duties	Power and duty to recommend a comprehensive, long-term climate action plan; monitor and recommend updates for the climate action plan based on quantified metrics to measure and evaluate reduction of greenhouse gas emissions and community benefits; provide the Council advice on how to strategically accelerate Chico's progress towards achieving the goals in the climate action plan; and make recommendations to Council on federal, state and regional policies and programs related to greenhouse gas reduction and community adaptation and resiliency to climate change.	
Composition	Consists of seven members, with three of the members having experience in at least one of the following areas: social or community services, greenhouse gas emission accounting, energy, transportation, economics, community engagement, or business leadership or ownership.

PLANNING COMMISSION 7 Members - 4 positions needed		
Duties	Prepares and recommends for adoption by the Council a comprehensive, long-term general plan, or amendments thereto, for the physical development of the City and of any land outside its boundaries which, in the commission's judgment, bears relation to the physical development of the City; and to include such elements in the general plan as recommended by the commission or required by the planning law of the state. Prepares and recommends to Council precise plans for implementation of the general plan. Performs duties in reference to zoning and subdivision matters as authorized by the Code or state laws. Performs other duties prescribed by the Council pertaining to planning.	
Composition	Consists of seven members. Three members will serve on the Architectural Review and Historic Preservation Board.
