WHAT WE DO:

SIP provides technical assistance, within the CA System of Support, in a three-tier system:

- Open access to resources including live/recorded webinars, reference banks and guidance on inclusive practices- designed to build LEA, school and classroom capacity for equity and inclusion.
- Ongoing support to grantee including funding, exclusive professional learning events and coaching/strategic planning designed to meet their specific needs as they improve out-comes on state performance indicators 3, 5, 6 and 7.
- Tier 3: Technical assistance for statewide change as directed by CDE.

IMPACT:

Data indicates that districts who have engaged consistently with SIP over multiple years have seen significant positive movement in key indicators. **Grantees who have been working with SIP for three years have seen an average 24.9% increase** in special education students who spend 80% or more of their time in general education settings. **Grantees who have been working with SIP for six years have seen a 19.39% increase in that same measure**.

For all LRE indicators (5a, 5b, and 5c) grantee performance moved in the desired direction:

- Grantees who have been in the project for 5 and 6 years on average meet all state targets.
- Grantees have seen more than a 10% average increase in indicator 5a since beginning with SIP.
- Grantees on average have seen over 4% decrease on indicator 5b.
- Grantees report an overall decline in indicator 5c, between .5 and 1.4% for SIP Grantee cohorts.
