

Projected Revenue by Fund Source




This chart shows the total general purpose revenue Eagle Peak Montessori School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Eagle Peak Montessori School is \$3,738,928, of which \$3,169,629 is Local Control Funding Formula (LCFF), \$421,299 is other state funds, \$148,000 is local funds, and \$0 is federal funds. Of the \$3,169,629 in LCFF Funds, \$64,950 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Plan Summary [2025-26]

General Information

As a small independent charter school located in Walnut Creek, Eagle Peak Montessori is a passionate and committed community which has been serving students for the past 24 years. The commitment is shared amongst not only staff and board but the parents and students as well. EPMS started twenty-four years ago, with 2 classrooms and 60 students. In that time, we have grown slowly, steadily, and with purpose, to 8 classrooms and an anticipated enrollment of almost 296 students. In addition to the number of students, the range of grades has increased to where we now serve grades 1 through 8. We are located within the Mt. Diablo School District (MDUSD), specifically in a suburban area of Walnut Creek. MDUSD is also our authorizer. We are unique in being an Independent Charter but Locally or Indirectly funded. This means that we have a close working relationship with the district and we are grateful for that relationship.

While our students are drawn from a wide range of neighborhoods and local cities, we continue to strive for more diversification. Within our population of students, we serve 3% English Language Learners and 8% socio-economically disadvantaged. Approximately 10.84% of all of our students are considered Unduplicated.

Through our educational model, we serve students on plans that are as individualized as possible. Our students are grouped in multi-age classrooms, which allow students to move through the curriculum at their own pace.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Unfortunately, the LCAP is founded on the deficit mindset that there will be a group failing in all schools. This makes it difficult to create programs and actions to serve low-performing groups when our groups are being successful. Overall, for the past few years, we have been satisfied with our accomplishments on the CAASPP assessment. The California Dashboard demonstrates that we have zero student groups who were ranked Yellow, Orange, or Red on the Dashboard for English Language Arts and one group that fell into the Orange in math. However, when looking at the percentage of students who scored proficient from that subgroup, there was not a sharp decline in passing rates. In fact the passing rate was only 1% lower than the previous year when their scores were in the Green. Because of these results and the lack of reported data on our remaining groups of students, it is necessary to allow for the actions that support our goals to serve the whole community as well.

Our all school ethnic make up is currently approximately 35% White, 23% Multi-Ethnic, 24% Hispanic, 11.5 % Asian, 3.8% Filipino, 1.15% Black, less than 1% American Indian, and 3.4% non stated. On our CAASPP testing we had several student groups without a large enough number to public a ranking on the Dashboard.

Teachers	Teachers are presented with proposed goals and actions during staff development days in January and June. They review student survey data and then reflect on the actions which were previously enacted. The teachers also contribute any ideas for additional or replacing actions for the goals. Specifically, teachers inquired as to how specific actions were created and determined. They were interested in if there would be training on different software programs included in the LCAP.
Students	At the end of the academic year, students in both the elementary and middle school program were provided with surveys which asked for feedback on goals found in the LCAP as well as some of the programs which were related to the actions for the goals.
Parents	Parents are engaged in two levels during the planning and development of the LCAP. First, parents are provided with a survey in the early Spring, which inquires about the overarching goals in the LCAP and how they feel the school is meeting those goals. Then parent representatives serve on the Board of Directors and are presented with both the mid- year update in December and the annual update prior to approving the documents. Parents are also invited to participate in the public meeting which is held prior to the plan being voted on at the Board level. Then the Board, which is made up of parents, community members, and staff, determines if the plan is approved.

Principal/Superintendent	As a small charter school the Principal also serves as the Superintendent who is responsible for creating the LCAP and engaging with all of the partners.
Business Manager	The business manager helped to create the budget for the LCAP. These meetings took place prior to the updates as well as during the development process. First the total amount which would be allocated to the LCAP was discussed and then after the engagement of the other educational partners, actions were assigned budgets.

The actions were continued or changed based on the feedback of teachers and students. These two groups are involved with the actions and know first hand how the actions are being implemented and if they see success from them. The overarching goals were evaluated based on the parent data. If parents cannot sense the goals as being impactful on their child's learning or school experience, we would need to re-evaluate if these goals were appropriate.

As a result of the surveys, we will be extending the "homework club" to more elementary students in grades 4-6. We will also add additional staffing to the Upper Elementary Homework Club. We will continue with the middle school Math program, and a new full time teacher was hired to take on this program and Algebra specifically. The teachers were very clear that we need to ensure that the reading support position is filled and is actually able to meet with students. We will be working towards more time for our credentialed staff to work with pull out support, as well as the current plan of having a teaching assistant working with students. This will also permit us to expand the program to work with an extended range of grades, moving from serving grades 1-3 to include 4-6.

While Eagle Peak Montessori school has seen improvement in our academic achievement over time and it is our intention to continue on that trajectory, we did experience a slight drop this year. We understand that this requires us to continue to invest in what works and what is needed to produce continued success. We believe that students work best when working at a pace that fits them both academically and social/emotionally. When held as a basic value, respecting the child's individual development enables them to reach their potential and even go beyond expectations. Therefore, we look for additions to our program that provide individualized support.

Some years there are an abundance of professional development opportunities within the Montessori Educational community which address the specific goals of working with students who exhibit specific learning needs. However, we are working on purchasing online training that teachers are able to take either as a group or individual.

The largest difference between budgeted amounts and actuals for Goal #1 was we spent approximately \$1400 more than planned for professional development.

The math program in our Adolescent Program (grades 7 & 8), as well as in one of our Upper Elementary classrooms were disrupted by personnel changes during the school year. This resulted in some inconsistency in the ability to perform the actions as planned. We did eventually hire additional credentialed staff to help mitigate these issues, but there was an impact.

We recognized a greater need for math support across grade levels and we will be including that support as the LCAP moves forward.

Eagle Peak Montessori School provides an environment where students develop deeply held values of independence, responsibility, self-respect, respect for others and compassion. This results in self-confidence which seeps into their academic progress. When a student feels confident they are willing to try challenging lessons and work. Often students need smaller instructional settings or even time outside of the school day to accomplish this. We will provide reading support staff as well as "homework club" after school hours run by credentialed teachers.

Both the reading support and homework club served fewer students than expected. As we move into next year, the staff and administration will work to increase the number of students served.

While we did hire additional credentialed staff to work with grades 4-6 in reading, we had budgeted for more hours being provided. This was not possible for the current year, however, we look to increase this moving forward. We also added Adolescent Program math pull out towards the end of the academic year.

There was a slight increase in the percentage of students reading at grade level. However, we would like to see a larger impact and hope that additional staffing and hours will move us towards that goal.

We will be adding an instructional assistant to provide reading support as well as math support as well for grade 4-6. We will also be adding hours to serve more students in the Lower Elementary grades 1-3.

While we increased the number of families on campus by approximately 12, the percentage of families who volunteered and average number of hours per family remained mostly the same. We had 85% of families who volunteered in 2023-2024 and 86% of families who volunteered in 2024-2025. Both years, the average number of hours each family volunteered was approximately 36 hours. This does not reflect the actual distribution of those hours, but is an average across enrolled families.
