IPM statement

It is the goal of the Willows Unified School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Willows Unified School District conducts routine pest monitoring and inspections at all school sites as part of its Integrated Pest Management (IPM) program. Monitoring activities include regularly scheduled inspections of classrooms, cafeterias, kitchens, food storage areas, restrooms, locker rooms, custodial closets, portable buildings, and exterior building perimeters. Sticky monitoring boards and mechanical traps are strategically placed in high risk areas such as kitchens and food service areas and are checked weekly by custodial or maintenance staff. Grounds staff inspect landscaped areas, irrigation systems, trash enclosures, and athletic fields on a routine basis to identify pest activity or conditions conducive to pests. When pest activity exceeds established action thresholds, appropriate prevention or control measures are implemented in accordance with the District's IPM Plan and applicable state regulations.

Chemical pest management practices

If non-chemical methods are ineffective, the school district will consider pesticides only after careful monitoring indicates that they are needed according to pre-established action levels and will use pesticides that pose the least possible hazard and are effective in a manner that minimizes risks to people, property and the environment.

This school district expects the following pesticides (pesticide products and active ingredients) to be applied during the year. (This list includes pesticides that will be applied by school district staff or licensed pest control businesses.):

Niban granular bait, alpine cockroach gel bait rotation 2 reservoir, Round Up Pro Max, Rely, Oryzalin4, Pin-Dee 3.3 EC, Cyuse Plus, Weed B Gone and Select Max

Submittal of pesticide use reports

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt¹ from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at www.cdpr.ca.gov/schoolipm. (Education Code Section 16711)



¹ These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained baits or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
