# **IMPORTANT UPDATES**

#### **SEIS GRADUATES EXITS**

Students with disabilities (SWD) graduating with a standard diploma **MUST** have their "exit date in SEIS" **the day** <u>after</u> their graduation day (as reported to CALPADS). Failure to exit a SWD that received a


standard high school diploma after the day they graduated will directly impact your high school cohort and your California State dashboard results.

### Alternative Pathway to diploma graduates

High school students with disabilities that are graduating with an Alternative Pathway to a diploma should use an exit code 71 (High School Completer - Student left high school after completing their academic program. This includes students who graduated from high school with a certificate of completion or other than diploma, or received a high school completion/achievement certificate through GED or the requirements of EC 56390)

# CALPADS End of Year (EOY) 3 and 4 Certification

To ensure that all enrollments for students with disabilities are exited appropriately, LEAs should certify EOY 3 and EOY 4 with the same snapshot date and time.



Our goal is to have LEAs "SELPA Approved" by the first certification deadline of July 25, 2025. Please find our EOY checklist here.

# Transition to Regional Workgroup Model for 2025–26

In 2025-26 the SELPA is moving to a Regional Workgroup model, which includes the reassignment for Program Technicians. To maintain continuity, Program Technician's LEA caseloads will remain the same through End of Year final deadline, August 25<sup>th</sup>, 2025. Once EOY has closed, your LEA will receive an introduction to your new Program technician and any technical instructions to complete the transition.



#### **Exit Students**

Ensure all students who will not be attending your LEA in the 25/26 academic year have been exited with the appropriate code before July 1st.

#### **Postsecondary Report**

Submit your postsecondary report once all data has been entered into SEIS. SELPA cannot SELPA approve without postsecondary submitted. Be sure to remind this year's graduates that you will be contacting them next year for postsecondary status.

#### **Manage SEIS Users**

Audit all SEIS user accounts for users who will not be returning next academic year.

Please wait until July 1st to add students for the upcoming school year in SEIS

Adding them early may cause adoption transactions to post to the wrong academic year.
