1. Faculty Association Leadership Comments

Eric Larsen shared reflections from a recent faculty leadership conference, expressing appreciation for the board and emphasizing the importance of supporting multiple student pathways beyond college, including CTE, careers, and the military.

Assistant Superintendent Leslie Redkey presented the second-year update of the district's three-year Local Control Accountability Plan, outlining five district goals, highlighting progress measured against baseline data, and noting areas that remain a focus. She introduced Long Term English Learners as a new reporting group.

2. Pacific Crest Academy Local Control and Accountability Plan (LCAP) Public Hearing to Solicit Recommendations and Comments of Members of the Public

Assistant Superintendent Leslie Redkey shared a year-over-year comparison of Pacific Crest Academy's LCAP goals, highlighting notable progress and continued areas of focus. She reported substantial gains over the past several years, describing the overall trajectory as an incredible success story.

Assistant Superintendent Robert Whittenberg advised that the Education Code requires school districts to hold a public hearing to receive and consider public comments regarding the 2025/26 Proposed Budget. Mr. Whittenberg reported that each year in mid-May, the Governor produces a revision to the state's proposed budget issued in January. Education Code § 42127(a)(2) requires that school districts adopt an annual budget no later than July 1 of each year. Mr. Whittenberg presented, for review and discussion, the May Revise budget information and the first draft of the District's completed budget based on the May revision.

Mr. Del Rio opened the meeting to a public hearing. There being no comments, Mr. Del Rio closed the public hearing.

A gradual rate increase over several years was recommended. A third-party study is underway to provide data that will support any proposed changes.
