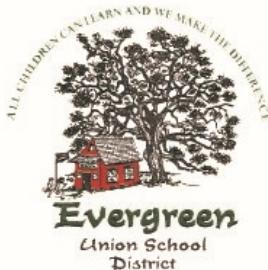

One of five schools in the district, Evergreen serves around 600 students from preschool through 4th grade. School Facility Conditions and Planned Improvements

The Evergreen Elementary School campus received an overall GOOD rating on the Facility Inspection Tool (FIT) in November 2025. Most systems—including cleanliness, electrical, restrooms and fountains, safety, structural components, and external systems—were found to be in GOOD repair at this attractive rural site. The interior received a FAIR rating. All identified repair needs have been documented, and steps are being taken to address them, with some already completed.

We continue to prioritize the physical safety of students at Evergreen Elementary. Recent improvements include installing additional perimeter fencing, ensuring lockdown and fire-alarm horns function effectively, upgrading surveillance cameras for clearer imaging, and regularly testing our two-way radios and Aeries Communication system for staff and family communication. Window blinds, window tinting, and the use of magnets on locked doors further support safety procedures during potential lockdowns. A generator has also been installed to ensure access to potable water during planned public safety power shutoffs.

Any facility repair concerns are either:

- promptly reported to the EUSD Safety Committee—which meets monthly, or more frequently as needed—to address safety issues, or
- submitted as a maintenance request to the EUSD Maintenance Department.

2025-26 School Safety Plan

Each year, Evergreen Elementary School reviews and updates its Comprehensive School Safety Plan to ensure it remains current, effective, and aligned with best practices. This plan outlines the school's vision, goals, and action steps for maintaining a safe and secure learning environment. It includes general safety policies, emergency procedures, evacuation route maps, and communication protocols to guide responses in a wide range of situations. The plan is designed to ensure that all staff and students are well-prepared for emergencies, with the overarching goal of minimizing harm and protecting lives. In any emergency, staff follow the "OODA" loop—Observe, Orient, Decide, Act—to respond quickly and effectively. The most recent plan was reviewed, updated, and approved by the Board in November 2025. It is publicly available on the school website, accessible in the front office, and shared with all staff during a schoolwide meeting each August. To maintain a high level of readiness, the school conducts regular emergency drills, including monthly fire drills, bi-monthly lockdown drills, and annual emergency preparedness training for staff. Evergreen Union School District actively supports and promotes a wide range of professional development opportunities for staff.
