General Comments on ELAC Needs Assessments:

- 1. No worries at all.
- 2. I am worried about the safety and behavior of teenagers. My son mentions that many teens are misbehaving and using vapes at school. This issue deserves attention, thank you.
- 3. I am worried about my child's math skills; is there a special class available to help strengthen his abilities?
- 4. Thank you to all the staff at Oakdale; you are doing an excellent job. My children have shown progress and are doing much better than when they first started. Our only concern relates to student behavior and vaping.
- 5. It would be wonderful if there were an additional English class available for EL students.
- 6. I greatly appreciate the communication with my son's teachers. I am very interested in staying informed about the lessons and content.

- 8. Providing students with books and homework would enhance their education. Initially, it's essential to focus more on new students learning English to ensure they keep up with educational standards.
- 9. In addition to their regular classes, it would be beneficial if the teacher could assist students with spelling.
- 10. We do not have a car, and transportation is a significant issue for us. Please address this matter
- 11. I am concerned about my children's English skills; they need improvement.
- 12. My child is five years old, and his teacher has treated him poorly. He was reluctant to attend that class and refused to go to school, which led me to change his school. However, by the next school year, I will have to return him to his home school since his siblings are at Oakdale. Again, I have concerns about his teacher and his safety.

General Comments on Parent Survey & Needs Assessments:

- 1. Afghan officials should oversee Afghan students to ensure that their challenges are communicated to the school administration, enabling them to address these issues and provide support for students who struggle in certain subjects.
- 2. A comprehensive meal plan for students should be developed and prioritized to ensure proper lunch provision.
- 3. My child feels secure, and both the teachers and the school atmosphere are positive. Additionally, we have an excellent individual who speaks our language at the school, which helps us address our concerns in our native language and understand school policies.
- 4. Mr. Mubariz consistently resolves all our issues.
- 5. All academic aspects are outstanding.
- 6. The lessons are exceptional, featuring effective teaching methods.
- 7. We have the invaluable Mr. Mubariz, who communicates in our language and adeptly addresses both our problems and those of our children.
