Griffin Technology Academies, a California nonprofit public benefit corporation with 501(c)(3) tax-exempt status, operates Griffin Academy High School is an independent, charter school authorized by VCUSD to serve the Vallejo community beginning in August 2020. Griffin Academy High School is a technology-focused school, with an emphasis on project-based learning and the integration of technology into the curriculum. Griffin Academy High School's graduates are self-motivated, technologically-skilled, responsible global citizens equipped to succeed in post- secondary training/education. Students have access to a variety of technology resources, including one-to-one devices for student use. Parents choose Griffin Academy High School for a more personal educational experience for their children. Griffin Academy High School is committed to being transparent and remaining accountable to its educational partners.

Griffin Academy High School serves the unique needs of students in grades 9-12. For high school students to experience academic and personal success, we must ensure that they have positive, supportive, and caring interaction with adults and peers. We must hold high expectations and provide support for demonstrated achievement. And we must ensure that they participate in meaningful ways in the school and community, building leadership skills. With parent, staff, and community involvement, Griffin Academy High School provides accountability in a nurturing and stimulating learning environment that extends beyond the classroom, building a commitment to our local and global communities. A Griffin Academy High School graduate will exemplify personal excellence with a curiosity and passion for learning.

Mission

Griffin Academy High School prepares students in Vallejo to be ready for college, career, and life through diverse, innovative instructional programs that focus relentlessly on student academic achievement and social and emotional well-being.

Vallejo is a working-class city of diverse ethnic and cultural backgrounds, located in the Bay Area near Mare Island and on the Napa River. The community of learners served by Griffin Academy High School is extremely diverse with multiple home languages represented (e.g., Spanish, Arabic, Tagalog). The Charter School is a diverse, 21st Century School. As of the 2023-24 school year based on the 2024 California School Dashboard ("Dashboard"), Griffin Academy High School's enrollment of 178 by student group was as follows: 60.7% socioeconomically disadvantaged ("SED") or low income ("LI") students, 14% English Learners ("ELs"), 6.2% students with disabilities ("SWD"), 0% foster youth ("FY"), 0.6% homeless students. As of the 2023-24 school year, enrollment by race and ethnicity at Griffin Academy High School was 18% Black or African American, 48.3% Latino, 10.1% Filipino, 6.7% two or more races, 7.3% White, 4.5% Asian, 1.1% Pacific Islander, and 1.1% American Indian. It should be noted that the supplemental and concentration grant funds that come from the Local Control Funding Formula ("LCFF") are for ELs, SED/LI, and FY. Of these subgroups, ELs and SED students are significant subgroups; however, Griffin Academy High School addresses specific actions and services for FY students to provide equal access to a high-quality program.

Griffin Academy High School is not eligible to be an Equity Multiplier School.

The purpose of this Local Control Accountability Plan ("LCAP") is to address the School Plan for Student Achievement ("SPSA") for Griffin Academy High School which is the Schoolwide Program; herein referred to as the LCAP. The Charter School's plan is to effectively meet the ESSA Requirements in alignment with the LCAP and other federal, state and local programs. The plans included in the LCAP address these requirements compliant to include focusing on three goals: GOAL 1: Griffin Academy High School will improve student achievement in English Language Arts, Mathematics, and Science for all students and significant subgroups, especially English Learners, to prepare students for college and career; GOAL 2: Griffin Academy High School will support the social emotional well-being of the students through character development and enrichment activities in a safe, inclusive, learning environment which fosters a strong relationship between teachers and students; and, GOAL 3: Griffin Academy High School's parents/guardians, teachers, staff, and community members will be contributing members of the school community as partners in education, communication, and collaboration to provide students with a well-rounded education.

The Charter School completed a comprehensive needs assessment of the entire school which included an analysis of verifiable state data and local performance data used to measure student outcomes as evidenced in the annual update portion of the LCAP. The needs assessment process included meeting parents, classified staff, teachers and administrators to identify areas of opportunity for the students and groups of students who are not achieving standard mastery and to identify strategies which will be implemented in the LCAP to address those areas of opportunity. The identification of the process for evaluating and monitoring the implementation of the LCAP and the progress toward accomplishing the established goals will include discussing the actions and services with the use of supplemental funds at the school level through the School Site Council ("SSC") and English Learner Advisory Committee ("ELAC"). SSC and ELA will meet a minimum of four times per year to inform the process. Parents, guardians, classified staff, certificated staff and an administrator will make up the SSC. The number of parents will exceed or be equal to the number of total staff members. The SSC will discuss academic performance, supplemental services and areas to make improvements with Title funds as part of the School Plan included in the LCAP conversations at the meeting in the fall and at the meeting in the spring. The teachers, staff, students and parents also participate in an annual survey which provides feedback on the goals and services. The teachers, staff and administrators actively participate in the decision-making process throughout the year and during LCAP workshops. The decisions will take into account the needs of Griffin Academy High School based on student achievement data to include SBAC, ELPAC, and interim assessment data such as, cumulative assessments, and attendance and student

discipline data to include the significant subgroups of Latino students, African American/Black students, English Learners, and socioeconomically disadvantaged students. The student data will be used as a basis for making decisions about the use of supplemental federal funds and the development of policies on basic core services.

Each goal includes actions and services that address the needs of all students and significant subgroups which include evidence-based strategies that provide opportunities for all students, methods and instructional strategies, and particular focus on students at risk of not meeting the State academic standards.

Reflections: Annual Performance

Griffin Academy High School is committed to developing a broad goal to improve the academic achievement of all students but to also focus specifically to improve the academic achievement of its significant subgroups of Latino students, African American/Black students, English Learners, and socioeconomically disadvantaged students because there has been a performance gap with these significant subgroups. The steps that will be taken to address these areas of achievement in the goals, actions, and services. Griffin Academy High School will engage in progress monitoring and will build upon the growth of the students and continue to focus on achievement.

ELA Performance

2024 Dashboard indicates the English Language Arts performance was "Medium" Overall – 11.9 points above standard, declined 20.1 points. The following subgroups had no performance color Latino – 22.2 points below standard, declined 39.4 points, Socioeconomically Disadvantaged- 2.1 points above standard, declined 19.3 points, and African American/Black- 4.8 points above standard. Other subgroups were not reported due to fewer than 11 students in the subgroup who participated in CAASPP testing in grade 11. Griffin Academy High School will focus specifically on increasing the ELA performance for all students, especially the significant subgroups of Latino students, African American/Black students, and socioeconomically disadvantaged students.

Math Performance

2024 Dashboard indicates the Math performance was "Medium" Overall – 108.3 points below standard, increased 11.5 points. The following subgroups had no performance color Latino – 161.2 points below standard, declined 44 points, Socioeconomically Disadvantaged- 131.8 points below standard, declined 19.4 points, and African American/Black- 99.2 points below standard. Other subgroups were not reported due to fewer than 11 students in the subgroup who participated in CAASPP testing in grade 11. Griffin Academy High School will focus specifically on increasing the Math performance for all students, especially the significant subgroups of Latino students, African American/Black students, and socioeconomically disadvantaged students.

<p>English Language Progress Indicator</p> <p>The 2024 Dashboard indicates that the English Learner Progress Indicator (“ELPI”) has no performance color with 50% of English Learners making progress toward English proficiency.</p>
<p>Suspension Rate</p> <p>2024 Dashboard indicates the Suspension Rate was Overall “Medium” – 6.7% of students were suspended at least one day, declined 4.7%. Students who are suspended multiple times are only counted once. The following subgroups were “High”-African American/Black – 11.4% of students were suspended at least one day, declined 13.6%, and English Learners - 6.5% of students were suspended at least one day, increased 0.4%. The following subgroup was "Medium" - Socioeconomically Disadvantaged – 18.1% of students were suspended at least one day, declined 5.2%. The following subgroup was “Low” - Latino – 4.4% of students were suspended at least one day, declined 0.7%. Griffin Academy High School will focus specifically on reducing the suspension rate of students.</p>

The adopted LCAP was influenced by the feedback provided by educational partners by ensuring that the three goals are supported by actions to include Student Achievement, Student Engagement, and Parent and Community Engagement. The actions include support for SWD and ELs. The contributing actions include support for SED students, ELs, and FY. The feedback was focused on academic interventions, social emotional support, and active parents and community members. The goals and actions support the whole child and ensures that every child can reach their potential. Additional feedback indicated a need to reconfigure Credit Recovery and support for students who are taking concurrent college classes. Teachers need PD on Culturally responsive instruction. The parents want to increase safety around the campus and reduce student behavior incidents.

- **Student Group(s):** Indicate the student group or groups who will be the primary beneficiary of the action by entering "All," or by entering a specific student group or groups.
- **Contributing to Increased or Improved Services?:** Type "Yes" if the action **is** included as contributing to meeting the increased or improved services requirement; OR, type "No" if the action is **not** included as contributing to meeting the increased or improved services requirement.
- If "Yes" is entered into the Contributing column, then complete the following columns:
 - **Scope:** The scope of an action may be LEA-wide (i.e., districtwide, countywide, or charterwide), schoolwide, or limited. An action that is LEA-wide in scope upgrades the entire educational program of the LEA. An action that is schoolwide in scope upgrades the entire educational program of a single school. An action that is limited in its scope is an action that serves only one or more unduplicated student groups.
 - **Unduplicated Student Group(s):** Regardless of scope, contributing actions serve one or more unduplicated student groups. Indicate one or more unduplicated student groups for whom services are being increased or improved as compared to what all students receive.

For transparency, the functionality and calculations used are provided below.

Contributing Actions Table

- **4. Total Planned Contributing Expenditures (LCFF Funds)**
 - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to EC Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7).  - This amount is the total of the Planned Percentage of Improved Services column.
- **8. Total Estimated Actual Percentage of Improved Services (%)**
 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- **13. LCFF Carryover — Percentage (12 divided by 9)**

- This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
