4.3 Contra Costa School of Performing Arts Update

Neil McChesney, Coordinator, Charter Oversight, gave the Charter Committee an update on the Contra Costa School of Performing Arts. CCCOE staff continues to communicate and closely monitor the situation at CCSPA, which will be closing at the end of the school year. A checklist is being developed to provide to CCSPA guidance regarding archiving essential school documents and student records.

4.4 District Charter Renewal Status

Neil McChesney, Coordinator, Charter Oversight, informed the Committee that Leadership Public Schools was approved at the latest West Contra Costa Unified School District Board meeting which accounted for two of the three charter schools in the county that are not authorized by the Couty Board were renewed. Amethod Public Schools Richmond Charter Academy would hear its decision at that

evening's WCCUSD Board meeting and the outlook was not looking good. The school had already reached out to McChesney about expediting the timeline for appeal to the County Board if the charter were not to be renewed.

4.5 Notice of Concern, Invictus Academy of Richmond

Neil McChesney, Coordinator, Charter Oversight, reviewed the Notice of Concern that was issued to Invictus Academy of Richmond for receiving a low performance on its recent Dashboard. The school was given a deadline of May 7, 2025, to provide a plan to remedy the situation and McChesney feels confident that deadline will be met.
