

Privacy Statement

The Board of Directors (Board) of EGRSF is concerned about your privacy and is committed to protecting and safeguarding your personal information. This Privacy Statement addresses the measures taken by EGRSF to protect and safeguard your personal information.

This Privacy Statement applies specifically to EGRSF's Board, committees, officers, employees, volunteers, other persons contractually or otherwise working on EGRSF-sponsored matters, and other persons having or granted access to your personal information.
