    - i. Desire to discuss as a group to be consistent with other levels.
      - 1. 7th grade, lesson 4 as example
    - ii. Motion to add "or revealing" to say "nude, partially nude, or revealing photo of themselves electronically." Seconded.
      - 1. Vote on menti.com, 8 yay, 1 abstain. Motion carries.
    - iii. Motion to replace 'teacher say' wording with "In Texas, it is a crime for a minor to intentionally or knowingly send another minor obscene photo/video or of a minor engaging in sexual conduct." Include reference to Texas penal code 43.261. Seconded.
      - 1. Vote on menti.com, 7 yay, 1 abstain.
  - c. Slide 84: sexual progression chart
    - i. Option 1: remove sexual progression and leave the rest of the slide
    - ii. Option 2: remove "sexual progression" on the slide and to change the question to reflect the questions from 7th grade.
    - iii. Option 3: leave "sexual progression" with 7th grade questions. This would also require a teacher note or teacher say to define sexual progression.
    - iv. Tabled for reworking and review.
