#### **Questions & Answers**

- 1. Are there concerns with FEOC / ITC? Yes, primarily for any battery components if proposed/included in the project. As a workaround, the District may engage with the successful Respondent, on a limited notice, to procure equipment before January 1<sup>st</sup>. Respondents should clarify any pricing and schedule dependencies on FEOC and taxes/tariffs.
- 2. Would the District provide a 2-week extension for proposal submittals? **Yes, please see revised** milestone schedule in the Clarifications section.
- 3. Are electrical as-built drawings, PTO, and IA letters available for Black Diamond H.S.? **This will be provided pending District authorization.**
- 4. MLK Jr. High School's SLD on "page 4: General notes" states that there are 612 modules with 51 source circuits. The SLD shows 52 source circuits for a total module count of 624. Please clarify. **The verification will be conducted during the Site Walk as part of the RFP process.**
- 5. Will the Respondent be required to retain and reuse existing monitoring system hardware and platform? May a new monitoring system that is compatible with the new proposed inverters be installed? Both options are acceptable. The District is looking for a cost effective proposal that allows continued monitoring at each site including the ability to report Renewable Energy Certificates.

Pittsburg Unified and TerraVerde will review the standard specifications along with the provided agreements in the RFP with the selected respondent to ensure all the required documentation is provided as part of contract award.
