Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. Quarry Trail Elementary School is one of eighteen schools in the Rocklin Unified School District. Quarry Trail serves students in Transitional Kindergarten through sixth grade, with an enrollment of approximately 771. The school is located in Whitney Ranch in a new and supportive community that expresses its values toward education through a high level of parent participation. Quarry Trail Elementary School opened to students for the first time in 2022-2023 and is the newest school in the District. Melanie Moss is the Principal, Katie Twelridge is the Assistant Principal, Melinda Good is the Dual Language Coordinator, and Roger Stock is the District Superintendent. The school staff strives to provide an exemplary learning environment. Academic achievement and Dual Language Education are certainly the primary focuses of the school. Still, the staff also operates on the principle that a caring environment fosters self-esteem and individual development and is the best

road toward achieving a well-rounded education. At Quarry Trail, students can participate in educational excellence through dual language education in Spanish and English. This school year in Dual Language, we offer a Transitional Kindergarten class, two Kindergarten Dual Language classes, and two 1st grade classes, two 2nd grade classes, and two 3rd grade classes. Each year, one grade level will be added to the Dual Language offering until there are classes in grades TK-6.

School Facility Conditions and Planned Improvements

Quarry Trail Elementary completed construction of its campus in the spring of 2022 and opened for students during the 2022-23 school year. As the newest campus in Rocklin Unified, every effort was taken to include the newest technologies, functional design for movement around campus, and beautiful landscaping using Native California plants to reduce water usage. It is aesthetically pleasing as well as being an excellent environment for student learning. It is a school that students, staff, and parents can be proud of. Supervision is provided before school, during recesses, and immediately after school. Visitors and volunteers are asked to report to the school office, sign in, and wear a visitor's badge while on campus. District safety inspections and cleanings are performed daily.

The district takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the State of California Office of Public School Construction. District maintenance ensures that the repairs necessary to keep the school sites in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.
