## Plan Summary [2025-26]

### General Information

Gateway International School (GIS) is operated and overseen by Gateway Community Charters (GCC), a 501c3 non-profit charter management organization (CMO). The school is governed pursuant to the bylaws adopted by the incorporators, as subsequently amended pursuant to the bylaws. GCC have been operating since 2003 and have expanded to serve over 5,800 students and 750 employees across nine charter schools. GCC charter schools serve predominantly underserved, vulnerable and at risk students; including English Learners, socioeconomically disadvantaged, 5th year seniors, foster and homeless. Gateway Community Charters manages a complex budget and has maintained above the required 3% reserve for each of its charter schools as well as keeping an additional reserve as needed for facilities, cash flow, and additional budget sustainability all while expanding enrollment.

The GCC Board of Directors believes that learning best occurs when students are provided with an educational program that challenges and motivates everyone to achieve their full potential. GIS is an independent charter school serving 630 students as of May 2025 in grades TK-8th in the Arden-Arcade area of Sacramento county. The school is in its 12th year of operation having been authorized in April 2013 by San Juan Unified School District. GIS serves a large English learner population (~56%) and also serve a large population of students who are socioeconomically disadvantaged (~76%). In order to better serve the students and their families, GIS has put time and effort into building relationships with our students through the Capturing Kids' Hearts Program (CKH), social-emotional learning (SEL) lessons through Sami's Circuit and Ripple Effects, and a focus on Positive Behavioral Interventions and Supports (PBIS).

GIS was authorized as an International Baccalaureate (IB) World School for the Primary Years Program (PYP) for TK-5th in the spring of 2016, and the Middle Years Program (MYP) for 6th-8th in the spring of 2018. Both programs have gone through successful evaluation visits:

the PYP in 2020 and 2025 and the MYP in 2023. GIS uses board approved curricula that are aligned to Common Core and Next Generation State standards for core subjects. PYP uses standards based report cards and MYP uses the traditional report cards along with IB report cards. Other programs that have a direct impact on student culture and social connections include Music, Design, Russian and Spanish instruction, Associate Student Body (ASB), After-School Program (ASP), and ASP clubs. These offerings play a critical role in the development of our students' ability to be creative and function in the IB program. These programs are a strong element that aid in setting the GIS school community apart from many other public schools in the area.

GIS expanded its after-school program to serve 400 students for the 2024-25 SY. This was possible with the Expanded Learning Opportunity Program (ELOP) funding and additional staffing. GIS added clubs within its program and utilizes outside vendors to bring additional clubs to engage students in the extended day. Such clubs include tap and ballet, sewing, Lego Robotics, eSports, seasonal sports, choir, clay art, gymnastics, modern dance, Girls on the Run, painting, and STEM engineering to name some. To close the achievement gap, tutoring with certificated staff is offered to all low-achieving students during the after-school program.

The El Dorado Charter SELPA supports GIS in meeting the needs of students with disabilities by providing professional learning to staff and administrators, Alternative Dispute Resolution tools and assistance, facilitation of root cause analysis for Program Indicator Review and other Special Education accountability measures, as well as access to program specialists and other technical experts to assist with specific student needs.

GIS has 94 employees; 37 certificated and 57 classified. Certificated staff consists of the Principal, two Vice Principals, School Counselor, RSP Specialist, part-time Speech Therapist, part-time School Psychologist, and 30 highly qualified teachers. The classified staff consists of office personnel, Site Manager, ASP Supervisor, Parent Liaison, custodians, para-educators, and playground assistants. The school employs a diverse group of bilingual and multilingual staff members who collectively speak a wide range of languages. The most commonly spoken languages among staff include Russian and Ukrainian, followed by Spanish. Other languages represented include Fijian, Punjabi, Hindi, Turkish, Hmong, and Farsi. Some staff members are fluent in as many as four languages, contributing to the school's strong capacity for multilingual communication.

## Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

On the 2023 California School Dashboard, English Learners at Gateway International School (GIS) received the lowest performance level (Red) on the Chronic Absenteeism indicator. (Keep this for three year LCAP).

The iReady data from the 2024–25 school year reveals several encouraging trends for GIS, especially in early grade growth and math proficiency. Most notably, all students demonstrated greater growth in meeting or exceeding grade level standards in both reading and math as compared to last year. Math proficiency across all students remained steady at 46% from the previous year, maintaining a strong baseline. In reading, early elementary grades demonstrated impressive gains—1st and 2nd graders showed significant increases in the percentage of students meeting or exceeding grade-level standards, with 2nd grade reading jumping 12 percentage points from the previous

year. 5th grade also saw strong improvement, with reading proficiency rising 11 points and math climbing 18 points, signaling meaningful academic momentum as students prepare for middle school.

Several subgroups also showed areas of notable growth. African American students achieved a substantial 15-point gain in math proficiency, marking a significant improvement that outpaced other demographic groups. English Learners and socioeconomically disadvantaged students both demonstrated continued growth in math, with the latter subgroup increasing by 3 percentage points. These results suggest that targeted instructional efforts and supports may be helping to close opportunity gaps, particularly in mathematics.

While some grade levels and subgroups experienced dips in performance—such as 3rd and 4th grade reading and some reduction in stretch growth percentages—the overall trend is one of steady growth, strong early literacy development, and increased math achievement among key student groups. These outcomes affirm the school’s ongoing commitment to academic improvement and provide a strong foundation for continued progress in the upcoming school year.

In addition to the positive trends reflected in the iReady data, the 2023–24 California School Dashboard results offer further evidence of progress. Notably, suspension rates and chronic absenteeism both declined overall, signaling improvements in school climate and student engagement. While performance in both Math and English Language Arts (ELA) remains in the orange performance band, it is important to note that ELA scores decreased, prompting a continued focus on literacy instruction. However, a major highlight of this year’s dashboard is the improvement in English Learner (EL) progress, which advanced from orange to yellow, a shift that likely reflects the growing impact of the English Language Development (ELD) program and the support of the school’s Reading Interventionist.

Equally significant is GIS’s exit from Additional Targeted Support and Improvement (ATSI) status. In 2021–22, GIS was identified for ATSI due to elevated absenteeism and suspension rates among Hispanic and socioeconomically disadvantaged (SED) students. Since then, the school has demonstrated consistent improvement: both subgroups showed gains in 2022–23, and the 2023–24 data shows a continued decrease in Hispanic student suspension rates and SED chronic absenteeism. While suspensions among SED students increased slightly, the overall trajectory reflects the school’s growing effectiveness in supporting students with the greatest needs.

Subgroup disparities continue to inform the school’s LCAP goals and Title I, Part A Schoolwide Program (SWP) planning.

GIS remains firmly committed to strengthening Tier 1 instruction, expanding targeted intervention opportunities, and building out restorative behavior systems. These efforts are clearly having an impact and will continue to serve as the foundation for sustained student growth and success.

#### A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

The school administration organized a variety of events and meetings throughout the academic year to seek input from different educational partners. Their feedback informed our goals in several key areas. For example, partners emphasized the importance of preparing students for college and careers, prompting us to enhance career exploration programs through explicit push-in lessons, revised unit planning with career connections, and academic counseling services in whole-group and 1:1 formats. We also considered their insights on addressing academic achievement gaps, leading us to develop targeted interventions during protected times in the school day, allocate resources more effectively to provide after school tutoring and additional instructional aides, and continue to build out our English Language Development (ELD) program. Additionally, partners highlighted the significance of supporting students' social-emotional well-being, guiding us to implement practices aimed at creating a nurturing school environment, including increasing the visibility of the school counselor through consistent SEL workshops and bringing in external partners for assemblies more frequently. By incorporating educational partner feedback into our LCAP, we ensure that our goals align closely with the needs of our educational community, fostering a supportive and inclusive environment for student success.

Input from the School Site Council (SSC) played a particularly important role in identifying resource gaps in academic and wellness supports. Their review of disaggregated student performance data led to the inclusion of Title I-funded actions focused on early identification of struggling students and the provision of targeted, evidence-based interventions under Goal 2. The SSC also advocated for consistent access to social-emotional supports, reinforcing the design of Actions 3.3–3.5 under Goal 3.

There was underspending in Action 1.1 (Certificated Staff) due to staffing shifts earlier in the year. In Action 1.4, the school increased spending on instructional materials and supplemental resources to ensure all students had access to the tools needed for academic success. For Action 1.6 (Clean and Safe Facilities), general fund dollars were used in place of LCAP funds to complete planned facility enhancements, allowing LCAP dollars to be redirected toward other priorities.

The implementation of diverse instructional programming and supplemental supports has led to sustained student interest in school activities and electives. Chronic absenteeism decreased, and student engagement improved. However, attendance still remains below the target.

Their work will focus on reinforcing core instruction, delivering intervention services, and supporting the implementation of individualized support plans. This investment ensures that students with the highest needs receive consistent, direct support to improve academic outcomes and engagement (aligned with Goal/Action 2.2).

## Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (California Education Code [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data.   - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
  - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
  - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

**Contributing Actions Annual Update Table**

  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

## **LCFF Carryover Table**

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
