JOB DESCRIPTION:

Provides consultation to IEP teams on implementation of Behavior Intervention Plans and Individualized Education Plans (IEPs) and support to staff, administration and parents on appropriate behavioral interventions consistent with Positive Behavior Support (PBIS).

DUTIES AND RESPONSIBILITIES:

- Conducts Functional Behavioral Assessments (FBA) to inform Behavior Intervention Plans (BIP) in accordance with federal and state regulations
- Provides formal and informal training and consultation to certificated and classified staff on PBIS, behavior and classroom management
- Consults with Crisis Response Team
- Provides consultation and training to Intensive Instructional Assistants who work with students with BIPs
- Develop Independence Plans targeting skills for students with Intensive Aide Support for behavior
- Develop IEP goals and attend IEP meetings as necessary
- Produce IEP progress reports on relevant goals
- Parent counseling to support the regular counseling and guidance program per student IEPs
- Collect data and maintain records on antecedents, behaviors and consequences
- Conduct home or community visits when necessary
- Collaborate with IEP team members
- Related other duties as assigned

- Provide positive behavior support and intervention to students
- Interact and communicate effectively with children and adults from various backgrounds
- Work independently with minimal supervision
- Communicate effectively in oral and written form
- Operate a computer and use email and standard software applications such as SEIS
