5.1 Student of the Month Recognition: Mr. Mercado proudly presented Sehajpreet Kaur Thiara as Orland High School's Student of the Month. Sehajpreet was described as an outstanding student who is taking advantage of the opportunity to concurrently enroll at Butte College while also taking A/P courses at OHS.

Beyond the classroom, Sehajpreet participates in numerous extracurricular activities and is deeply committed to leadership and community service. She is a charter member of the OHS key club and was instrumental in the club's reactivation.

5.2 Principal's Report: Mr. Mercado shared his principal's report with the Board. He discussed school events, site goals, and site data. The addition of two CTE pathways for the 26/27 school year was announced and the expanding dual enrollment options with Butte college were reviewed.

5.3 School Representative Report: Sehajpreet Kaur Thiara shared an update on Orland High School sports, clubs and school activities.
