Part IV - Carry-forward Adjustment

Enrollment is projected to increase modestly over the multiyear period, by 256 students in 2026-27, 250 students in 2027-28, and 192 students in 2028-29.

Average Daily Attendance (ADA) is projected at approximately 94% each year, reflecting stabilization near pre-pandemic levels inclusive of conservative Attendance Recovery program gains.

Expenditures

Step and column movement is 1.5% for certificated staff and 1.78% for classified staff each year. Two percent vacancy savings assumed and included for the unrestricted General Fund.

Contributions

Special Education projections reflect known and anticipated cost increases, including staffing, service delivery, and contractual obligations. Routine Restricted Maintenance is calculated at 3% of total General Fund expenditures for each year.
