### **Subject: IMPORTANT UPDATE AND NOTICE OF PUBLIC HEARING REGARDING PROPOSED MAPS AND SEQUENCE OF ELECTIONS - Transition to By-District Trustee Area Elections**

Dear East Side Community,

Since April 2025, the District has been undergoing the process for transition from at-large trustee elections to a single-member district-based election system. -The District is now nearing the completion of the districting process, which must conclude on or before October 5, 2025.

At a Special Board Meeting held on September 18, 2025, the East Side Union High School District Governing Board approved the addition of the following timelines/dates of public hearings and public meetings on this process:
