When Can My Child Start?

Transitional Kindergarten (TK):

Students who turn 4 between September 2 and June 2 may enroll in TK, as outlined in Education Code 48000(c).

Kindergarten:

Children who turn **5 on or before September 1** may enroll in kindergarten.

First Grade:

Children who turn 6 on or before September 1 are eligible for first grade.

Early entry may be allowed on a case-by-case basis with: - Parent/guardian approval - Space availability - School board determination

Proof of Age

Acceptable documents include: - Birth certificate - Baptismal certificate - Passport - Affidavit of parent/guardian

Expanded Learning Opportunities Program (ELOP) After School Program (ASP)

We are proud to offer an **After School Program** on our campus, provided in partnership with the **Butte County Office of Education**. This enriching afterschool program supports academic achievement, youth development, and family engagement in a safe and supportive environment.

Program Overview

The ASES Program is **available to all students** every day that school is in session. The program offers:

- · Academic support, including homework assistance and tutoring
- Enrichment activities, such as art, STEM, music, and physical activity •

Health and wellness education, fostering social-emotional growth

· A safe, supervised environment until the end of the program day

The program is designed to complement the regular school day and promote positive youth development in alignment with state ASES goals.

Program Hours

The program operates **every regular school day**, The program operates immediately following school dismissal until 4:30 p.m., except on minimum days when it ends at 3:30 p.m. or 2:30 p.m.

Site Coordinator

The ASES program at our site is coordinated by **Jenna Miller**, who oversees daily operations, student safety, staff supervision, and communication with families.

How to Apply

Applications for the ASES Program are available in the **school office**. Enrollment may be limited based on program capacity and staffing, and priority may be given according to the ASES grant requirements. Families are encouraged to submit completed applications as early as possible to secure placement.

Attendance

Why Attendance Matters

Regular attendance (missing less than 10% of school days) is a proven foundation for academic success. Students who meet this benchmark are more likely to earn higher grades, master core subjects, and graduate on schedule.

Missing school—even a few days early in the year—can negatively affect learning trajectories.

Half of students who miss just **2–4 days in September** wind up missing nearly a month overall in a single year

Call by 8:30 a.m. to report absences. Tardy? Check in at the office.

Excused:

- Illness
- · Medical/dental
- Family funeral
- · Religious events

Unexcused:

- No credit for missed work
- Risk of SARB referral after 10+ absences

Short-Term Independent Study

In accordance with Education Code Section 51747, short-term independent study may be available for students who require absences of 3 or more consecutive days. Families must provide the school with at least 24 hours' notice prior to initiating independent study. Elementary students are limited to a maximum of **14 cumulative days** of short-term independent study per school year. Approval is at the discretion of the school administration and based on adherence to district policies and procedures.

School Rules & Behavior Expectations Positive Behavioral Interventions and Supports (PBIS)

Pioneer Union School District uses a Tier I PBIS framework to promote a positive school climate and consistent behavioral expectations across all settings. PBIS is a proactive, school wide system that supports students' academic, social, and emotional success by:

- · Clearly teaching school-wide expectations
- · Recognizing positive behavior consistently
- · Using data to guide decisions and interventions
- · Collaborating among staff, students, and families

Behavioral Expectations

Our four core school-wide values are:

- Personal Best Be ready to learn and always do your best.
- Be Responsible Own your behavior and learning.
- Be Safe Follow rules and procedures to keep everyone safe.
- Be Respectful Treat others the way you want to be treated.

These expectations are taught explicitly in all environments (e.g., classroom, playground, cafeteria, restrooms, hallways) and reviewed throughout the year—including after school breaks and when new students arrive

Positive Reinforcement

Students demonstrating expected behaviors receive recognition through a structured acknowledgment system, including:

- PBIS tickets that can be redeemed at the student store
- · Special privileges or class-based incentives
- Celebrations and verbal praise aligned to desired behaviors

All staff participate in recognizing students for positive behavior, and students have daily opportunities to be acknowledged.

Corrective Discipline

Minor behaviors are handled in the classroom through proactive strategies like reteaching, redirection, and student conferences. Repeated or major behavior infractions may result in office referrals, additional support, or parent contact. The focus remains on **teaching appropriate behavior** and restoring a positive learning environment.

Team-Based Implementation

A dedicated PBIS team meets monthly to review discipline and behavior data, assess progress, and adjust strategies. Input is also gathered from families and staff to ensure the system reflects our school community's needs.

To graduate, students must: - Earn a 2.0 GPA - Complete the 8th Grade Project - Pass the Constitution Test (75%) - Have <10 unexcused absences - Demonstrate basic computer skills

Join in! - Student Council - Clubs - Field Trips - ELOP Events

To participate: - Maintain 2.0 GPA - Follow attendance/behavior rules

Parent Rights & Liabilities

You have the right to be informed, involved, and supported.

You may be liable for damages caused by your child (up to \$10,000). Attendance at school may be required if your child is suspended for certain behaviors (Ed Code 48900.1).
