## Student Pick Up/ Sign Out Policy

Dear Parents or Guardians,

### **Student Pickup :**

For your child's safety, participants must be signed out daily by the parent or other adults on the registration form. Reminder you must sign your full name, document the time, and mark the appropriate early release box. To ensure safety, picture identification is required to pick your child up from Rocky Point Discovery Club. The program ends promptly at 6 p.m. If your child has not been picked up by 6 p.m., the staff will try to contact the people authorized to pick up your child that are listed on your registration form. **At 6:15 p.m., authorities will be contacted if you have not picked up your child. Repeated tardiness will result in the following procedure:**

- 1st Tardy- Warning
- 2nd Tardy- You will be charged \$5 for the first five minutes and \$1 dollar for each additional minute thereafter.
- 3rd Tardy- Late fees and possible removal from Rocky Point Discovery Club

### **Student Sign out**

The sign out iPad will be located at the discovery club office unless otherwise stated you must sign your full name, and mark one appropriate early release box. You must use your 4 digit pin number in order to sign your child out from the program. Signatures will be checked daily and repeat missing signatures will result in the following:

- 1-3 missing signatures- warnings
- 4 missing signatures- one-day suspension from the program
- 5 missing signatures- removal from the program

When signatures are missing the director has the option to check the student as "signed out" the next day, by the parent who picked up the student. If this is a recurring issue it still counts as missing signatures which follow the same results stated above.

The Rocky Point Discovery Club will make exceptions to the hour requirement on a case-by-case basis. Understand that exceptions to the hour requirement will only be granted as listed on this early release form.

I agree that my child will attend the Discovery Club program during regular hours. I understand that it is my responsibility to communicate with the Discovery Club Program when my child will not attend the program due to illness and family vacations to avoid removal from the program. I understand that failure to attend the program regularly will result from removal of the program. I understand that it is my responsibility to sign my child out on a daily basis with the correct time and appropriate early release box marked.

## Program Information and Rules

### **Registration Fee:**

**Rocky Point Discovery Club Does not charge.** The Rocky Point Discovery Club is committed to making the program open for each and every student. Please contact Stephanie D'Acosta at (530) 722-7047 to discuss payment arrangements. Our Federal Tax Identification number is 20-8485404.

### **Student Supervision:**

The program is staffed by at least one group leader for every twenty students. A site facilitator oversees and supervises the site's program. All staff are fingerprinted and screened by Rocky Point Charter School.

### **Student Safety:**

The safety of your child is important to the Rocky Point Discovery Club staff. Therefore, please notify the staff of changes in your contact information throughout the year. (Rocky Point Discovery Club Program staff does not have access to your child's school file after the school office closes).

### **Attendance:**

Rocky Point Discovery Club is primarily funded through the After School Education and Safety (ASES) grant. The grant provides after-school academic assistance and enrichment for students. Priority registration is given to students identified as being at risk of meeting grade-level standards. **The Grant requires that elementary students attend five days per week, while middle school students must attend a minimum of nine hours a week and three days a week.** Priority is given to middle school students who attend daily. As part of the legislature, we hope that students participate in the full program which ends at 6:00 pm daily. Any expectations to the hour requirement must be pre-approved and will only be granted as listed on the early release form. Participants that do not fulfill the hour requirement may be excused from the program to allow space for others. To maintain your child's space at Rocky Point Discovery Club, please notify us if you ever have a personal emergency or illness requiring your child to be absent by calling the school the school office and requesting a note to be put in the Rocky Point Discovery Club box. We will be happy to work with you.

### **Student Pickup:**

Participation in the Rocky Point Discovery Club program is a privilege. All children are expected to follow the rules of the program. **Continuous disruptive/ disrespectful behavior will result in the following procedure:**

- 1st Pink Slip- Warning: Parent/Guardian contacted in person or by phone
- 2nd pink slip- 1 Day Suspension: Parent/Guardian conference
- 3rd Pink Slip- 1 week Suspension: Parent/Guardian conference- behavior contract
- 4th Pink Slip- removal from rocky Point Discovery Club Program

### **Parent Support:**

### **Student Early Release Form**

It is the intent of the legislature that students participate in the full after-school program except when released early in accordance with an early release policy established by each local program.

The Rocky Point Discovery Club allows for early release of students from the program under the following conditions:

- Medical Appointments
- Last Available transportation
- Walkers and Bike Riders (safety)
- School and Community-wide events
- School Site Closure due to weather

The Rocky Point Discovery Club will make exceptions to the hour requirement on a case-by-case basis. I understand that exceptions to the hour requirement will only be granted as listed on this early release form. I agree that my child will attend the Discovery Club during regular program hours. Dear Student,

We are excited to welcome you to our program! To ensure a healthy, happy, and safe environment for everyone, we will ask you to follow some rules. It's important that our students are safe, responsible, and respectful to everyone. Please read the following rules. (Group Leaders may add to the list of rules. This is a general list).

1. All students must follow day school rules.
2. Students from 2<sup>nd</sup> to 8<sup>th</sup> grade must complete one hour of academic time. **45 minutes** for kindergartens and first graders (This is a requirement for our program).
3. Students must try to complete all homework and missing assignments during academic time. **(Discovery Club tries our best to ensure students complete assignments. However, it is still the parent's responsibility to ensure their child's academic success).**
4. Students are not allowed to use cell phones in the Discovery Club. If a student has a phone regularly, they will need to see their program director for a phone contract.
5. Students must ask their group leader before they leave an area.
6. Students need to properly use school grounds and equipment.
7. There is no hanging or climbing on anything other than the playground.
8. Students need to be **Safe, Responsible, and Respectful.**

Our program strives to ensure our students are happy and respected as well. We hope that all students can follow the rules. However, if rules are repeatedly broken this may result in write ups and other consequences.
