Involvement Process for the SPSA and Annual Review and Update

Colusa Alternative High School (CAHS), in collaboration with Colusa High School (CHS) staff, reviews all components of the SPSA to ensure the needs of all students are effectively addressed. The CHS/CAHS Leadership Team provides ongoing insight, reflection, and recommendations for improvement throughout the school year. In addition, School Site Council members review all elements of the plan and play an active role in goal setting and the development of the needs assessment to support the delivery of high-quality instruction for all students.

Resource Inequities

Briefly identify and describe any resource inequities identified as a result of the required needs assessment, as applicable.

As a result of the required needs assessment, Colusa Alternative High School (CAHS) identified one area of concern under the Suspension Rate indicator, which was designated as an Orange performance level. This data indicates a need for more equitable access to behavioral, social-emotional, and intervention supports for students. While academic resources are largely equitable, this inequity highlights the need for additional supports such as restorative practices, targeted behavioral interventions, and increased counseling and SEL resources to ensure all students have consistent access to the supports necessary for engagement, positive behavior, and school success.

California School Dashboard (Dashboard) Indicators

A review of the California School Dashboard and local data identified Suspension Rate as an area in need of significant improvement, with CAHS receiving an Orange performance level. This indicates a higher rate of suspensions compared to state expectations and highlights a need to reduce exclusionary discipline practices. While no significant academic performance gaps were identified among student groups, suspension data suggests that some students may not be receiving equitable behavioral and social-emotional supports. To address this area, the school has implemented increased social-emotional learning supports, restorative practices, staff collaboration around behavior interventions, and targeted counseling supports to reduce suspensions and improve student engagement and school climate.















Additional Targeted Support and Improvement

A school eligible for ATSI shall:

1. Identify resource inequities, which may include a review of LEA- and school-level budgeting, which will be addressed through implementation of its TSI plan (*Sections: Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities, and Annual Review and Update, as applicable*).

Authority Cited: Sections 1003(e)(1)(B), 1003(i), 1111(c)(4)(B), and 1111(d)(2)(c) of the ESSA.

Single School Districts and Charter Schools Eligible for ESSA School Improvement

Single school districts (SSDs) or charter schools that are eligible for CSI, TSI, or ATSI, shall develop a SPSA that addresses the applicable requirements above as a condition of receiving funds (*EC Section 64001[a]* as amended by Assembly Bill [AB] 716, effective January 1, 2019).

However, a SSD or a charter school may streamline the process by combining state and federal requirements into one document which may include the local control and accountability plan (LCAP) and all federal planning requirements, provided that the combined plan is able to demonstrate that the legal requirements for each of the plans is met (*EC Section 52062[a]* as amended by AB 716, effective January 1, 2019).
