ETHICS IN PURCHASING

Statement to Vendors

SCHOOL DISTRICT RESPONSIBILITY

RECOMMENDATION OF PURCHASES

It is the desire of the Board of Education to have all Board employees and officials practice exemplary ethical behavior in the procurement of goods, materials, supplies, and services.

School district officials and employees who recommend purchases shall not extend any favoritism to any vendor. Each recommended purchase should be based upon the quality of the items, service, price, delivery, and other applicable factors in full compliance with N.J.S.A. 18A:18A-1 et. seq.

Solicitation/Receipt of Gifts – Prohibited

School district officials and employees are prohibited from soliciting and receiving funds, gifts, materials, goods, services, favors, and any other items of value from vendors doing business with the Board of Education or anyone proposing to do business with the Board.

VENDOR RESPONSIBILITY

Offer of Gifts, Gratuities -- Prohibited

Any vendor doing business or proposing to do business with the Board of Education shall neither pay, offer to pay, either directly or indirectly, any fee, commission, or compensation, nor offer any gift, gratuity, or other thing of value of any kind to any official or employee of the Board or any member of the official's or employee's immediate family.

Vendor Influence -- Prohibited

No vendor shall cause to influence or attempt to cause to influence, any official or employee of the Board of Education, in any manner which might tend to impair the objectivity or independence of judgment of said official or employee.

VENDOR CERTIFICATION

Vendors or potential vendors will be asked to certify that no official or employee of the Board of Education or immediate family members are directly or indirectly interested in this request or have any interest in any portions of profits thereof. The vendor participating in this request must be an independent vendor/contractor and not an official or employee of the Board of Education.

GENERAL CONDITIONS

1. AFFIRMATIVE ACTION REQUIREMENTS

The winning vendor or contractor shall be required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 et seq., and the terms and conditions of the Mandatory Equal Employment Opportunity Language—Exhibit A. Each company shall submit to the Board of Education, after notification of award, but prior to execution of a goods and services contract, **one** of the following three documents:

- Appropriate evidence that the contractor is operating under an existing federally approved or sanctioned affirmative action program;
- A Certificate of Employee Information Report approval issued in accordance with N.J.A.C.17:27-4; or
- The successful bidder (respondent) shall complete an Employee Information Report, Form AA-302, and submit it to the Division of Purchase and Property Contract Compliance and Audit Unit with a check or money order for \$150.00 made payable to the Treasurer, State of NJ and forward a **copy** of the form and check/money order to the board of education. Upon submission and review by the Division, the Report shall constitute evidence of compliance with the regulations.

Please note: A completed and signed Affirmative Action Questionnaire is requested with the submission of the proposal. However, the Board will accept in place of the Questionnaire, Affirmative Action Evidence in the form of a current Certificate of Employee Information Report submitted with the bid/proposal.

If awarded a contract your company/firm will be required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 et seq., and the terms and conditions of the Mandatory Equal Employment Opportunity Language—Exhibit A.

2. AMERICAN GOODS (N.J.S.A. 18A:18A-20)

The District intends to purchase, wherever available, and practical, goods and materials manufactured in the United States.

3. AMERICANS WITH DISABILITIES ACT

The contractor must comply with all provisions of the Americans with Disabilities Act (ADA), P.L. 101-336, in accordance with 42 U.S.C. 5121 01 et seq.

4. ANTI-BULLYING BILL OF RIGHTS—REPORTING OF HARASSMENT, INTIMIDATION, AND BULLYING—CONTRACTED SERVICE

The contracted service provider shall comply with all applicable provisions of the New Jersey Anti-Bullying Bill of Rights Act—N.J.S.A. 18A:37-13.1 et seq., all applicable code and regulations, and the Anti-Bullying Policy of the Board of Education. The district shall provide to the contracted service provider a copy of the board's Anti-Bullying Policy. In accordance with N.J.A.C. 6A:16-7.7 (c), a contracted service provider, who has witnessed, or has reliable information that a student has been subject to harassment, intimidation, or bullying shall immediately report the incident to any school administrator or safe schools resource officer, or the School Business Administrator/Board Secretary.

5. ANTI-DISCRIMINATION PROVISIONS—N.J.S.A. 10:2-1

N.J.S.A. 10:2-1. Anti-discrimination provisions. Every contract for or on behalf of the State or any county or municipality or other political subdivision of the State, or any agency of or authority created by any of the foregoing, for the construction, alteration or repair of any public building or public work or for the acquisition of materials, equipment, supplies or services shall contain provisions by which the contractor agrees that:

- a. In the hiring of persons for the performance of work under this contract or any subcontract hereunder, or for the procurement, manufacture, assembling or furnishing of any such materials, equipment, supplies or services to be acquired under this contract, no contractor, nor any person acting on behalf of such contractor or subcontractor, shall, by reason of race, creed, color, national origin, ancestry, marital status, gender identity or expression, affectional or sexual orientation or sex, discriminate against any person who is qualified and available to perform the work to which the employment relates;
- b. No contractor, subcontractor, nor any person on his behalf shall, in any manner, discriminate against or intimidate any employee engaged in the performance of work under this contract or any subcontract hereunder, or engaged in the procurement, manufacture, assembling or furnishing of any such materials, equipment, supplies or services to be acquired under such contract, on account of race, creed, color, national origin, ancestry, marital status, gender identity or expression, affectional or sexual orientation or sex;
- c. There may be deducted from the amount payable to the contractor by the contracting public agency, under this contract, a penalty of \$50.00 for each person for each calendar day during which such person is discriminated against or intimidated in violation of the provisions of the contract; and
- d. This contract may be canceled or terminated by the contracting public agency, and all money due or to become due hereunder may be forfeited, for any violation of this section of the contract occurring after notice to the contractor from the contracting public agency of any prior violation of this section of the contract.

No provision in this section shall be construed to prevent a board of education from designating that a contract, subcontract or other means of procurement of goods, services, equipment or construction shall be awarded to a small business enterprise, minority business enterprise or a women's business enterprise pursuant to P.L.1985, c.490 (C.18A:18A-51 et seq.).

6. BRAND NAME OR EQUIVALENT

Whenever the Board of Education requests a brand name for a particular item, it will consider a "brand name or equivalent". If the vendor desires to quote an equivalent item, the vendor shall do the following:

On the Quotation Proposal Form, write in ink next to the item requested, the vendor's substitute item, including the brand name and model number. This is the only change to the Quotation Proposal Form the Board will accept.

Provide a sample of the substitute item if requested. The sample item must be provided before or at the time of the quotation deadline. The sample item shall be a paper, brochure, or illustrative literature outlining the brand/manufacturer name, model number, and full description of the item.

If a sample is not required the Board requests a brochure, pamphlet, or illustrative literature that outlines the specifications of the item including the manufacturer's name, model number, etc., to be included with the quotation.

Failure to provide a sample item or literature when requested shall be cause for disqualification of that item from the quotation. It is the responsibility of the vendor or contractor to demonstrate the equivalency of the items offered.

7. BUSINESS REGISTRATION CERTIFICATE (N.J.S.A. 52:32-44)

Pursuant to N.J.S.A. 52:32-44, the board of education is prohibited from entering into a contract with an entity unless the bidder/proposer/contractor and each subcontractor that is required by law to be named in a bid/proposal/contract have a valid Business Registration Certificate on file with the Division of Revenue and Enterprise Services within the Department of the Treasury.

Request of the Board of Education

All respondents or companies providing responses for requested proposals are **requested** to submit with their response package a copy of their "New Jersey Business Registration Certificate" as issued by the Department of Treasury of the State of New Jersey.

The Board reminds all respondents that failure to submit the New Jersey Business Registration Certificate prior to the award of the contract will result in the rejection of the proposal.

Subcontractors

Prior to contract award or authorization, the contractor shall provide the Contracting Agency with its proof of business registration and that of any named subcontractor(s).

Subcontractors named in a bid or other proposal shall provide proof of business registration to the bidder, who in turn, shall provide it to the Contracting Agency prior to the time a contract, purchase order, or other contracting document is awarded or authorized.

During the course of contract performance:

The contractor shall not enter into a contract with a subcontractor unless the subcontractor first provides the contractor with valid proof of business registration.

The contractor shall maintain and submit to the Contracting Agency a list of subcontractors and their addresses that may be updated from time to time.

The contractor and any subcontractor providing goods or performing services under the contract, and each of their affiliates, shall collect and remit to the Director of the Division of Taxation in the Department of the Treasury, the use tax due pursuant to the Sales and Use Tax Act, (N.J.S.A. 54:32B-1 et seq.) on all sales of tangible personal property delivered into the State. Before final payment is made under the contract, the contractor shall submit to the Contracting Agency a complete and accurate list of all subcontractors used and their addresses.

N.J.S.A. 54:49-4.1: Violations of Registration Requirements; Penalties.

A business organization that fails to provide a copy of a business registration as required pursuant to section 1 of P.L. 2001, c.134 (C.52:32-44 et al.) or subsection e. or f. of section 92 of P.L. 1977, c.110 (C.5:12-92), or that provides false information of business registration under the requirements of either of those sections, shall be liable for a penalty of \$25 for each day of violation, not to exceed \$50,000 for each business registration copy not properly provided under a contract with a contracting agency or under a casino service industry enterprise contract.

8. CONTRACTOR/VENDOR REQUIREMENTS—OFFICE OF THE NEW JERSEY STATE COMPTROLLER

Contractors/vendors doing business with the board of education are reminded of the following legal requirements pertaining to the Office of the New Jersey State Comptroller:

- **Access to Relevant Documents and Information—N.J.S.A. 52:15C-14 (d)**

Private vendors or other persons contracting with or receiving funds from a unit in the Executive branch of State government, including an entity exercising executive branch authority, independent State authority, public institution of higher education, or unit of local government or board of education shall upon request by the State Comptroller provide the State Comptroller with prompt access to all relevant documents and information as a condition of the contract and receipt of public monies. The State Comptroller shall not disclose any document or information to which access is provided that is confidential or proprietary. If the State Comptroller finds that any person receiving funds from a unit in the Executive branch of State government, including an entity exercising executive branch authority, independent State authority, public institution of higher education, or unit of local government or board of education refuses to provide information upon the request of the State Comptroller, or otherwise impedes or fails to cooperate with any audit or performance review, the State Comptroller may recommend to the contracting unit that the person be subject to termination of their contract, or temporarily or permanently debarred from contracting with the contracting unit.

- **Maintenance of Contract Records—N.J.A.C. 17:44-2.2**

Relevant records of private vendors or other persons entering into contracts with covered entities are subject to audit or review by OSC pursuant to N.J.S.A. 52:15C-14(d).

The contractor/vendor to whom a contract has been awarded shall maintain all documentation related to products, transactions or services under this contract for a period of five years from the date of final payment. Such records shall be made available to the New Jersey Office of the State Comptroller upon request.

- **Board of Education Requirement**

In addition to, and independent of, the requirements of N.J.S.A. 52:15C-14 (d) and N.J.A.C. 17:44-2.2, the Contractor shall also maintain and make any or all books and records related to products transactions or services rendered under this contract, available to the Board of Education upon request.

9. CRIMINAL HISTORY BACKGROUND CHECKS—N.J.S.A. 18A:6-7.1--REQUIREMENT

All providers of services of this contract shall provide to the school district prior to commencement of the contract, evidence or proof that each employee assigned to provide services and that comes in **regular contact** with students has had a criminal history background check, and furthermore, that said background check indicates that no criminal history record information exists on file for that worker. Failure to provide proof of criminal history background check for any employee coming in regular contact with students, prior to commencement of contact, may be cause for breach of contract. If it is discovered during the course of the contract that an employee has a disqualifying criminal history or the employee has not had a criminal history background check, that employee is to be removed from the as a service provider immediately. All contracted service providers shall comply with N.J.S.A. 18A:6-7.6 et seq., and **NJDOE Broadcast September 9, 2019**, as it pertains to disclosure of information from previous employers, when applicable.

10. DEBARMENT, SUSPENSION OR DISQUALIFICATION N.J.S.A. 52:32-44.1 (A), N.J.A.C. 17:19-1.1 et seq.

The Board of Education will not enter into a contract for work with any person, company, or firm that is on the State Department of Labor and Workforce Development; Prevailing Wage Debarment List, or the State of New Jersey Consolidated Debarment Report (www.state.nj.us/treasury/debarred). Pursuant to N.J.S.A. 52:32-44.1 (a), any person who is debarred at the federal level from contracting with a federal government agency shall be debarred from contracting for any public work in this State.

All bidders are required to submit a sworn statement indicating whether the entity listed on the bid form or any person employed by this entity, nor the person's affiliates are not debarred from contracting with a federal government agency, nor debarred from contracting with the State of New Jersey. The Board of Education will verify the certification by consulting

11. DELIVERY

When purchasing goods, supplies, materials, etc., all quotation prices are to include:

- Shipping and Handling costs
- Delivery costs

FOB Destination, Freight Prepaid - The successful vendor, to whom the contract is awarded, retains title and control of goods, selects the carrier, and is responsible for the risk of transportation; title passes to the Board of Education upon delivery and ownership by the Board; the successful vendor pays and bears the costs of all freight and delivery charges listed below.

The Board of Education recognizes two types of delivery:

● **Inside Delivery**

Items are to be delivered to a Board of Education location and taken off the truck by transportation carrier personnel and brought to a designated area inside the school or office building.

● **Spotted Delivery**

Items are to be delivered to a Board of Education location and taken off the truck by transportation carrier personnel and brought to a designated area inside the school or office building. Transportation carrier personnel are responsible to uncrating, setting up, assemble items to determine good working order and remove all debris to the satisfaction of the Board of Education. Vendors are cautioned to provide adequate personnel to deliver goods as none will be provided by the Board of Education. If a specialized person is needed to set up, assemble or erect an item, such assembly shall be completed within five (5) school days of the actual delivery date.

Failure to assemble, set up, or erect items within the stated time may result in a *\$100.00 per day* assessment against the vendor for each day items are not assembled, set up, or erected.

The Board of Education will not be responsible for any extra delivery costs.

Specific delivery instructions are provided in the General Specifications. **Please Note:** All packages, boxes, cartons, etc., when delivered, must be plainly marked on the outside as to contents, and the Board of Education’s purchase order number must be clearly printed on the packages, boxes, cartons, etc.

- **Delivery Guarantee**

All vendors are to guarantee the delivery of the requested items within a certain number of business days from the receipt of the Board of Education purchase order. The number of days shall be written on the Quotation Proposal Form by the vendor.

In certain cases, the delivery guarantee may be the determining factor in whether a quotation is awarded to one vendor over another vendor.

Failure to deliver items (assemble, install, erect, etc., if so required) within the timelines agreed upon shall be cause for a deduction penalty from the amount due to the vendor.

If items are not received within twenty (20) days after the deadline date, the Board of Education reserves the right to cancel the order.

12. DOCUMENTS TO BE SUBMITTED—ORIGINAL SIGNATURE; BLUE INK

All participants in this quotation process must submit the following documents with original signatures:

- Affirmative Action Questionnaire or Certificate of Employee Information;
- Assurance of Compliance;
- Chapter 271 Political Contribution Disclosure Form;
- Non-Collusion Affidavit;
- Quotation Proposal Form;
- Statement of Ownership; and
- Vendor Questionnaire/Certification.

13. EQUAL PRICES

Pursuant to N.J.S.A. 18A:18A-37(d) when two or more respondents submit equal prices and the prices are the lowest responsible quotes, the Board may award the contract to the vendor whose response, at the discretion of the Board, is the most advantageous, price and other factors considered.

14. ESTIMATED QUANTITIES

The Board of Education intends to order the quantities of items listed on the Proposal Form. Bidders are notified that the aforementioned quantities are estimated quantities that the Board intends to purchase and are not to be relied upon as the actual quantity to be purchased. There may be some deviation in the number of items ordered because of the budgeting and financial constraints of the school district.

15. INSURANCE AND INDEMNIFICATION

The vendor or contractor to whom the contract is awarded for any service work or construction work shall secure, pay the premiums for, and keep in force until the contract expires, insurance of the types and amounts listed below:

- **Commercial General Liability** with a \$1,000,000 and \$2,000,000 General Aggregate per each occurrence for Bodily Injury, Personal and Advertising Injury, Property Damage, and Products Liability.
- **Automobile Liability** with a \$1,000,000 Combined Single Limit of Liability for Bodily Injury and Property Damage per accident. Automobile liability insurance shall be included to cover any vehicle used by the insured.
- **Cyber Security and Privacy Liability** with a \$1,000,000 per occurrence or claim.

Indemnification

The contractor shall assume all risk of and responsibility for, and agrees to indemnify, defend, and save harmless the Board and its agents, employees and Board members, from and against any and all claims, demands, suits, actions, recoveries, judgments and costs and expenses (including, but not limited to, attorneys fees) in connection therewith on account of the loss of life or property or injury or damage to any person, body or property of any person or persons whatsoever, which shall arise

from or result directly or indirectly from the work and/or materials supplied under this contract and the performance by contractor of services under the contract or by a party for whom the contractor is liable. This indemnification obligation is not limited by, but is in addition to, the insurance obligations contained in this agreement.

The Contractor is to assume all liability of every sort incident to the work, including property damage caused by the contractor's workers or by any subcontractor employed by the contractor or any of the subcontractor's workers.

16. IRAN DISCLOSURE OF INVESTMENT ACTIVITIES N.J.S.A. 18A:18A-49.4

The Board of Education, pursuant to N.J.S.A. 18A:18A-49.4, shall implement and comply with Public Law 2012, c.25, Disclosure of Investment Activities in Iran—N.J.S.A. 52:32-55 et seq.

N.J.S.A. 52:32-57, et seq. (P.L. 2012, c.25 and P.L. 2021, c.4)

a. A person or entity that, at the time of bid or proposal for a new contract or renewal of an existing contract, is identified on a list created pursuant to subsection b. of this section as a person or entity engaging in investment activities in Iran as described in subsection f. of section 2 of this act, shall be ineligible to, and shall not, bid on, submit a proposal for, or enter into or renew, a contract with a State agency for goods or services.

N.J.S.A. 52:32-58: Certification Required.

a. A State agency shall require a person or entity that submits a bid or proposal or otherwise proposes to enter into or renew a contract **to certify, prior to the time a contract is awarded** and at the time the contract is renewed, that the person or entity is not identified on a list created pursuant to subsection b. of section 3 of this act as a person or entity engaging in investment activities in Iran described in subsection f. of section 2 of this act.

Such certification is required to be submitted prior to the award of the contract.

The Disclosure of Investment Activities in Iran Form is to be completed, certified, and submitted prior to the award of the contract.

17. NON-COLLUSION AFFIDAVIT

A notarized Non-Collusion Affidavit shall be submitted with the bid/proposal. The bidder/respondent has to certify that he has not directly or indirectly, entered into any agreement, participated in any collusion, discussed any or all parts of this proposal with any potential bidders, or otherwise taken any action in restraint of free, competitive bidding in connection with the above-named proposal and that all statements contained in said Proposal and this affidavit are true and correct, and made with full

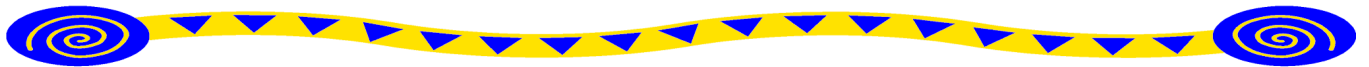

HIGH IMPACT TUTORING SERVICES RFQ 26/27-01

SCOPE OF SERVICES AND MINIMUM REQUIREMENTS

The Mine Hill Township Board of Education seeks proposals from qualified providers to furnish a comprehensive virtual tutoring program that includes scheduled high-impact tutoring with live tutors and a secure digital platform through which tutoring sessions will be delivered. The proposed program shall include, at a minimum, the following components:

Scheduled High-Impact Tutoring

Provide live, virtual High-Impact Tutoring in English Language Arts and Mathematics for twenty-five (25) District-identified students, primarily in grades 3-5, while accommodating other grade levels identified by the District.

Provide each participating student with a total of ninety (90) minutes of scheduled tutoring per week for 27 weeks, generally delivered through three (3) sessions of thirty (30) minutes each.

Maintain a student-to-tutor ratio not exceeding 3:1. Preference may be given to proposals that provide lower student-to-tutor ratios when educationally appropriate and within the proposed cost.

Make scheduled tutoring services available from October 5, 2026 through May 14, 2027. Proposals may include earlier implementation or extended access through the end of May 2027 at no additional cost to the District. NOTE: Tutoring will not be required during holiday breaks or weeks when school is in session for fewer than four days. No tutoring will be scheduled during the following periods: November 2–6, November 23–27, December 21, 2026–January 1, 2027, and March 29–April 2, 2027.

Assign qualified tutors consistently to participating students to the greatest extent practicable and provide a process for tutor substitution, supervision, and quality assurance.

Secure Virtual Tutoring Platform

Provide a secure, web-based platform through which all scheduled virtual tutoring sessions will be delivered. The platform shall be accessible to participating students, tutors, and authorized District staff as appropriate.

The vendor shall describe the platform's security, student-data privacy protections, access controls, functionality, accessibility, reliability, and ease of use.

Provide all necessary implementation, account setup, rostering, training, technical support, and ongoing platform support. The proposal shall identify the anticipated platform-access period and any services available before October 5, 2026 or after May 14, 2027.

Instructional Requirements

Align tutoring in English Language Arts and Mathematics with NJDOE High-Impact Tutoring principles and the New Jersey Student Learning Standards (NJSLS).

Use research-based instructional practices and high-quality instructional materials appropriate to the targeted grade levels and students' identified learning needs.

Use available District assessment and performance data to differentiate instruction and support struggling learners, multilingual learners, and students with disabilities.

Tutor Qualifications, Training, and Screening

Demonstrate the immediate capacity to recruit, assign, supervise, and retain a sufficient number of qualified tutors to meet all scheduling and ratio requirements.

Ensure that each tutor possesses at least sixty (60) semester-hour credits from a nationally accredited college or university. Preference may be given to tutors with advanced coursework, credentials, or experience in education, mathematics, or English Language Arts.

Ensure that tutors have relevant experience working with students in the grade levels and content areas to which they are assigned.

Ensure that all personnel who will have regular contact with students satisfy applicable criminal-history record check requirements, including N.J.S.A. 18A:6-7.1 and applicable regulations, before providing services.

Provide initial and ongoing tutor training in research-based tutoring practices, NJSLs alignment, use of student data, virtual instruction, cultural responsiveness, student confidentiality, and support for diverse learners.

Progress Monitoring, Reporting, and Communication

Monitor student attendance, participation, usage, and academic progress and provide the District with regular reports in a mutually agreed-upon format.

Provide District administrators with appropriate dashboards or reports showing scheduled tutoring participation, platform utilization, and available measures of student progress.

Designate a qualified program manager to maintain regular communication with District staff, address scheduling or service concerns, and support program implementation throughout the contract period.

Vendor Proposal and Pricing Requirements

Describe the proposed program, implementation timeline, staffing model, tutor qualifications, instructional methodology, secure virtual tutoring platform, reporting capabilities, technical support, data-privacy protections, and evidence of effectiveness.

Provide references and documentation demonstrating successful implementation of comparable virtual tutoring programs for school districts or similar educational organizations.

- Secure Virtual Tutoring Platform - 12 Points: Security, student-data privacy protections, access controls, functionality, accessibility, reliability, and ease of use of the platform through which scheduled tutoring sessions will be delivered, as well as the quality of related technical support.
- Standards Alignment and Instructional Materials - 8 Points: Alignment with NJDOE High-Impact Tutoring principles and the NJSLS; quality of instructional materials; use of assessment data; and the extent to which instruction is individualized to student needs.
- Progress Monitoring, Reporting, and Evidence of Effectiveness - 7 Points: Quality of attendance, participation, usage, and academic-progress monitoring; usefulness and frequency of District reports; communication procedures; and documented evidence that the proposed methodology has produced positive results in comparable programs.
- Completeness and Responsiveness - 3 Points: Completeness, clarity, organization, and responsiveness of the proposal to all RFQ requirements.

Management Criteria - 35 Points
