- 2. Set up safety to keep the general public away from the shoring.
- 3. Install shoring utilizing steel bracing only as indicated in attached sheets SK-1 and SK-2
 - a. Include Helical anchors

- 4. Work shall be performed during normal working hours on weekdays.
- 5. Work will be performed at one time, under one contract.
- 6. Work cannot be completed during inclement weather.
- 7. We have included one mobilization for the project. Additional mobilizations will result in additional charges.
- 8. Any items not specifically mentioned in this proposal are excluded
- 9. Use of building electric power, water, and restroom facilities for the duration of the project.
- 10. City Permits and Payment Performance Bond are excluded.
- 11. Sales tax has been excluded.
