As an alternative educational setting, WCHS is committed to offering a comprehensive curriculum tailored to support students at risk of not meeting graduation requirements or adequately preparing for college and career pathways.

Many WCHS students face challenges such as poor attendance, disciplinary issues, and low academic performance. To address these needs, WCHS provides students with opportunities for both academic and behavioral growth through the use of the Edgenuity online curriculum and additional programs that accommodate diverse learning styles and ability levels. To prepare students for careers, they complete industry sector trainings. In addition to academic supports, to support the whole-child, the district has partnered with community organizations to provide WCHS students access to school-based counseling and social-emotional supports from Certified Wellness Coaches.

School Facility Conditions and Planned Improvements

In August 2007, the District Office moved from the property located downtown, to its current location on the west side of the Community High building. The relocation has been successful for both the District and the Community High School.

The safety, cleanliness, and adequacy of school facilities, including any needed maintenance to ensure good repair of the buildings, are important to the school and district. Most recently, improvements were made to the classroom and office heating and air conditioning systems as well as the outside security lighting. The older adjunct portable buildings were remodeled with new interior ceilings, walls and carpets. The parking lot and "hard court" play area were also resurfaced and security cameras were installed for night monitoring.

The facility consists of one permanent building for the office and two portable buildings for classrooms. Breakfast and lunches are prepared at the comprehensive high school and transported to our facility on a daily basis. A part-time custodian and the district maintenance and grounds personnel help to provide safe, clean, and well-kept classroom and office facilities.

To determine the condition of our facilities, our district annually performs an inspection using a survey called the Facilities Inspection Tool (FIT), which is issued by the Office of Public School Construction. Information and data from the FIT survey were used in putting together this report. Please note that the information reflects the condition of our buildings as of the date of the report. Since that time, those conditions may have changed.

2025-26 School Safety Plan

Ensuring safety is a top priority at Willows Community High School. A comprehensive school safety plan, aligned with SB 187, is developed and updated annually. This plan encompasses a range of emergency procedures, including responses to traumatic incidents, imminent danger (Code Red), evacuation and relocation, civil defense/disorder, bomb threats or emergencies, earthquakes, chemical spills, crimes in progress, and fire or explosions. Regular emergency drills are conducted throughout the year to prepare staff and students.
