REGULAR SESSION MINUTES

The Pymatuning Valley Local Board of Education met in regular session on Monday, September 8, 2025 at 6:00 pm in the High School Lecture Room with the following Board Members present: President Margaret Struna, Vice President Josh Peyton, Mr. Curt Harvey, Mrs. Jodie Hitchcock and Mr. Duane Marcy.

President Struna invited all present to join in the Pledge of Allegiance, followed by each person introducing themselves.

Superintendent Christopher Edison introduced Venie Hinson who gave a presentation on the Back-to-School Bash. Mrs. Hinson said this is the 16th year of providing school supplies to the district. Around 535 children, along with a number of Amish students benefited from the donations. She thanked the High School girls' soccer team and the PV maintenance staff for their help. There were over 40 volunteers from five local churches and from the Laker Ruritans.
