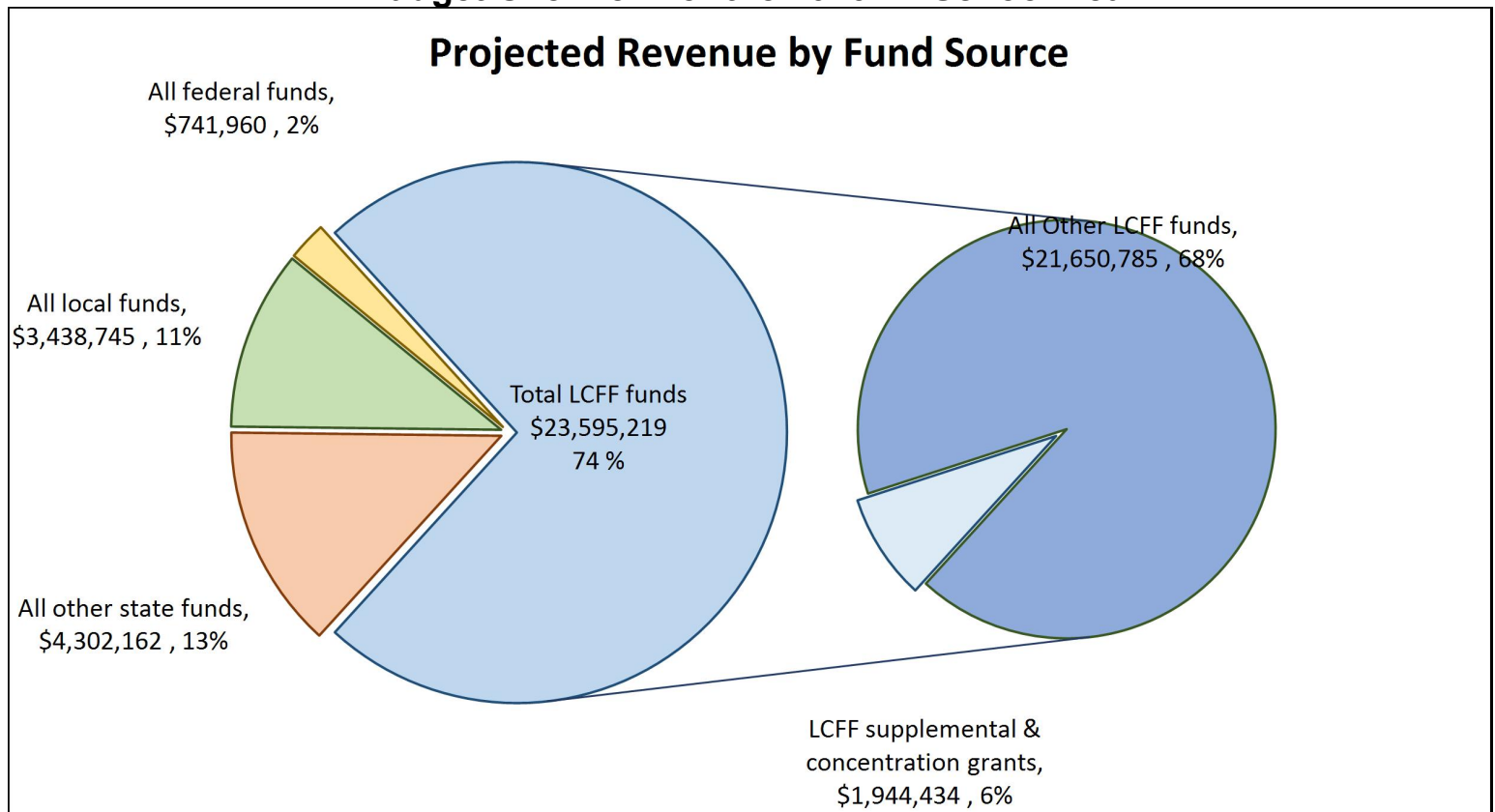

Budget Overview for the 2026-27 School Year

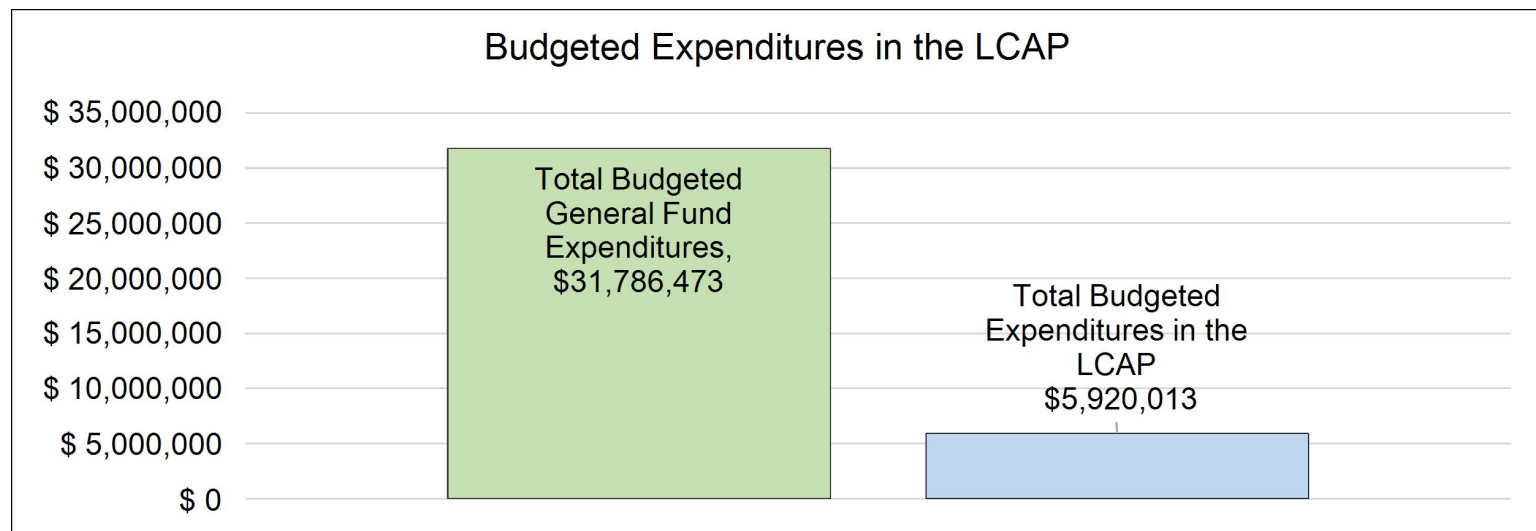


This chart shows the total general purpose revenue Plumas Lake Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Plumas Lake Elementary School District is \$32,078,086, of which \$23,595,219 is Local Control Funding Formula (LCFF), \$4,302,162 is other state funds, \$3,438,745 is local funds, and \$741,960 is federal funds. Of the \$23,595,219 in LCFF Funds, \$1,944,434 is generated based on the enrollment of high needs students (Foster Youth, English learner, and low-income students).

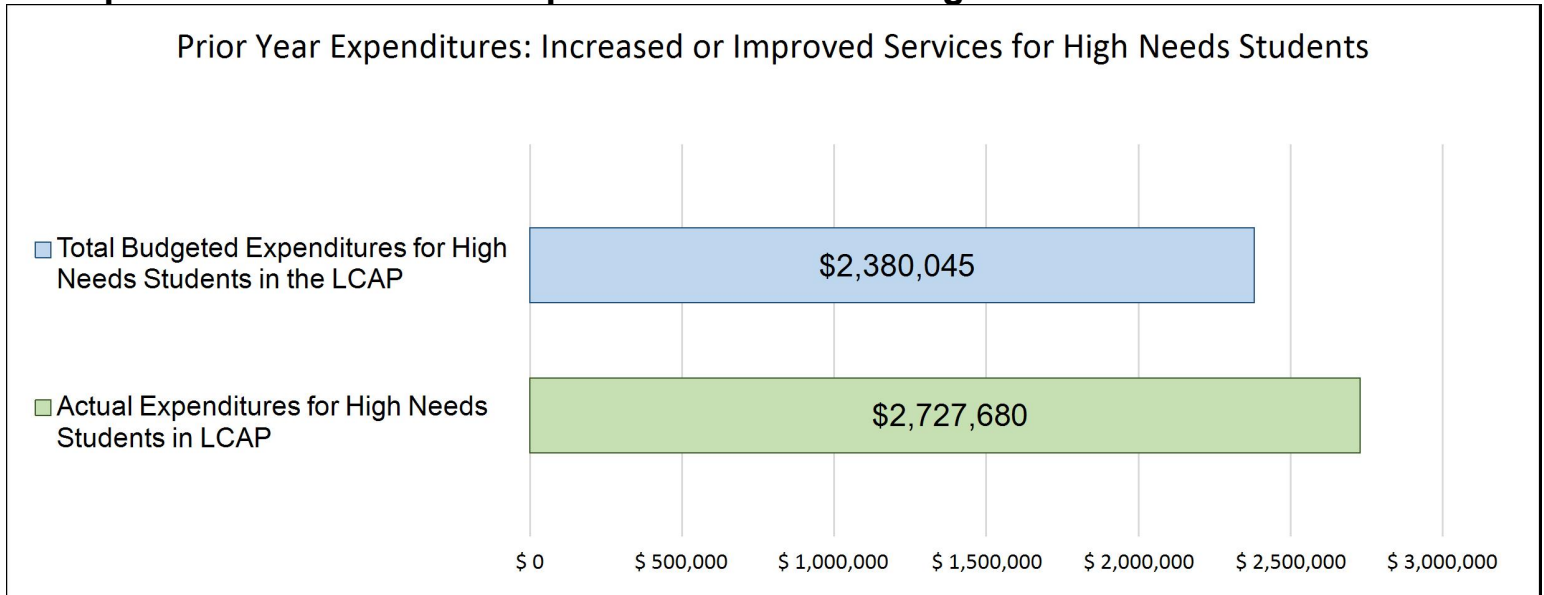

Plan Summary [2026-27]

General Information

Plumas Lake Elementary School District serves the students of Plumas Lake, an unincorporated area of Yuba County. The school district has been in service for over 150 years, but was a small rural district with one school until the early 2000's when the community began to grow. The District in coordination with the developers built 3 schools in four years and saw enrollment grow from about 100 students to 1000. After the recession, the district has seen a growth of over 750 students in the last 7 years. Currently PLESD is serving 1903 students at 3 school sites. In August of 2027, the District will open a fourth site.

Through our strategic planning process it is clear that the Plumas Lake parents strongly value the small community feel of our schools. One of the clear goals for both parents and teachers is to remain focused on providing small class sizes with no combination classes. In grades TK-3, all classes are below 24:1 ratio and all 4-8 grade core classes have 28 or fewer students.

The student demographics broken down by ethnicity shows 31.8%% of students are White, 34.5% are Hispanic, 11.5% are Multi-ethnic, 13.5% are Asian and 4.1% are Black. Socio-economically Disadvantaged students make up 55.9% of our student population, 13.5% of our students are enrolled in Special Education and 9.6% of our students are English Learners.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

On the CAASPP ELA and Math, PLESD students continue to score well as compared to other students in the area and neighboring counties and the State of California. In English Language Arts 49.03% of students were proficient which increased by 1.97% and was .2% above State Average. State Dashboard data shows that on average students scored 5.9 points below standard which maintained by 1.6 points. Students with Disabilities, African American, English Learners, Hispanic, Asian, and Socioeconomically Disadvantaged struggled. In Mathematics, 35.28% of students were proficient. This was a slight decrease of 1.01% from the prior year. State Dashboard data shows that on average students scored 38.4 points below standard which declined by 6.2points. The same student groups also struggled with math.

Chronic Absenteeism still is higher than prior to Covid. Last year 8.7% students were chronically absent which declined 2% from prior year. Our Hispanic (12.5%) and White (11.2%) students are chronically absent more than the average. However, this subgroup data still represents a slight improvement.

Suspension data showed 3.8% of PLESD students were suspended at least 1 day in the 2024-25 school year. This maintained .2% from the prior year.

Our lowest response still had a 75.1% satisfaction rating on the Anti-Bullying/ Positive Citizenship Initiative.

On June 4, 2026 both union leaders were emailed with the opportunity to meet to discuss the LCAP. Neither chose to meet. Class size reduction has continued to be a priority in PLESD.

We are extremely pleased with the progress our site teams have made with the collection of data (DIBELS, ELPAC, & STAR), analysis of screening and progress monitoring data and planning for intervention.

We've had about half of the a school year implementing ECRI. The consultant will continue to work with our teams through 25-26 beginning in August with data analysis, instructional planning, and progress monitoring.

All current Special Education staff and most paraprofessionals have participated in OG training.

PLESD has made good progress toward implementing Thinking Classrooms in math. New hire teachers are registering for the summer intensive training. We will continue to contract for one more year with SCOE for consultation support with thinking classrooms, PDSA cycles, and general support for the revised math frameworks.

Summative ELPAC scores reveal a 10% increase in our redesignation percentage. Riverside Meadows teachers have been participating in monthly trainings to improve instructional strategies for our multilingual learners.

The actual costs of class size staff increased due to a mid-year raise. Chose to use internal people to lead and coach the cycles of comprehensive data analysis. Due to increased Special Education needs paraprofessionals were paid out of Special Education funding. We had several unfilled positions.

Class size reduction will face an extreme challenge as the community is rapidly outgrowing the district's facilities.

Teacher turn over does make ongoing PD and sustainability a challenge. We may need to focus on the rate of staff turn over as well.

District education specialists have benefited greatly from the OG teaching strategies. The curriculum is, however, needed less frequently now that ECRI is in place.

Our best attempts will be made to continue small class size.

Administrators have had a final year meeting with out consultant and have planned PD before the start of school for teachers to have reading and math data ready for instructional planning on the first days of school.

We will have several new teachers who will need the initial ECRI training and veteran teachers who will receive ongoing coaching.

Further OG trainings will not be provided. Instead staff will focus on ECRI. Paraprofessional staff would benefit from ECRI training as well.

PLESD is planning for sustainability of BTC and will continue with a math TOSA position.

PLESD will participate in the Solution Tree the Professional Learning Communities at Work trainings

In addition, teacher lead English learner strategy modules are being planned at the elementary schools.

The social and emotional aspect of learning is extremely important to the overall success of students and families. This was a major finding throughout the strategic planning process and even though 86% of parents were satisfied with our SEL program and 74% were satisfied with the Anti-bullying/Positive Citizenship initiative, these were some of the lowest satisfaction rates on the survey.

Our sites continue to focus on restorative practices. New teachers receive training on restorative practices and admin use restorative questions when responding to disciplinary concerns or student conflict. Office staff are kind and welcoming to all students and parents when they come into the office which fosters a positive learning environment. PLESD Psychologists and Counselors are running individual as well as group skill based support opportunities and we have been consistent in establishing reintegration and safety plans for students who have

experienced a mental health crisis. We are also able to provide on site therapy through the LCSSP grant. Our teaching staff knows their students beyond their academic levels and work hard to find commonalities to help in making connections.

Received a grant that allowed the District to use outside consultants versus our own staff. The actual staff costs of Behavior System action increased due to a mid-year raise.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

One way of monitoring this goal is through suspension data which currently sits at 3.8% which is a total of 66 kids district wide that have received a suspension. This is a decrease of 0.5% from last years data. An area we need to continue to work on is the reintegration of students after a suspension. We still had 38 students district wide who were suspended more than one time.

Next year we will be combining the 5 components of SEL with restorative practices to show how they connect to each other. This will allow us to add more SEL content without rolling out a new initiative. We also now have good data regarding what the common infractions are and where they are occurring which will allow us to target more specific areas. For example, 61 of the 104 suspensions have been for fighting or a violent or aggressive act. This data helps us establish target skills that need to be focused on. Next year we will also be adding a series of student culture surveys that will give is more immediate data.

At present time we have dropped our chronic rate over 4% as it currently sits at 6.1% In coordination with the county LCSSP grant our prevention specialist targeted students at two of our three school sites who were on the chronically absent list. This has proven to be successful as we have pulled 12 students off of that list that were on it prior to being targeted. Site attendance clerks ran effective positive attendance initiatives rewarding students for positive attendance. We continued our regular attendance meetings, held SART meetings, and

made numerous referrals to the South County SARB. This year we also added a series of attendance meetings with the other districts in south county. This allowed to share successes as well as challenges we are having and brainstorm best practices.

The actual staff costs of the Positive Environment action increased due to a mid-year raise.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

We were very effective in accomplishing the goal of improving attendance in regards to the chronically absent list. Overall ADA did not improve as much as we thought it would even though we have dropped our chronic rate by over 4%. This means less students are absent over 18 times, but more students overall are still missing school.

We are currently proposing using our prevention specialist differently and adding on site attendance support at two of our schools. Through the LCSSP grant we are trying to add a 2 hour position that is on site daily to target students and work on reward systems and recognition for staff and parents. The prevention specialist will focus more on family resources, monitoring excessive absence cases, and following up on SART meetings. At the end of this year we overhauled our SART meetings and will be making those changes to start the 25-26 school year in an effort to be more consistent in monitoring attendance after an intervention.

Purpose

- **5. Total Planned Percentage of Improved Services (%)**
 - This amount is the total of the Planned Percentage of Improved Services column.
- **8. Total Estimated Actual Percentage of Improved Services (%)**
 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- **13. LCFF Carryover — Percentage (12 divided by 9)**

- This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
