




This chart shows the total general purpose revenue Evergreen Institute of Excellence expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Evergreen Institute of Excellence is \$2,671,944, of which \$2,414,084 is Local Control Funding Formula (LCFF), \$232,360.00 is other state funds, \$25,500.00 is local funds, and \$0.00 is federal funds. Of the \$2,414,084 in LCFF Funds, \$277,808.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



General Information

Evergreen Institute of Excellence (EIE) is authorized under the Evergreen Union School District.

The school opened August 2015, operating as a Personalized Learning program serving TK-12th grades. The school is governed by our Advisory Council, with oversight provided by the Evergreen Union School District Board of Trustees. Evergreen Union School District fully supports and is committed to the success of the school and educational opportunities EIE provides to our community and surrounding area. Evergreen Institute of Excellence currently serves TK-12th grade students. Our mission is to, "...empower students to take charge of their education by connecting their individual needs and interests to a rigorous learning plan, thus creating responsible citizens, critical problem solvers, and lifelong learners." EIE provides a Flex-Based Personalized Learning program that follows California Independent Study law and regulations, including state independent study attendance accounting. EIE is committed to assisting parents who choose this flexed-based instruction model for their children. Families remain key to the success of the school coupled with highly qualified teachers and sound standards based curriculum. To facilitate success, each EIE student is assigned a credentialed teacher that works with the parent/guardian and student to create a personalized learning program based on student strengths, needs and interests.

The school provides standards based curriculum that emphasizes the development of strong core learning competencies necessary to lead a fulfilled and successful life. Particular attention is devoted to English/Language Arts, Mathematics, Science and Social Studies. EIE supports high school students choosing to be concurrently enrolled in our local junior college, Shasta College. This support allows high school students to explore higher education and vocational opportunities. Additional resources and broad course of instruction are offered in the areas of Visual and Performing Arts, Physical Education, Technology, as well as a variety of elective subjects using vendors, online software programs and community college concurrent enrollment. In addition to their Assigned Credentialed Teacher, students are supported by EIE

staff that includes the Director, Math and Science teachers, high school guidance counselor, Special Ed, paraprofessionals, extra curricula vendors and other staff through EUSD, such as Librarian, IT and Special Education Director.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Evergreen Institute of Excellence is successful in serving students and their families which is evident in a high Attendance Rate, Low Chronic Absenteeism, Low Suspension Rate and Low Drop Out Rate of Middle School and High School students. Our Attendance Rate is above District, County and State Averages. Our Chronic Absenteeism, Suspension Rate and Drop Out Rates are below the District, County and State averages. EIE students are continuing to increase year over year towards College Career Preparedness as demonstrated through the state's indicators.

Evergreen Institute of Excellence students continue to show year over year growth and improvements, as demonstrated through our local assessments, toward grade level standards to be at or above grade level, especially when the student has been with us three or more years. EIE continues to score in the 4/5 range for our Charter School Climate Survey, according to our students. Parents also continue to rank EIE high on our annual LCAP survey.

This year, EIE was able to maintain in person offerings for intervention, enrichment and classes providing two days a week onsite for our high school students and one day for TK-6th students. With the increase in onsite offering there was a need to help transport students who may not have been able to attend, the EIE van and staff were used for this service.

EIE invested in SEL for our middle and high school students through two sessions of 5 Peaks Bootcamp. This allowed new to EIE students an opportunity for guidance in goal setting, communication and learning new behaviors towards healthier choices.

Advisory Council Meetings held throughout the school year kept the LCAP in the forefront of planning and development. Multiple reviews of the 24/25 LCAP, State priorities, expectations, goals and progress were discussed by council members. Member were provided a LCAP survey to complete.

Team and Touch Base meetings looked at State priorities, EIE local data, charter needs, and responded to LCAP survey. Additionally this year we reviewed our mid-cycle WASC progress, which aligns with our LCAP gaols.

Parent/Teacher Triad meetings were focused on student achievement, LCAP goals and program needs for each student.

Informal feedback from students was captured through weekly/bi-weekly teacher/student meetings and/or in person opportunities while on campus.

The Advisory Council reviewed LCAP progress several times during 2024/2025 school year. The 2024-25 Mid-Year Report was presented and reviewed February 4, 2025. 2025-26 LCAP recommendations solicited and given during our regular meetings on March 4, 2025. The LCAP Partnership Survey was provided following our May 6, 2025 council meeting. An additional meeting June 3, 2025 was held to provide final input and approval to continue with the three sub-goals as outlined. Adjustments to the draft LCAP were made and the final plan will be provided to the EUSD Board of Trustees for approval at regularly scheduled Board meetings June 17 and 24, 2025.
