Plan Summary [2025-26]

General Information

Futures High School is an independent charter high school serving approximately 460 students in grades 9–12. Located in the Del Paso Heights community at 900 Grace Avenue in Sacramento, Futures has operated since 2004 under the authorization of Twin Rivers Unified School District (TRUSD). The school maintains strong enrollment and serves a student population that includes a high percentage of socioeconomically disadvantaged students and English Learners—many of whom are newly arrived immigrants attending U.S. public school for the first time.

Futures' charter was most recently renewed by Twin Rivers USD in February 2025, reaffirming the school's strong commitment to its mission. Originally founded by community leaders and families seeking both academic rigor and real-world career preparation, Futures supports students in achieving postsecondary success—whether through college, university, or direct entry into the workforce. Families also value Futures as a safe, welcoming environment where immigrant students can begin their transition into American society.

Futures High School is a member of the El Dorado Charter SELPA and employs a full-time RSP teacher and two full-time RSP paraprofessionals to support students with disabilities. The SELPA provides the school with access to professional development for staff and administrators, Alternative Dispute Resolution supports, facilitation for root cause analyses, and guidance related to Program Indicator Reviews and other state accountability processes.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

A review of California School Dashboard and local assessment data highlights key areas of progress and continued need at Futures High School. The 2023 Dashboard indicates that English Learners, socioeconomically disadvantaged students, and white student subgroups received the lowest performance levels on one or more state indicators in both English Language Arts (ELA) and Math.

English Language Arts (ELA) – CAASPP Performance:

2022: 12.09% Exceeded | 27.47% Met | 24.47% Nearly Met | 32.97% Not Met | Participation: 98%

2023: 10.30% Exceeded | 24.10% Met | 26.40% Nearly Met | 39.10% Not Met | Participation: 84.78%

2024: 13.40% Exceeded | 24.74% Met | 25.77% Nearly Met | 36.08% Not Met | Participation: 95% (unofficial)

ELA results show an upward trend in the percentage of students exceeding standards, reaching a three-year high in 2024. While the dip in 2023 reflected pandemic recovery challenges, the rebound in 2024—particularly among higher-performing students—suggests that instructional shifts and literacy-based interventions are taking hold. Despite these gains, over one-third of students remain in the “Not Met” category, reinforcing the need for continued targeted support.

Futures’ ELA performance exceeded that of several neighboring schools with similar demographics. The gap between socioeconomically disadvantaged students and the overall student group was narrow, indicating equitable improvement. English Learners, while still performing below the overall average, showed gains, particularly in math, with performance increasing from 2.5% to over 5% meeting or exceeding standards.

Mathematics – CAASPP Performance:

While math continues to be a challenge, Futures has shown incremental growth in the “Met” category each year since 2022. The consistent 100% participation rate enhances the reliability of this data. A slight decline in students exceeding standards in 2024 is an area of concern, but the growing number of students meeting standards reflects the positive impact of new pacing guides, developed collaboratively by the math team and instructional coaches, as well as a renewed focus on foundational math skills.

Local Diagnostic Data:

Local assessments offer further insight into growth:

ELA: In fall and winter, 16% of students performed at or above grade level. A total of 24 students moved out of the “3 or more grade levels below” category, and the percentage of students at or above grade level increased by 6%, reflecting measurable academic progress.

Math: 35 students moved out of the “3 or more grade levels below” category, suggesting that foundational skill-building strategies and new instructional resources are supporting student acceleration.

Summary of Findings:
The gains seen in both ELA and math performance—particularly in the “Met” and “Exceeded” bands—reflect the intentional, data-driven work of Futures’ educators. While a large proportion of students remain in the lowest performance band, the data validates that the school’s intervention strategies are beginning to yield results.

Futures remains committed to closing achievement gaps, especially for English Learners, socioeconomically disadvantaged students, and students with disabilities. These subgroup disparities continue to inform the school’s LCAP goals and Title I, Part A Schoolwide Program (SWP) planning. Futures will continue using a combination of state and local data to drive instructional improvement, allocate resources, and refine supports for students most in need.

In shaping our LCAP, we actively engaged educational partners, recognizing the value of their perspectives in aligning our goals with student and community needs. Their input directly informed several key areas of focus.

For example, partners emphasized the importance of preparing students for postsecondary success, which led to the development of Goal 1: Preparing Students for College and Career (Actions 1–6). In response, we enhanced our career exploration programs, strengthened academic counseling services, and expanded support for college and workforce readiness.

Feedback also highlighted the urgency of closing academic achievement gaps, prompting the creation of Goal 2: Increase Academic Achievement and Close Achievement Gaps (Actions 1–5). These actions include increased professional development, implementation of targeted academic interventions, and more strategic resource allocation to support historically underserved student groups.

Additionally, our partners stressed the need for stronger support of students' social-emotional well-being. This input informed Goal 3: Foster a Positive Culture and Climate (Actions 1–6), which includes strategies to build safe, supportive, and inclusive school environments.

Input from the School Site Council (SSC) played a particularly important role in identifying resource gaps in academic and wellness supports. Their review of disaggregated student performance data led to the inclusion of Title I-funded actions focused on early identification of struggling students and the provision of targeted, evidence-based interventions under Goal 2. The SSC also advocated for consistent access to social-emotional supports, reinforcing the design of Actions 3.3–3.5 under Goal 3.

By integrating this feedback, the LCAP reflects the shared priorities of our educational community and strengthens our collective commitment to student success.

An explanation of why the LEA has developed this goal.

<p>The LEA developed this goal in direct response to persistent academic performance gaps and the need to better prepare students for postsecondary success. Across the LEA, a significant percentage of students are performing below grade level in literacy and mathematics, as evidenced by state and local assessment data. These academic challenges—particularly among English Learners, socioeconomically disadvantaged students, and students with disabilities—underscore the need for a comprehensive approach to instruction and support.</p> <p>In addition to academic achievement, students require access to a wide range of experiences that connect their learning to real-world college and career opportunities. This includes exposure to rigorous, standards-aligned instruction; integrated CTE pathways; dual enrollment opportunities; and strong academic and career counseling.</p> <p>By establishing this goal, the LEA is committed to closing achievement gaps, expanding course access, and providing students with the knowledge, skills, and support systems necessary to graduate ready for college, career, and lifelong learning. The goal also reflects stakeholder priorities—particularly the emphasis on relevant, future-oriented learning—and aligns with multiple state priorities related to conditions of learning, pupil outcomes, and student engagement.</p>

Goal Analysis [2024-25]

Futures High School fully implemented the planned actions under Goal 1 to support the development of college and career readiness. This included investments in certificated and classified staffing, supplemental instructional materials, and access to a safe and supportive learning environment. These strategies enabled the school to provide targeted academic support, CTE pathway access, and college readiness preparation.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Several actions showed differences between budgeted and actual LCFF expenditures:

Action 1.1 (Certificated Staff): Actuals came in below the planned \$1,048,179, totaling \$916,893 due to staffing changes and partial-year vacancies.

Action 1.3 (Professional Development): Significantly underspent (\$10,541 vs. \$81,996 planned); however, PD was still provided using alternate funding sources.

Action 1.4 (Supplemental Instructional Programs/Resources): Reported lower LCFF expenditures (\$123,420 of \$210,280.78 budgeted), but materials and supports were fully delivered using a blend of restricted funds.

Action 1.5 (Events and Activities): Actual LCFF spending totaled \$1,199 vs. \$6,651 planned; student engagement activities were maintained through alternative site-based budgets.

Action 1.6 (Clean and Safe Facilities): Actuals exceeded the original \$5,000 plan, with \$65,523 in expenditures—reflecting a shift to use LCFF to address immediate site facility needs.

All actions were carried out in full, though LCFF expenditures were supplemented or replaced with other sources where appropriate.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The actions taken under Goal 1 were effective in advancing college and career readiness. Increased access to high-quality staff and instructional supports improved student participation in CTE and dual enrollment. Facilities investments enhanced the learning environment for pathway-aligned, hands-on experiences. Although LCFF expenditures did not fully reflect the scope of work due to alternate funding use, outcomes such as pathway enrollment, credit completion, and student engagement indicate progress toward goal metrics.

No substantive changes have been made to the goal or core actions for 2025–26. Based on implementation reflections, the school will strengthen alignment between planned LCFF expenditures and actual funding sources, particularly in the areas of professional development and student events, to ensure better tracking and reporting of college and career readiness supports.

An explanation of why the LEA has developed this goal.

This goal was developed in response to student performance data that reveal persistent gaps in academic achievement—particularly in English Language Arts and mathematics—and a need to better serve underperforming student subgroups, including foster youth, socioeconomically disadvantaged students, English Learners (ELs), Long-Term English Learners (LTELs), and students with disabilities (SWDs). Standardized test results across the LEA indicate that a significant number of students are not meeting proficiency levels, and that achievement gaps remain consistent across multiple years.

To address these disparities, the LEA recognizes the importance of providing differentiated academic supports, expanded intervention services, and high-quality enrichment opportunities that engage students and support growth across the achievement spectrum. This goal also reflects feedback from educational partners calling for targeted efforts to accelerate learning and expand access to rigorous academic and enrichment programs—especially for historically underserved populations.

By focusing on academic growth and equity, this goal aims to ensure that all students have access to the resources, instruction, and opportunities they need to succeed, while strategically closing performance gaps for the most vulnerable student groups. The goal aligns with multiple state priorities and supports a system-wide approach to continuous academic improvement.

Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Overall LCAP goal 2 Implementation: All actions under Goal 2 were implemented to support improved academic achievement and address the needs of low-performing students. This included expanding certificated staff for intervention and credit recovery, classified staff for instructional support, and professional development aligned to student learning needs. While some expenditures were reported under alternate funding sources, all planned services were provided. Instructional materials and student engagement events were delivered using Title I and other federal funds, allowing LCFF dollars to be redirected toward staffing where student need was greatest.

Title 1, Part A - SWP Requirement:

Goal 2 was implemented as designed. Title 1, Part A funds were used to hire certificated and classified staff were hired to provide Tier I and Tier II support to students struggling in core academic areas. Daily intervention blocks were maintained, and targeted supports for English Learners were offered via small-group and push-in services. Professional development included RTI and data-driven instructional practices.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 2.1 (Certificated Staff): Actual expenditures exceeded the planned amount (\$329,140 vs. \$226,531), reflecting increased investment in academic intervention and support staff.

Action 2.2 (Classified Staff): Actual expenditures were lower than planned (\$64,712 vs. \$143,351), due to staffing turnover and partial-year vacancies.

Action 2.3 (Professional Development): Slight overspending occurred (\$51,364 vs. \$26,830) as more sessions were offered to staff to address learning loss and data-driven instruction.

Action 2.4 (Instructional Programs and Resources): No LCFF expenditures reported, as these materials were funded through other categorical sources.

Action 2.5 (Activities and Events): No LCFF expenditures recorded, but academic events and family engagement efforts were implemented using alternate funds.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Overall LCAP Goal 2 Effectiveness: Certificated staffing and expanded professional development were highly effective in increasing access to targeted academic supports, particularly for students performing below grade level. Instructional practices were enhanced through training focused on differentiation and intervention strategies. Although S/C grant did not fund all planned materials and events, those services were still delivered and contributed to improved engagement and instructional access for low-performing students. Areas like classified support could be strengthened with more consistent staffing.

Title 1, Part A - SWP Requirement:

Early results from local diagnostic data show that approximately 23 students moved out of the lowest reading category, and 35 students advanced at least one level in math. However, EL subgroup progress in math remained limited. Intervention sessions were more effective for SED and White subgroups, but additional targeted EL supports are necessary. Based on subgroup progress monitoring, Goal 2 actions were partially effective in increasing academic outcomes and closing gaps.

Overall LCAP Goal 2 Description of Changes: No major changes have been made to the goal or actions for 2025–26. However, to improve alignment between budget and implementation, the school will prioritize early hiring for classified roles and ensure clearer tracking of alternate funding used for instructional resources and student events.

Title 1, Part A - SWP Requirement:
Based on this analysis, Futures will revise its intervention strategy to include more structured math tutoring specifically for EL students, implement new assessment tools to better identify skill gaps, and increase alignment between classroom pacing and diagnostic data. Ongoing evaluation will continue via progress reports and subgroup disaggregation during SSC and leadership team data reviews.

The LEA serves a high percentage of unduplicated students—including low-income students, foster youth, and English Learners—who often face increased barriers to academic success and long-term school engagement. Research and internal data show that these students are at a higher risk for chronic absenteeism, disengagement, and dropping out. In response, the LEA has prioritized the development of a safe, supportive, and inclusive school climate that actively fosters student well-being, belonging, and connectedness.

This goal is designed to increase student attendance, engagement, and retention by providing access to social-emotional supports, behavioral interventions, health and wellness services, and meaningful enrichment opportunities. It reflects both student and stakeholder feedback emphasizing the need for nurturing environments where students feel seen, supported, and empowered to succeed.

By investing in a positive culture and climate, the LEA aims to address barriers to learning while creating conditions that help every student thrive—academically, socially, and emotionally. This goal aligns with multiple state priorities and reinforces the belief that strong school climate is foundational to academic growth and equitable outcomes.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Futures High School fully implemented its planned actions under Goal 3 to enhance student engagement and SEL supports. Classified staff and instructional resources played a significant role in increasing access to mental health services, behavior supports, and engagement initiatives. Certificated staff support and professional development were adjusted mid-year based on evolving site needs. Activities and events were successfully expanded beyond original plans, helping to re-engage students.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 3.1 (Certificated Staff): Underspent (\$19,052 actual vs. \$45,345 planned) due to staffing reassignments and partial-year coverage.

Action 3.2 (Classified Staff): Slightly overspent (\$321,093 actual vs. \$303,193 planned) to meet increased needs for SEL-related student supports.

Action 3.3 (Professional Development): Overspent (\$34,429 actual vs. \$5,979 planned) due to expansion of trauma-informed practices and SEL training for all staff.

Action 3.4 (Instructional Resources): Slight underspending (\$158,966 actual vs. \$180,305 planned), though all planned resources were purchased.

Action 3.5 (Events and Activities): Significantly overspent (\$126,339 actual vs. \$5,000 planned), reflecting a successful and expanded push to improve student belonging and engagement.

Action 3.6 (Supports for Homeless and Foster Youth): No LCFF expenditures reported, but services were provided using Title I and McKinney-Vento funds.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Goal 3 actions were effective in increasing student engagement, access to SEL supports, and connection to school culture. Increased staffing and targeted professional development improved staff capacity to address behavioral and emotional needs. Engagement events and schoolwide initiatives created a more inclusive environment, particularly for students struggling with attendance and motivation. The expanded use of classified staff and SEL training helped stabilize campus climate and improve student outcomes.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

No changes have been made to the core goal or metrics for 2025–26. Moving forward, the school will refine spending projections to better reflect actual needs for engagement programming and PD. Additionally, efforts will be made to more clearly track and report services for foster and homeless youth, even when funded outside of LCFF.

Additional Concentration Grant Funding

FHS will utilize the additional concentration grant add-on funding—totaling approximately 15% of its LCFF allocation—to increase the number of staff providing direct academic support to students at schools serving high concentrations of foster youth, English learners, and low-income students.

Funding under Goal 2.1 will be used to hire additional certificated staff, including intervention teachers, who will provide targeted instruction and academic intervention to unduplicated students demonstrating learning gaps. These teachers will support small-group and individualized instruction aligned to student performance data, with a focus on accelerating growth in literacy and math.

In parallel, Goal 2.2 will fund additional classified staff, such as paraeducators, who will work alongside credentialed teachers to deliver academic support during core instruction, intervention blocks, and independent work time. Their role will enhance student engagement, provide scaffolded support, and increase access to differentiated instruction.

Together, these staffing investments will ensure that our highest needs students receive consistent, personalized academic support designed to close achievement gaps and improve overall student outcomes.

 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
