Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. 2025-26 School Description and Mission Statement

New Vista Middle School provides a supportive and academically rigorous learning environment for students in grades six through eight. As students progress through their middle school experience, they transition from a two-teacher instructional model in sixth grade to a departmentalized structure in seventh and eighth grades.

The staff at New Vista Middle School is dedicated to ensuring the success of every student through comprehensive academic programs, targeted intervention strategies, and enrichment opportunities designed to meet diverse learning needs. In addition to a strong academic focus, the school emphasizes the importance of relationships and connectedness among students and staff.

This culture of engagement is strengthened through initiatives such as Capturing Kids' Hearts and mentoring programs like

Elevo, which support students’ social, emotional, and academic growth. Additional opportunities for involvement and leadership include ASB, Leadership, AVID, Band, lunchtime activities, Family Game Nights, and Cultural Heritage events, among other positive campus experiences. Student engagement and satisfaction are reflected in consistently strong attendance rates and favorable survey data.

To support student success at New Vista Middle School, the Positive Behavioral Interventions and Supports (PBIS) program was implemented in 2015. As part of this program, NVMS promotes the principles of ROAR—being Respectful, taking Ownership of actions and property, striving for Achievement, and being Responsible. Since the implementation of PBIS, the school has earned a Silver Level of Implementation from the Los Angeles County Office of Education (LACOE), recognizing its strong commitment to maintaining a positive school climate and providing behavioral support for all students.

Building on this foundation, NVMS established a partnership with the Flippen Group to implement the Capturing Kids’ Hearts program, utilizing its EXCEL strategies to strengthen relationships and engagement across the campus. These strategies have had a measurable impact on school culture, fostering stronger student connections, greater self-awareness, and improved academic performance.

A central focus at NVMS is the continuous professional development of teachers as a key driver of student achievement. The school actively engages educators in research-based training and collaborative learning opportunities designed to enhance instructional practices and improve student outcomes. NVMS partners with UCLA Center X’s professional programs, including the Science Project and History-Geography Project, to provide teachers with high-quality professional learning aligned to state standards and inquiry-based instructional approaches. Through these partnerships, teachers deepen their content knowledge, refine pedagogical skills, and implement strategies that promote critical thinking, engagement, and equity in the classroom.

New Vista Middle School offers a diverse selection of elective courses designed to foster creativity, leadership, and exploration of future college and career pathways. These include STEM (Science, Technology, Engineering, and Mathematics), Band, Leadership, Choir, Guitar, Art, Multimedia, Drama, Spanish I and II, Yearbook, Podcasting, and Computer Literacy. Technology plays an important role in student learning, with tools such as PRSIMS VR headsets integrated into math instruction to enhance engagement and deepen conceptual understanding. Students further enrich their learning through extracurricular and co-curricular opportunities such as athletics, Robotics, and GATE classes and enrichment activities.

All of these initiatives are in alignment with the goals outlined in our Single Plan for Student Achievement (SPSA): to increase CAASPP scores in ELA, Math, and Science, provide targeted support for multilingual learners, and continue to cultivate a school-going culture where students are motivated, engaged, and connected to their learning community.

New Vista Middle School remains committed to continuous improvement in both instructional quality and student programs. By investing in staff development, strengthening academic and elective offerings, integrating innovative technology, and fostering a supportive learning environment, NVMS ensures that all students are equipped to reach their full potential, prepare for college, and pursue their chosen career pathways with confidence. At NVMS, we take pride in cultivating well-rounded students who embody the spirit of the Tiger—respectful, responsible, and ready to achieve.

General
The district takes great efforts to ensure that all schools are clean, safe, and functional. Maintenance and Repair
District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Cleaning Process and Schedule
The district governing board has adopted cleaning standards for all schools in the district. A summary of these standards is available at the district office. The facilities department works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Budget
Although the State no longer requires a Deferred Maintenance contribution, Lancaster School District is still dedicated to maintaining the facilities for our students. These expenditures would include but not be limited to roofing, plumbing, heating, air conditioning, electrical, painting, and flooring. For the 2024-25 school year, the district has budgeted \$2,683,000. for deferred maintenance projects.

Professional Development

The Lancaster School District provides professional development throughout the school year that trains and supports staff in the effective implementation of our adopted core and cornerstone programs including, but not limited to: Teacher Clarity, PLC+, Standards-Based Grading and Reporting, Structured Literacy, Data Analysis, Leadership Training, Writing Instruction, Coaching, Direct Instruction, Conceptual Development, Building Academic Vocabulary, Culturally Responsive Teaching and Learning (including Capturing Kids Hearts), Integrating Technology into the Classroom, PBIS, Intervention, and Differentiation in Strategies for teaching Multilingual Learners and at-risk students. High-quality, ongoing professional development opportunities are recognized as an important component in our work towards continuous improvement in student learning.

Ongoing opportunities include in-services during and after the work day as well as through site and district in-class and on-site coaching. All teachers are provided multiple opportunities to receive optional paid professional development. The school year calendar allows for 37 minimum days in which 26 days are utilized to provide 1-2 hours of district and site designed professional development specific to their needs. Outside workshops, conferences and other in-services that provide more in-depth training and further prepare our staff members to become trainers for our district are available as approved by the Board of Trustees.

Professional development supporting our instructional programs and services for students is also provided for our classified staff members. Additionally, workshops designed to improve technology skills, provide training with key software programs utilized in the district, and offer information on personal excellence and social responsibility are included in the professional development course offerings for classified staff throughout the school year.
