New LEAs to the SELPA: Your access will be limited until SELPA and SEIS have completed and created all your accounts. Your Program

Technician will be reaching out to you to meet for a one-on-one training session.

RETIRED SERVICE AND SERVICE LOCATION CODES

As of July 1, the following codes will be retired from CALPADS and SEIS:

Service Location

• 570 - Charter Schools. 510 - Regular classroom/public day school is the appropriate code for Charter Schools going forward, this will apply to LEAs adopting students from Charter LEAs

Services


- 350 Individual and Small Group Instruction
- 540 Day Treatment Services

As of July 1st, these codes will trigger an error. Unaffirmed meetings that were using any of these codes will need to be updated prior to affirming. LEAs will also encounter errors when submitting adoptions to CALPADS. Per CALPADS: district level users will need to edit service locations that is representative of your LEAs intentions. LEAs will need to update these codes at the 30-day when a student enrolls.

For continuing students, these codes will be updated at the student's next IEP event.

CALPADS EOY 3 and EOY 4 Certification

To ensure that all enrollments for students with disabilities are exited appropriately, LEAs should certify EOY 3 and EOY 4 with the **SAME snapshot date and time**.



Our goal is to have LEAs "SELPA Approved" by the first certification deadline of July 25, 2025. Please find our EOY checklist <u>here.</u>

Transition to Regional Workgroup Model for 2025–26

In 2025-26, the SELPA is moving to a Regional Workgroup model, which includes the reassignment for Program Technicians. To maintain continuity, Program Technician's LEA caseloads will remain the same through End of Year final deadline, August 8th, 2025. Once EOY has closed, your LEA will receive an introduction to your new Program technician and any technical instructions to complete the transition.

SEIS <u>District Level User</u>

Postsecondary Report

Submit your postsecondary report once all data has been entered into SEIS. SELPA cannot SELPA approve without postsecondary submitted. Be sure to remind this year's graduates that you will be contacting them next year for postsecondary status.

Transfer Requests

You may add students for the upcoming school year in SEIS.

- How to Adopt a Transferred SEIS Student Record
- How to Complete and Initial CALPADS Affirm (Adoptions of a Non-SEIS or Out of State IEPs)

How to Create an Interim Placement Amendment (must be completed after all adoptions)

For new LEAs to EL Dorado SELPA, you cannot report any transactions until SEIS and CALPADS complete their academic year rollover, which could be expected in late August, early September.

Staffing Changes

Please let SELPA know of any staffing changes for District Level User Data Reporters and/or CALPADS Administrators.

Searches > Shared Search > Student is Eligible with Exit Date/Reason

SEIS <u>Provider/Case Manager</u>

Ensure your caseload is up to date

- Review your caseload to ensure it is current
- Request exits for student that are no longer enrolled, or you are no longer supporting
- Review your student's reporting LEA and school of attendance for accuracy
- Please contact your district level user for any discrepancies
