The following additional information is provided in the updated Bid Form as part of Addendum No. 3:

Q1: Please provide the total square footage for Area #2 Primary Playground.

A: Approximately 4,720 Square Feet.

Q2: Please clarify if the new poured-in-place safety surfacing for each play area is to be quoted as a line item for the scope of work?

Or is the poured-in-place district provided and installed separately from this bid?

A: Pour-In-Place is not in this RFP scope. The District is providing installation separately from the installation RFP.

Q3: Can you let me know if we are eligible to bid on this project with just a B license? The ITB says B and C-61/D-34. Is this an either/or situation, or do we need the B AND the specialty license?

A: No. California Specialty Licences C-61/D-34 are required.

Q4: We request a copy of the bid documents.

A: All bid documents can be found on the Del Mar Union School District website at:

Q5: Which play areas are getting EWF fully removed and hauled, and which are we leaving woodchips on site for the district?

A: All play areas will have the existing wood fill removed. It is at the District's discretion whether the existing wood fill will be hauled off by the awarded contractor.

Q6: Will the district or contractor be addressing any landscape repairs/re-seeding?

A: The awarded contractor is required to take precautions not to damage the existing turf, landscape, asphalt, and concrete surfaces. The awarded Contractor will be responsible for any repair work and costs.

Q7: There appears to be high gopher activity, which may affect long lasting compaction of base gravel. Would the district like to add an alternate for slurry/concrete base?

A: No, concrete subbase is included in the scope of work.

Q8: When is the play equipment set to arrive?

A: Date is TBD at this time.

Q9: What is the desired timeline of construction?

A: All work shall be performed between February 14, 2026, and April 5, 2026, and no later than June 30, 2026.

Q10: Please confirm if the plastic timbers at the swing area will be left on site for the district.

A: Yes.

Q11: Will the contractor have to transport the play equipment from the district yard to the site?

A: No. The District will have the material sent to the school site and stored at a central location. The awarded contractor will need the means and equipment to move the materials to all four (4) play areas.

Q12: Is screening required for the temporary fencing?

A: Yes.

The following RFI's pertain if the poured-in-place is to be bid as a line item for the scope of work.

Q13: Please clarify the binder type to be used within the top ½" thick colored EPDM wear course layer for the poured-in-place safety surfacing?

Aromatic or Aliphatic?

Q14: Please clarify the color of the top ½" thick colored EPDM wear course layer for the poured-in-place safety surfacing?

For each play area.
