BOARD OF EDUCATION RESOLUTION NO. 01-11-12-25 APPROVAL OF CAREER TECHNICAL
EDUCATION FACILITIES GRANT APPLICATIONS

WHEREAS,

The State of California, through the California Department of Education (CDE), the Office of Public School Construction (OPSC), and the State Allocation Board (SAB), administers the *Career Technical Education Facilities Program (CTEFP)* pursuant to Education Code Section 17078.72; and

WHEREAS,

The purpose of the CTEFP is to provide funding to qualifying Local Educational Agencies (LEAs) and Joint Powers Authorities (JPAs) to construct, reconfigure, or modernize Career Technical Education (CTE) facilities and purchase equipment to enhance educational opportunities that align with current labor market needs and industry standards; and

WHEREAS,

The Metropolitan Education District (MetroED), a Joint Powers Authority serving the six partner school districts of Campbell Union High School District, East Side Union High School District, Los Gatos-Saratoga Union High School District, Milpitas Unified School District, Santa Clara Unified School District, and San Jose Unified School District and in Santa Clara County, offers comprehensive CTE programming at the Silicon Valley Career Technical Education (SVCTE) campus to prepare students for high-skill, high-wage, and high-demand careers; and

WHEREAS,

MetroED seeks approval to submit six CTEFP grant applications under the 7th Funding Cycle to modernize and enhance instructional facilities in the following industry sectors and pathways:

1. Hospitality, Tourism, and Recreation Sector (2)

o Pathways:

1. Food Science, Dietetics, and Nutrition;
2. Food Service and Hospitality

2. Transportation Sector

o Pathway: Structural Repair and Refinishing

3. Manufacturing and Product Development Sector

o Pathway: Welding and Materials Joining

4. Information and Communication Technologies Sector

o Pathway: Software and Systems Development

5. Health Science and Medical Technology Sector

o Pathway: Patient Care

WHEREAS,

Each project will support modernization and equipment upgrades to ensure alignment with high-quality CTE standards, promote equity and access, strengthen articulation with postsecondary institutions such as Mission College, Iron Workers Local 377, and other regional partners, and meet local labor market demand across Silicon Valley's hospitality, transportation, and advanced manufacturing industries; and

WHEREAS,

The MetroED CTE Employer Advisory Boards, pursuant to Education Code Section 8070, will be convened to review and approve the proposed CTE Plans for these projects, confirming that they meet the requirements of Education Code Sections 51224, 51225.3, and 51228 regarding comprehensive high school programs; and

WHEREAS,

MetroED is committed to contributing the required local matching funds, equal to the amount of state funds requested, through local resources and/or partnerships as required by Education Code Section EC 17078.72(g)(1); and

WHEREAS,

The Governing Board recognizes that these facility upgrades will significantly enhance the district's capacity to provide industry-relevant, hands-on learning opportunities and prepare students for success in college, career, and life consistent with MetroED's mission and Vision 2030 strategic plan.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Governing Board of the Metropolitan Education District hereby approves the submission of six Career Technical Education Facilities Grant applications to the California Department of Education for the following CTE industry sectors and pathways:
 - o Hospitality, Tourism, and Recreation Sector: *Food Science, Dietetics, and Nutrition and Food Service and Hospitality*
 - o Transportation Sector: *Structural Repair and Refinishing*
 - o Manufacturing and Product Development Sector: *Welding and Materials Joining*
 - o Information and Communication Technologies Sector: *Software and Systems Development*
 - o Health Science and Medical Technology Sector: *Patient Care*
2. The Board authorizes the Superintendent or designee to execute all documents and take all actions necessary to complete and submit these applications in accordance with the *CTEFP 7th Funding Cycle Application Guidelines*.
3. The Board acknowledges that the MetroED CTE Employer Advisory Committees will be convened to review and approve each CTE project application prior to submission, in

accordance with Education Code Section 8070 and the *CTEFP 7th Funding Cycle Application Guidelines*.

4. The Board commits to providing the required local match equal to the State grant funds awarded and to maintaining the ongoing operation, staffing, and sustainability of the projects once completed.


