Paint Your Own Parking Spot Contract

I hereby agree to abide by all the following rules and regulations corresponding to my **privilege** of having a reserved painted parking spot.

- I understand that prior to painting my parking spot, I must have purchased and paid the \$100.00 for a painted spot in the green lot, turned in the parking contract, the required driving documents, and have **turned in and received administrative approval** on my painting design template.
- I agree to only use exterior all weather **WATER based (no oil-based paint is allowed)**. Paint will not be supplied by ASB.
- I understand that I am not allowed to use spray paint, reflective paint, or fluorescent paint of any kind.
- I will only paint my approved design template following all the guidelines, in my assigned numbered painted spot in the green lot.
- I understand that I must display my green parking permit while parked in my numbered painted spot.
- I understand that in the event of any unforeseen circumstances – that are out of ASB's control a refund will not be issued.
- In addition to signing this contract you must also submit a sketch of your design. It must include the exact colors you are going to use. Your name (or any other personal identifying indicators) cannot be used in your design to protect student safety, property damage, and vandalism.
- If someone is parked in your spot during the school day (periods 0-7) notify the Main Office with the following information Parking permit number, license plate number, make and model of the vehicle, and a picture of the vehicle as proof.
- You only have rights to your painted parking spot during school hours Periods 0-7. You cannot park in other parking lots on campus during school hours Periods 0-7. You will receive a parking ticket and will be in violation of the Painted Parking Contract.
- I understand that my green parking permit is only good for my painted spot and not for other spots.
- I understand that I cannot loan my parking permit and painted spot to another student. I understand that if I loan my parking permit and painted spot to another student, that student will receive a parking ticket. Repeated defiance may cause me to lose my parking permit and painted spot.
- You **CAN NOT** begin painting until you have been approved by Administration/ASB and must paint on the agreed painting day.
- I understand that painting day will be **Saturday, August 15, 2026, 8:00 am – 12:00 pm** and **only** on this date.
- I understand that repainting the parking spot black will be **after school on Friday, May 28, 2027**, and **only** on this date. Failure to attend (student or parent) on this date will result in a \$125 fee.

IF I DO NOT ADIBE BY ALL OF THESE RULES AND THE GENERAL PARKING CONTRACT RULES, I UNDERSTAND THAT MY PAINTED SPOT WILL BE TAKEN AWAY, PAINTED OVER, AND I WILL NOT RECEIVE A REFUND.
