IV. SCOTT KUYKENDALL, STANISLAUS COUNTY SUPERINTENDENT OF SCHOOLS. PRESENTATION: 3...2...1... READY OR NOT UNPLUG!

- A. Superintendent Scott Kuykendall gave a presentation in conjunction with the book The Anxious Generation by Jonathan Haidt. Kuykendall touched on technology's effects on the current generation.
 - a. Kuykendall discussed an unprecedented increase in mental health issues between the years 2010-2015 that can be linked to social media.
 - i. Major depression amongst teens has increased 135% in girls since 2010 and 161% in boys since 2010.

- b. He touched base on the infant's developing brain and urged to limit or not allow screen time for infants in the first 1000 days. If screen time is provided, it should be long-form content.
- c. Kuykendall described how a once play-based childhood is now a phone-based childhood.
- d. Scott Kuykendall encouraged parents to be proactive and try these things:
 - i. Give your children some freedom by practicing letting them out of your sight, or consider having them walk to school in a group of similarly aged children.
 - ii. After school is for free play. At school, there is always an adult present during recess, and sports are structured. Allowing free play will encourage children to learn how to resolve low-level conflicts.
 - iii. Go camping - spend time with your children unplugged and away from electronics.
