NORTH EAST INDEPENDENT SCHOOL DISTRICT Power Of Attorney Guidelines and Procedures

Our goal in the North East Independent School District (ISD) is to assist families who reside in our District with enrolling children in their care in our schools. When a parent or legal guardian under an order of a court has given permission for his/her minor child to establish a residency separate from him/her, appropriate documentation for a POWER OF ATTORNEY must be provided prior to admission into the District.

The North East ISD POWER OF ATTORNEY form must be completed by the parent or legal guardian and notarized prior to enrolling a child. A parent/legal guardian will need to complete one (1) POWER OF ATTORNEY form per child.

By receiving the POWER OF ATTORNEY, the person is affirming:

- 1. The child lives with the person and spends the night at the person's residence Sunday through Thursday;
- 2. The person as the responsible adult for the child will be listed as the primary contact on all educational records with the ability to make all educational decisions (absent revocation of the power of attorney, the campus will honor decisions made by this individual and is not obligated to further notify or solicit input from a parent);
- 3. The person will be responsible for attending conferences to include but not limited to,-teacher/school conferences, discipline conferences, and discipline hearings;
- 4. The person will be responsible for participating in and authorizing North East ISD's decisions, to include hearings and testing that may affect the child's evaluation for placement in or removal from any type of special educational classes and/or program;
- 5. The person will be responsible for monitoring the attendance of the child and liable for any truancy issues and potential penalties;
- 6. All information submitted by the person is true and if found to be false, the person understands (s)he may be subject to prosecution under 37.10 Penal Code for committing the offense of presenting a false document or false records while enrolling the child.

Once the person has obtained the notarized POWER OF ATTORNEY form, the person should contact the campus designated for the guardian's address.

The POWER OF ATTORNEY must be renewed annually at the campus. Should there be a change in the person receiving guardianship, the completion of a new North East ISD POWER OF ATTORNEY form would need to occur along with an appointment scheduled at the campus designated for the new guardian's address.
