

**Description of Project:** The Project consists of pavement rehabilitation and related improvements along 2.8 miles of South Park Drive in Lower Bidwell Park, including roadway and parking resurfacing, shoulder backing, and signage upgrades. The work will improve corridor functionality, safety, and accessibility without increasing roadway capacity and will incorporate best management practices to protect trees, vegetation, and Big Chico Creek.


