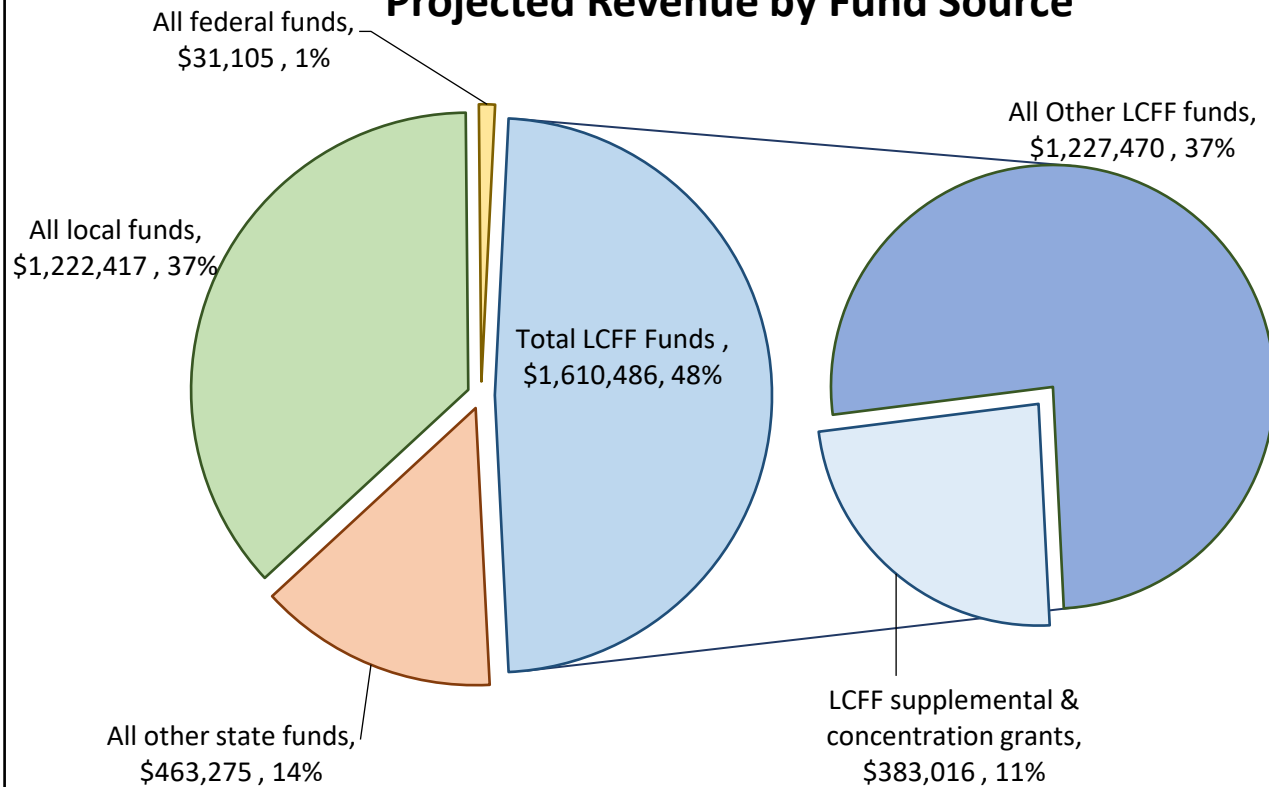

Projected Revenue by Fund Source

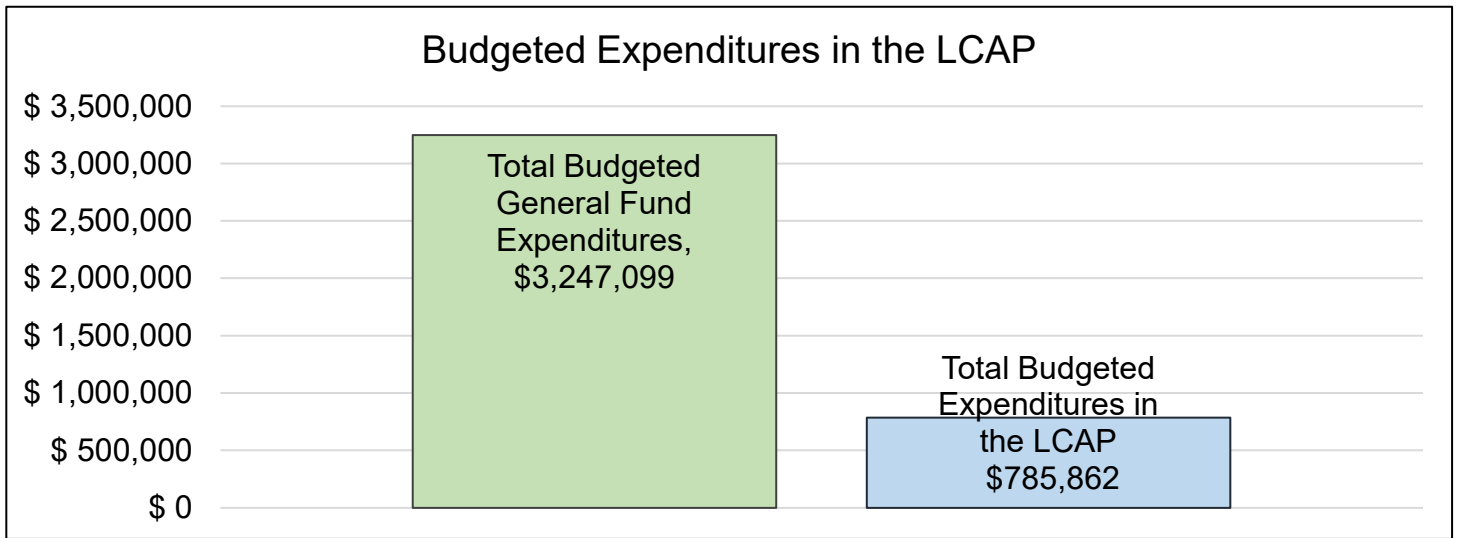


This chart shows the total general purpose revenue Winship-Robbins Elementary School District expects to receive in the coming year from all sources.

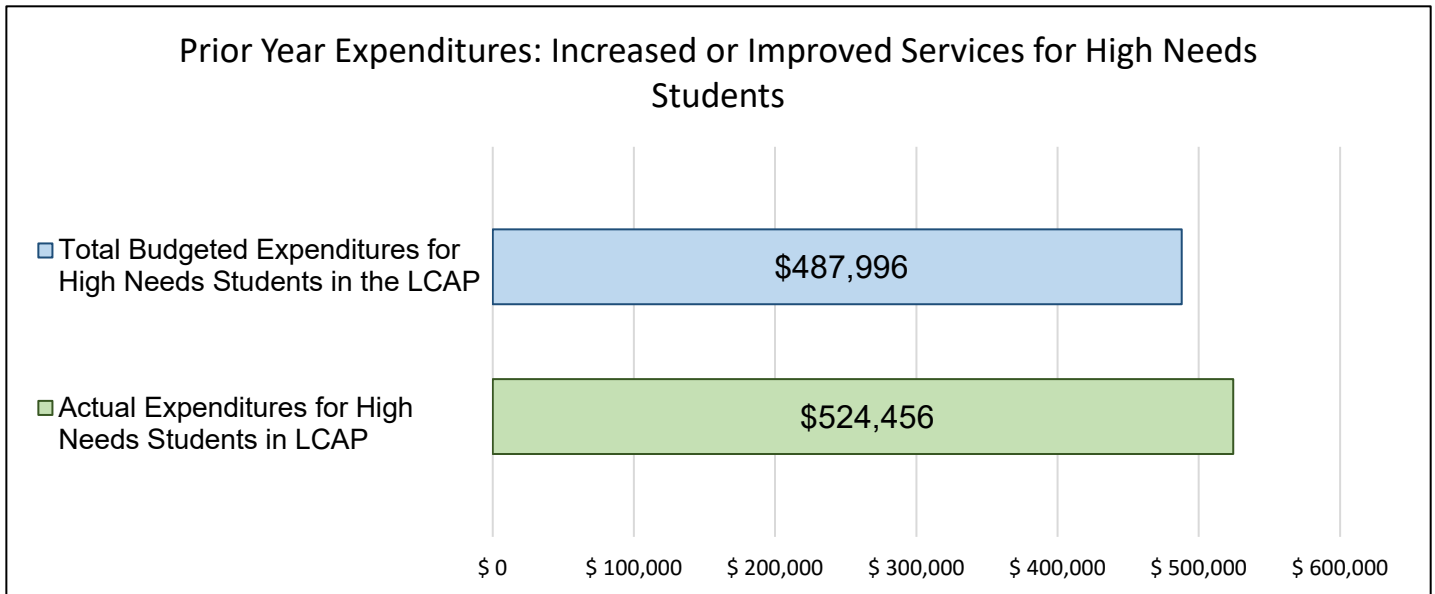

Plan Summary 2025/26

General Information

Winship-Robbins Elementary School District was formed in July 2005 when Robbins Elementary, a part of Yuba City Unified School District, joined Winship Elementary. Winship had been a one-school district in Sutter County since 1863 and Robbins School dates back to 1927. The reorganization of the two small schools into one district combined resources and strengthened the programs and services available to students. In 2016, Winship became an independent charter school authorized by the district, closing in June 2022. Robbins School, the only school in the district, is a small, rural school in the center of the Sutter Basin, in southern Sutter County. Known for its community involvement and warm, neighborly atmosphere, Robbins School strives for academic excellence through high expectations and strict compliance with the California Standards. Our staff provides students with a positive, safe educational experience that enables our students to attain his or her potential.

The Winship-Robbins Elementary School District serves students in transitional kindergarten (TK) through 8th grade. To support our English learner community, the district offers an early education program including TK for all 4-year-olds and all-day preschool for children ages two and a half to four. Our population of 112 students is 34% English learners (EL), 78% of our students are low-income, and 36% of our students are inter-district transfers. Our staff members who directly affect student achievement include a superintendent/principal, eight teachers, one preschool teacher, six paraprofessionals, and one technology expert. There is a dedicated team of classified staff members who support all functions of the school district. The district authorizes one charter school that is required to create its own LCAP.

Our rural atmosphere and old-fashioned family values are a rarity in this era, and we are proud to say that our school offers sound educational teaching along with a good dose of character.

Based on 2024 California School Dashboard (Dashboard), 2024 California Assessment of Student Performance and Progress (CAASPP) results, local data collected through our educational partner engagement, surveys, and ongoing academic and social emotional learning assessments W-RESD has identified successes and needs that directed our planning for the 2025/26 LCAP. Our review included all significant student groups including Socio-economically Disadvantaged (SED), Students with Disabilities (SWD), and English learners (EL).

- 2024 Dashboard
 - All reported student groups increased and are now closer to Standard Met in ELA. All student groups are in the Medium (Yellow) performance level.
 - The All, Hispanic, and SED student groups increased in Math and moved from the Low (Orange) performance level to Medium (Yellow). Our EL student group declined and stayed in the Low (Orange) performance level.
 - There was a 3.1% increase in the percentage of English learners making progress toward English Language Proficiency by increasing one level on the English Language Proficiency Assessments for California (ELPAC).

- 2024 CAASPP
 - In ELA, all reported student groups increased in the percentage of students who Met/Exceeded Standards.
 - In Math, our All, Hispanic, and SED student groups increased in the percentage of students who Met/Exceeded Standards but our EL student group decreased in the percentage of students who Met/Exceeded the standard.
 - All student groups increased in the percentage of students who Met/Exceeded Standards in Science.
- MAP ELA (grades 2-8)
 - There was little growth or a small decrease in the percentage of students scoring at or above the 50th percentile (comparing winter 2025 to fall 2024). All: 35% winter 2025, 36.84% fall 2024; SED 32.14% winter 2025, 35.48% fall 2024; EL 4.55% winter 2025, 4.2% fall 2024.
 - A comparison between winter 2025 to fall 2024 shows a few more students scored at or below the 20th percentile and need Tier III intervention. All: +0.56%; SED: +0.59%; EL +9.09%
 - Slightly more EL students met their Growth Projections compared to winter 2024 (+0.62%) but fewer students in the All student group (-5.23%) and SED student group (-5.36) met their Growth Projections.
- MAP Math (grades 2-8)
 - There was an increase in the percentage of students scoring at or above the 50th percentile for all student groups (comparing winter 2025 to fall 2024). All: 47.5% winter 2025, 36.84% fall 2024; SED: 44.64% winter 2025, 33.87% fall 2024; EL: 9.09% winter 2025, 4.2% fall 2024.
 - Comparing winter 2025 to winter 2024, more students in all student groups met their Growth Projections. All: 62.03% in 2025 compared to 59.77% in 2024; SED 64.29% in 2025 compared to 63.41% in 2024 ; and EL 54.55% in 2025 compared to 53.33% in 2024.
 - Fewer students scored at or below the 20th percentile and need Tier III intervention. All: -4.54%; SED: -8.02%; EL -17.81%

Performance Gap: About 78% percent of our students are in the SED student group so we usually don't see much of a gap between scores for our All student group and our SED student group. However, we do see a performance gap between our All student group and our English learners in ELA and Mathematics on the 2024 Dashboard, 2024 CAASPP, and our MAP assessments. Also, on the 2024 Smarter Balanced Assessment in ELA, 54.54% of students who are not socioeconomically disadvantaged scored Standard Met/Exceeded but 42.86% of our SED student group met or exceeded the standard and in Math the rate was 72.72% of students not SED and 23.21% for students in our SED student group.

The successes in Pupil Achievement are largely due to the actions in Goal 1. W-RESD's part-time Director of Curriculum & Instruction provided coaching and on-going professional development (PD) along with Sutter County Superintendent of Schools (SCSOS) staff. PD consisted of the Science of Reading, unpacking standards in math, Math Lesson Study, High Five for All, and a book study on *Building Thinking Classrooms* in Math (Actions 1.1 Part-time Director of Curriculum and Instruction and 1.7 Professional Development). We provided high quality instruction to all students including unduplicated pupils and individuals with exceptional needs with 8 classroom teachers. Our staff included additional staff for small class sizes (Action 1.2 Additional Teacher to Eliminate Combo Class & Action 1.3 Staff for Small Class Sizes). Data was monitored and maintained through Illuminate and our local spreadsheets. A local tool was used to track benchmark data for every grade level for each assessment point in the year. The Director of Curriculum & Instruction supported teachers in the use of data from our MAP and local assessments to analyze student progress and identify students in need of intervention. We used the Math MAP Learning continuum and designed a program that matched the MAP Rasch UniT (RIT) ranges with lessons, practice activities, and assessments. Then we formed MTSS groups for math intervention based on RIT scores and used resources from the MAP Learning Continuum document

to plan and guide intervention. Reading comprehension and writing skills were enhanced through the use of Novel Studies. Teachers and four paraeducators provided intervention to all students during the school day as well as numerous students after school (Actions 1.4 Data and Progress Monitoring & 1.5 Interventions and Supports). We purchased ELD curriculum to use for our Designated ELD instruction and all students were instructed using Academic Vocabulary Toolkit (AVT) (Action 1.6 Instruction for English Learners).

We have worked to put programs and services in place to support student achievement and although progress is slow, we have seen improvement over time, therefore we will maintain the actions in Goal 1 with few changes. Our Part-time Director of Curriculum and Instruction will continue to work with teachers on the use of data to form and monitor intervention groups, paying particular attention to the progress of our SED student group and English learners, plus training and coaching for intervention strategies (Action 1.1). Staff for Small Class Sizes will ensure teachers have more time and attention for all students but will be especially beneficial to our English learners (Actions 1.2 & 1.3). In our Data and Progress Monitoring action, we will build upon the work we did in the 2024/25 school year to evaluate our universal assessment system by determining assessment cut points and we will also add the K-2 Reading Difficulties Screener, Multitudes (Action 1.4). We will begin our second year using our ELD curriculum in Action 1.6 Core Instruction for English Learners and we will investigate local assessments of English Language Proficiency. Professional Development will focus on expanding the work we have been doing using the book, *Expanding Thinking Classrooms*, to include TK-2nd grades. In the second half of the year, we will delve into the “tasks” explained the text and plan how to use the “tasks” within lessons. We will continue Math Lesson Study for grades 3-8 with SCSOS staff in the first half of the year; TK-8th grade teachers will participate in Math Framework training; and our Director of Curriculum and Instruction will continue coaching training with SCSOS (Action 1.7).

School Climate Summary:

- 2024 Dashboard
 - Suspension Rate declined for all student groups and all student groups improved two performance levels and are now in the Low (Green) performance level.
 - Chronic Absenteeism Rate increased for our All, Hispanic, and SED student groups and our Hispanic and SED student groups are in the Very High (Red) performance level. The rate maintained for our EL student group, but their performance level declined to High (Orange).
- On the 2025 survey, more students say if they have a problem in class, they can talk to their teachers about it 72.6% compared to 63.6% in 2024
- 2025 Parent Survey: 100% of parents say there is good communication between home and school, maintained from 100% in 2024.

We continued to use Restorative Justice practices to maintain a positive school climate thus supporting low suspension and expulsion rates. Local data from our Student Information System (SIS) as of April 15, 2025, indicated we had a local suspension rate of 0.89% for all students and a 0% suspension rate for our SED and EL student groups. To support a positive school climate and the social-emotional well-being of students a part-time school counselor offered services to students (Action 2.3 School Counselor). We held one community event per month such as: Science Night, Read Across America, Harvest Carnival, Patriots Day, and Winter Program. Teachers and staff held weekly meetings and activities to encourage positive behaviors. Good citizen trips helped foster a positive school climate and culture. On the 2025 Parent Survey 100% of parents say their family feels a sense of belonging and connectedness at the school compared to 90% in 2024 and 100% of parents say the school is a friendly, welcoming environment for students, parents, and families compared to 80% in 2024. We attribute these increases to Action 2.2 Community Outreach and the work our Community School Liaison does to connect parents and the community to the school.

In the 2025/26 LCAP we will intensify our efforts to increase student attendance by continuing to improve an attendance monitoring/notification system that includes regular monitoring of absences and letters and phone calls to parents regarding attendance as well as funding a part-time Community School Liaison position to work directly with families to improve student attendance. (Action 2.1 Attendance). We will also continue to offer family events each month but with the Community School Liaison we plan to expand our direct outreach to parents so we can increase their engagement in their child’s education, encourage them to volunteer in classrooms, and make them feel comfortable at the school so they will provide input and be involved in decision making groups (Action 2.2 Community Outreach). An addition to both actions is to offer Incredible Years Training to parents: This 14-week (one time per week) training is provided as a collaborative effort between SCSOS and Sutter County Children and Families Commission. The goal of this training is geared to support parents in strengthening skills that foster parent involvement in children’s school experiences, promote children’s academic, social, and emotional skills and reduce challenging behaviors. With this additional program and the support of the Community School Liaison we are confident we will bridge the gap between home and school and continue to improve student achievement and begin to decrease absences.

The goals, actions, and services in the 2025/26 LCAP are a direct result of consultation with our educational partners, data analysis of student academic and social emotional performance, survey data, and teacher observations. The feedback we received directly impacted the 2025/26 LCAP.

Educational partners agree that small class sizes are essential if we are to increase achievement for all students and that intervention is necessary and should be during the school day. Teachers noted that more English learners need Tier III intervention than students in the All student group in Reading (All: 21.25%; SED: 22.81%; EL: 59.09%) and Math (All: 15%; SED: 15.79%; EL: 36.36%). With so many competing needs we believe we must maintain Action 1.2 (Additional Teacher) so we can eliminate our combination class. This action will allow teachers to fully immerse themselves in the standards and skills for one grade level, deliver high-quality instruction, and provide intervention to struggling students. We will also maintain Action 1.3 Staff for Smaller Classes, Action 1.4 Data and Progress Monitoring, and Action 1.5 Intervention and Support.

Staff noted that attendance affects the achievement of students, especially our English learners. The 2024 Dashboard Chronic Absenteeism Rates increased slightly from our baseline year for all groups except EL. Our local Chronic Absenteeism Rate for our English learners is only 2.56%, a decrease of 9.04% from the 2024 Dashboard rate. Based on educational partner input and attendance outcomes for our English learners we are keeping our attendance action (Action 2.1) with the addition of Incredible Years Training to parents: This 14-week (one time per week) training is provided as a collaborative effort between SCSOS and Sutter County Children and Families Commission. The goal of this training is geared to support parents in strengthening skills that foster parent involvement in children’s school experiences, promote children’s academic, social, and emotional skills and reduce challenging behaviors. With this additional program and the support of the Community School Liaison we are confident we will bridge the gap between home and school and continue to improve student achievement and begin to decrease absences.

Students and parents appreciate the engaging family activities offered and want them to continue. On the 2025 Parent Survey 100% of parents say their family feels a sense of belonging and connectedness at the school compared to 90% in 2024 and 100% of parents say the school is a friendly, welcoming environment for students, parents, and families compared to 80% in 2024. We attribute these increases to the work our Community School Liaison does to connect parents and the community to the school. We will maintain our efforts to improve community outreach by continuing to offer family events each month but with the Community School Liaison we will have more direct outreach to individual parents and add additional parenting programs as interest arises. (Action 2.2 Community Outreach)

The programs and services put in place to improve student achievement are supporting improvement efforts, but we still have work to do so we need to maintain this goal and actions. On the 2024 Dashboard all reported student groups increased and are now closer to Standard Met in ELA. The All, Hispanic, and SED student groups increased in Math and are closer to Standard Met, but our EL student group declined. There was a 3.1% increase in the percentage of English learners making progress toward English Language Proficiency by increasing one level on the ELPAC.

As reported on the 2024 CAASPP in ELA, all reported student groups increased in the percentage of students who Met/Exceeded Standards. In Math, our All, Hispanic, and SED student groups increased in the percentage of students who Met/Exceeded Standards, but our EL student group decreased in the percentage of students who Met/Exceeded the standard. All student groups increased the percentage of students who Met Exceeded Standards in Science.

Looking at MAP ELA (grades 2-8) results we see there was little growth or a small decrease in the percentage of students scoring at or above the 50th percentile (comparing winter 2025 to fall 2024). All: 35% winter 2025, 36.84% fall 2024; SED 32.14% winter 2025, 35.48% fall 2024; EL 4.55% winter 2025, 4.2% fall 2024. A comparison between winter 2025 to fall 2024 shows more students scored at or below the 20th percentile and need Tier III intervention. All: +0.56%; SED: +0.59%; EL +9.09%. One important note is that on the 2024 Smarter Balanced Assessment in ELA, 54.54% of students who are not socioeconomically disadvantaged scored Standard Met/Exceeded but 42.86% of our SED student group met or exceeded the standard and in Math the rate was 72.72% of students not SED and 23.21% for students in our SED student group.

Goal Analysis for 2024/25

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

We were successful in implementing the actions and services in Goal 1.

W-RESD's part-time Director of Curriculum & Instruction provided on-going professional development (PD) and coaching to support the implementation of the use of data when forming intervention groups; intervention strategies; and the implementation of the California (CA) standards, frameworks, and materials. Professional development was also provided in Science with SCSOS staff; the Science of Reading; unpacking standards in Math; lesson study in Math; High Five for All; and book study with *Building Thinking Classrooms* in Math. Our TK-2nd grade teachers worked on curriculum; classroom management and how to maximize learning time and implement rotations to meet the needs of students; and productive struggle in Math. (Action 1.1 Part-time Director of Curriculum and Instruction and Action 1.7 Professional Development Services)

We provided high quality instruction to all students including unduplicated pupils and individuals with exceptional needs with appropriately assigned teachers. We had to start off the school year with one class as a combination class with paraeducator support until we could hire a credentialed teacher and split the class. Our staff included additional staff for small class sizes. (Actions 1.2 Additional Teacher to Eliminate Combo Class and 1.3 Staff for Small Class Sizes)

The Data & Technology Coordinator and the Superintendent monitored and maintained data through Illuminate and our local spreadsheets. A local tool was used to track benchmark data for every grade level for each assessment point in the year. The Director of Curriculum & Instruction supported teachers in the use of data from our MAP and local assessments to analyze student progress and identify students in need of intervention. We evaluated our universal assessment system. We continued to use Exact Path which is an intervention system that students use daily for Reading, Language, and Math practice. Teachers and four paraeducators provided intervention to all students during the school day as well as numerous students after school. We formed MTSS groups for Math and ELA intervention for students in grades 1-8 for 30 minutes per day, 5 days per week. We purchased one class set of Chromebooks. (Actions 1.4 Data and Progress Monitoring and 1.5 Interventions and Supports)

All EL students had 30 minutes per day of English language development instruction each day. Students were grouped based on their ELPAC level; instruction using Kate Kinsella's Academic Vocabulary Toolkit occurred daily in each class for all students; we purchased Ballard & Tighe ELD curriculum and all staff received training; and the Director of Curriculum/EL Coordinator attended High 5 For All sessions offered by SCSOS and shared resources and training with staff on integrated and designated ELD. (Action 1.6 Core Instruction for English Learners)

There were no substantive differences in planned actions and actual implementation of the actions but there were some challenges. We had one more combination class than we wanted for part of the year as we were not able to hire a teacher until after winter break. We spent more time than anticipated reviewing our universal assessment system, so we were not able to determine cut points for the assessments. Also, students were resistant to using Exact Path and we saw very little growth so we will eliminate that for next year.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Overall, in Goal 1 we spent 2.51% more than budgeted. We spent less in Action 1.2 than planned because we kept one class as a combination class with paraeducator support for the first part of the school year and then when we found a credentialed person, we split the class. We spent more in Action 1.5 due to the addition of a paraeducator for intervention after the LCAP was approved.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The actions in Goal 1 including additional classroom staff; a part-time Director of Curriculum and Instruction to coach teachers in improving instruction and using data to plan instruction and intervention; data and assessment; staff to provide intervention; ELD instruction; and PD were effective in making progress toward the goal during Year 1 of this three-year LCAP, as demonstrated by state data and key metrics. While some metrics did not show the expected level of impact, the overall evaluation indicates that these actions are supporting progress toward the goal. As a result, they will be continued in the 2025–26 LCAP with adjustments to enhance effectiveness, as outlined in Prompt 4.

- On the 2024 Dashboard all student groups increased and are closer to meeting the standard in ELA, increases ranged from 9.9 to 16 points. All groups except EL increased in Math. Increases ranged from 17.2 to 22.8 points. EL decreased 3.2 points. (Metric M.1.5)

- As reported on the Dashboard 3.1% more English learners made progress toward English proficiency by increasing one level on the Local Control and Accountability Plan

ELPAC (48.3%). (Metric M.1.6)

- *The percentage of unduplicated students and students with exceptional needs in grades 2-8 scoring at or below the 20th percentile on the NWEA MAP fall ELA and/or Math assessment, receiving tutoring or tiered intervention increased for all student groups. Increases ranged from 20% to 28.95%. (Metric M.1.9)*
- *The percentage of students (2nd-8th) who met their growth projection (fall to winter) on the MAP assessment in Reading and Math increased for all student groups in Math, our EL student group increased in Reading. (Metric M.1.11)*
- *On the 2024 CAASPP ELA assessment all student groups improved and we had a 5.23% to 13.41% improvement in the percentage of students scoring Met/Exceed Standard. In Math, all student groups except EL improved and all student groups increased in the percentage of students who Met/Exceeded Standards in Science.(Annual Progress)*
- *On the Local Indicator Priority 2, we increased two levels from 3 Initial Implementation to 5 Full Implementation and Sustainability on the question, *Rate the LEA's success at identifying the professional learning needs of groups of teachers or staff as a whole.* (Local Indicator)*

Changes to Actions:

Action 1.2: This action was funded with LREGB funds but will now be funded by Base funds.

Action 1.4: We are removing the following: We evaluated our universal assessment system and identified the purpose for each assessment, we determined all current assessments are effective, so we did not identify or implement any new skills assessments. We are adding that we will determine assessment cut points for the assessments in our universal assessment system and we added the K-2 Reading Difficulties Screener.

Action 1.5: Students are resistant to using Exact Path and we saw little growth, so we are eliminating this part of the action. We believe that we get better results with intervention provided directly by trained staff.

Action 1.6: We purchased the curriculum, so we are removing that and removing the training for the curriculum. We added, *Investigate and implement a local English Language Proficiency assessment*. SCSOS is changing the training related to English learners and ELD, so we have removed High Five for All. It is unclear what that will be called but we will be attending whatever they offer.

Action 1.7: We participated in Science of Reading training, so we are removing it. We have been participating in Math Lesson Study with SCSOS staff, and we are adding that for grades 3-8 and our Director of Curriculum and Instruction has been participating in coaching training and since we want to continue, we have added that. We are expanding our work with *Building Thinking Classrooms for Mathematics* to TK-2nd grades and we will be delving in to the “tasks” explained in the *Building Thinking Classrooms* and plan how to use the “tasks” within lessons. We also added Math Framework training for TK-8th grade teachers.

An explanation of why the LEA has developed this goal.

Our Suspension Rate on the 2024 Dashboard declined 1.9% to 0.9% for all students and declined about 2.3% for each student group. Our local April 2025 data indicates a 0.89% suspension rate for all students, and 0% for our SED and EL student groups for the 2024/25 school year. Parents continue to feel that the school is a safe place for their children to learn (100% in 2025, 100% in 2024)) and 100% of parents felt connected to the school (90% in 2024). Fewer students say the school is safe (79.4% in 2025, 86.21% in 2024) and 73.4% of students felt connected to the school (79.31% in 2024).

The results of our spring 2025 survey show that parents see the school as a welcoming environment for families and community members (100% 2025, 80% 2024). The feedback also indicated that 100% of parents think we do a good job having 2-way communication between families and educators using language that is understandable and accessible to families. A bilingual administrative secretary translated information for parents and supported our efforts to engage in two-way communication with families. We held one community event each month. Activities such as Science Night, Read Across America, Harvest Carnival, Patriots Day, and the Winter Program were well attended.

The 2024 Dashboard reported our Chronic Absenteeism Rate as 17.4%. This is a 0.5% increase from 2023. However, the rate is 11.6% for our English learners. Based on local data as of April 2025, our rate was 20.89% but 2.56% for our EL student group. Our P2 2024 Attendance Rate was 92.45%, a decrease from 93.42% in 2024. Our LCAP Goal 2, *Through community outreach, develop and cultivate positive relationships between staff, students, parents, and the community to create a safe and welcoming environment that will ensure a successful learning environment for all students*, has supported this work and will continue in the 2025/26 school year.

Goal Analysis for 2024/25

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

We were successful in implementing actions and services in Goal 2.

The Bilingual Administrative Secretary monitored daily attendance through SchoolWise. We formed a team that met weekly to identify students with attendance problems and to discuss additional support students and families may need. Through this process, we made a list of families our liaison would contact that week. When warranted, we issued truancy letters and continued to monitor attendance. We scheduled meetings with parents if attendance did not improve. We worked with families to find solutions rather than punishment. We purchased t-shirts encouraging school attendance and celebrated good attendance at assemblies with incentives. We had field trips to celebrate good attendance and behavior. Bus transportation services were provided to and from school for all in-district students and to designated stops for inter-district students. We transported about 50% of our students. (Action 2.1 Attendance)

We held one community event per month such as Math Night, Science Night, Read Across America, Harvest Carnival, Patriots Day, and Winter Program. We funded a part-time Community School Liaison position, she contacts families to invite them to monthly events, organizes, and holds after school events. She is responsible for school and district communication with families in the area of parent, community and student engagement. She sat with parents to help them do surveys and reached out to families to promote the DC trip to help with financial aid. She and the superintendent received certification in the FACES training – family engagement and implementing strategies and she works with SCSOS staff to provide resources to families in need. (Action 2.2 Community Outreach)

We continued to partner with Sutter County Health and Human Services, and SCSOS staff to provide counseling services to students and monitor the social-emotional needs of all students. Anti-vaping education and training for students and staff provided by SCSOS was offered in the spring. If a student has on-going behavior problems, our Community School Liaison worked with the school counselor, students, and

parents to: Determine if there are underlying problems causing the behavior; Support the development of a behavior plan; and Monitor student behavior and make referrals for additional support as needed. (Action 2.3 School Counselor)

There were no substantive differences between planned and actual actions in Goal 2. Working with families regarding attendance continued to be a challenge. It was difficult convincing families that taking their children out of school and having them do independent study is not the same as having a child in class with a teacher. Families still took their children out of school for extended vacations or kept their children home for minor illnesses. (Action 2.1 Attendance)

In Goal 2, we spent 4.82% more than budgeted and there were no material differences between Budgeted Expenditures and Estimated Actual Expenditures for actions within the goal.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

In Action 2.1 (Attendance) we worked to improve student attendance by developing and continuing to improve an attendance monitoring/notification system and we funded a part-time Community School Liaison position to work with families to improve student attendance. This action as a whole was not effective but parts of the action were effective according to state and local data. The 2024 Dashboard Chronic Absenteeism Rates increased slightly from our baseline year for all groups except EL (Metric M.2.5). However, our local Chronic Absenteeism Rate for our English learners is only 2.56%, a decrease of 9.04% from the 2024 Dashboard rate showing the effectiveness of our Community School Liaison position (Metric M.2.6). Since we are not getting the improvements we desire, adjustments will be made to this action as explained in prompt 4 below.

Metrics, Local Indicator ratings, and surveys indicate Action 2.2 Community Outreach was effective. The progress is due mainly the work our Community School Liaison did cultivating relationships between parents and the school.

- One hundred percent of parents still agree their involvement is valued. (Metric M.2.2)
- This year was our baseline, and we had 100% of parents for all student groups attend Trimester 1 Parent/Teacher Conferences. (Metric M.2.3)
- We increased from 3- Initial Implementation to 4 – Full Implementation on 2025 Local Indicator Priority 3, *Rate the LEA's progress in providing all families with opportunities to provide input on policies and programs, and implementing strategies to reach and seek input from any underrepresented groups in the school community and Rate the LEA's progress in providing opportunities to have families, teachers, principals, and district administrators work together to plan, design, implement and evaluate family engagement activities at school and district levels.*
- 2025 Parents Survey results improved on several questions related to engagement and connectedness.
 - My child's school is a friendly environment for students, parents, and families: 100%, 80% in 2024
 - My family feels a sense of belonging and connectedness at the school: 100%, 90% in 2024
 - I have been given different options or ways that I can be involved with the school: 100%, 80% in 2024

- In Action 2.3 School Counselor we provided counseling services to students and our Community School Liaison worked with the counselor, students, and parents to support behavioral improvement. This action was effective in making progress toward the goal as evidenced by state and local data.
- Fewer students in all student groups were suspended as reported on the 2024 Dashboard. All student groups moved from the High (Orange) performance level to Low (Green). We met our Target for Year 3 Outcome for all student groups except EL but we are only 0.2% away. (Metric M.2.8)
 - We continue to have no students expelled thus meeting our target for Year 3 Outcome. (Metric M.2.9)
 - Our local Suspension Rate remains very low, All: 0.89%; SED 0%; EL: 0%

The goal of this training is geared to support parents in strengthening skills that foster parent involvement in children’s school experiences, promote children’s academic, social, and emotional skills and reduce challenging behaviors.*

 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table
