Approval of Minutes: May 22, 2024 (Motion-Ken Phillips/2nd-Shaina Strahm)

New business: Mrs. Hernandez discussed the council configuration for the 24-25 school year. She introduced returning members, Liz Cochran, Shaina Strahm, Dresden Hester, Alyna Pluim. She then introduced new members Drew Luque, Alphonso Lara, Ken Phillips (new term), Ana Kristina Romo Garcia, and Yanira Servin (new term). SSC reviewed roles and responsibilities along with SSC bylaws. Ken Phillips will be Chairperson (Motion-Shaina Strahm/2nd-Liz Cochran), Shaina Strahm, Vice Chairperson (Motion-Ken Phillips/2nd-Liz Cochran), and Dresden Hester, Secretary (Motion-Ken Phillips/2nd-Shaina Strahm). SSC did a motion by Ken Phillips and second by Shaina Strahm to transfer responsibility for oversight of the District-Level English Learner Advisory Committee (DELAC) and services to SSC. Mrs. Hernandez presented information on the Comprehensive School Safety Plan (CSSP). A motion from Liz Cochran and second from Alphonso Lara to transfer responsibility for updating the CSSP to the School Safety Committee. Mrs. Hernandez then provided information on the district's decision on combining the School Plan for Student Achievement (SPSA) with the LCAP. Discussed that MUESD is no longer in Additional Targeted Support and Improvement (ATSI) for chronic absenteeism for students with two or more races. Mrs. Hernandez gave an update on school climate and safety. She discussed the district use of Raptor and shared the outcome of the Emergency Preparedness Drill on September 25, 2024 and the Great Shake Out on October 17, 2024. In addition, students receive a Bus Safety presentation by site principals in September. Mrs. Hernandez provided an LCAP update. She then reviewed the engagement of educational partners, services being provided, and the SPSA along with Title 1 budget. Mrs. Gina Arevalo provided SSC with a DELAC update. She shared that MUESD currently has 146 English Learners. She shared that 32.8% of those EL students are at-risk of becoming Long-Term English Learners. Mrs. Arevalo shared Initial ELPAC information and the services that EL students receive both in designated and integrated ELD.

Reports: Mrs. Hernandez then provided information on achievement monitoring. Students in K-2nd grade took the i-Ready Reading and Math diagnostic assessment. Students in 3rd-8th took the ICA Math and ELA assessment. All grade levels participated in Data Days to review results and create goals. Attendance for Period 1 was at 98% and Period 2 at 95.83%.

Parent Involvement: Mrs. Hernandez provided SSC with an overview of the school wellness plan. Finally, Mrs. Hernandez provided parent involvement information which included parent conference week (November 5th-8th), Sports, PeaceBuilder, communication platform Parent Square, MUESD website, Red Ribbon week (October 28th-November 1st) and the Halloween carnival on October 26, 2024.
