REQUIRED DOCUMENTATION

- Each year, all private lesson instructors must complete the "Private Teacher Affidavit"
 - Email completed form to Director of Music Programs, Philip Flynn-pflynn@neisd.net
 - Director of Music Programs will complete the bottom of the form (signature portion) upon receipt
 - Completed form with signature will be sent to the NEISD H.R. Dept. for processing.
- Returning private lesson instructors are not required to be fingerprinted as long has there has been NO lapse in service years.
 - If a private lesson instructor leaves the district and returns after one or more years, he/she will be required to be fingerprinted upon their return.

COMMUNICATION EXPECTATIONS

- Lesson expectations MUST be shared (in writing) with students, parents, and campus music directors.
- Payment procedures MUST be made clear (in writing) and provided to students, parents, and campus music directors.
- Lesson Cancellation Policy MUST be shared (in writing) with students, parents, and campus music directors.
- Student lesson materials are the responsibility of the student.
- It is <u>highly recommended</u> that you do not teach private lessons without the campus director(s) on site.

TEACHING ROLE

- All private lesson instructors MUST follow the <u>NEISD Private Lesson Instructor Code of</u> Ethics and Standard Practices
- Proper modeling on the instrument student health must remain a priority in order to ensure long-term success.
- Private lesson instruction MUST parallel instruction as provided by campus directors.
- Recital programs are encouraged on campuses (arrangements should be made with campus directors)
- Consistent communication with students, parents, and campus director(s), regarding student progress, practice habits, preparedness, etc.

LIABILITY INSURANCE

- All private lesson instructors are highly encouraged to purchase liability insurance through the Texas Music Educators Association or other reliable association or company.
- TMEA Liability Insurance costs only \$30.00 annually
