For Thursday block days, explore after-school incentives at home and/or at school to reward getting through the school day. The IEP team will explore adding movement breaks to IEP for block schedule, support with pass if needed. Consult with teachers for a signal when a five minute break is appropriate. Approved (5/0).</p> <p>Case #2526-008: Directives: The student will complete current high school work for credit transfer to Del Amigo. Finish Edgenuity Biology, send transcript to registrar. Del Amigo will send a follow up email regarding credit transfer information. Approved (5/0)</p> <p>Case #2425-005: Directives: The student will attend school 15 minutes per week or as directed by the therapist in agreement with school. Release of Information form for</p>

County Mental Health and Seneca to collaborate with the school team and Discovery Counseling Center. Offer an additional eight Discovery Counseling Center sessions, if funding is available. Explore options for planning for next school year. Approved (5/0)

Case #2526-006: Directives: The student will attend school and complete all school assignments. Meet with the school counselor to develop a plan to get back on track with school work at high school. Establish a contingency plan if not on track by February 1, start Del Amigo transfer process. Del Amigo transfer information will be shared by the counselor. Site team to meet with student for plan, check-in at the start of February, support with Del Amigo transfer if needed. Offered eight Discovery Counseling Center sessions at no cost. Approved (5/0)

Case #2526-007: Directives: Offered referral to C.O.P.E and eight Discovery Counseling Center sessions at no cost. Approved (5/0)
