C. RECOGNITION OF SPECIAL CONTRIBUTIONS AND ACHIEVEMENTS

1. Reports from Student Representatives: El Dorado, Oak Ridge, Ponderosa, and Union Mine High Schools and Alternative Schools/Programs

El Dorado High School Representative, Lela Rojelio, reported on student activities.

Oak Ridge High School representative, Cadence Murdoch, reported on student activities.

Ponderosa High School representative, Joshua Gonzaga, reported on student activities.

Union Mine High School representative, Morgan Williamson, reported on student activities.

Alternative School representative, Delaney Lee, reported on student activities.

2. Supporting Students: Recognizing Paraprofessionals

Senior Director of Student Success, Pam Bartlett highlighted the essential role paraprofessionals play in supporting students and teachers. They provide specialized assistance, follow behavioral plans, offer one to one and small group support, and help students with disabilities access the curriculum while building independence. Paraprofessionals work across both general and special education settings and collaborate closely with staff to meet diverse student needs.

Kristina Mumford added that paraprofessionals are often the first welcoming faces students see each day. She noted their exceptional adaptability as they support students with significant needs, transition seamlessly into general education settings. Both leaders emphasized that paraprofessionals are invaluable to creating a positive and inclusive learning environment.

3. Teaching and Learning: Recognizing Kristina Mumford and Jennifer Zimny

Assistant Superintendent Leslie Redkey shared expressed deep gratitude towards Ms. Mumford and Ms. Zimny and noted that the presentation was clear, relevant, and approachable, with 96 percent of participants agreeing that it effectively explained the goal of AI. She added that the presenters modeled high quality instruction and set a strong standard for professional learning.

Brooke Van Komen shared her appreciation and said the keynote helped staff feel less intimidated by AI. Jessicca Rodgers agreed. Mrs. Van Komen also noted that a memorable moment was the presenters sharing what they would do if they were the superintendent.

E. INVITATION TO ADDRESS THE BOARD (GC54954.3)

1. Faculty Association Leadership Comments

Eric Larsen, Faculty Association President, shared that Proposition 30, which added a temporary tax on households earning over 500,000 dollars to support education, will expire in 2030 unless extended. The union plans to pursue a 2026 ballot measure to continue the funding through 2040. Mr. Larsen encouraged staff and community members to support signature gathering and help raise awareness about the importance of preserving this funding for K to 12 programs.,

2. California School Employees Association Comments

Teri Whiting, CSEA President, reported that classified staff in maintenance, custodial services, and health are managing increased workload demands. She has been working with Mr. DeVille to address impacts from recent reductions in staff, and explore options such as offering additional custodial or after hours work and encouraging employees to join the substitute list. She also noted that preparations for 25/26 negotiations are underway and a meeting date will be set soon.

Mrs. Van Komen asked about the need for bus drivers. Mrs. Whiting shared that a training class with about eight candidates is underway, although routes could accommodate up to fourteen drivers. The district continues to actively recruit

3. Public Comments

Community member, Todd White, speaking for Senator Alvarado Gil, noted her office is conducting community visits and shared that she continues to advocate for education.

Community member, Sarah Renner, shared concerns about community tensions, church safety issues, access to a course of study, and also noted concerns about students leaving schools.

G. EDUCATIONAL SERVICES – ACTION/DISCUSSION ITEMS

 Keynote Presentation by Kristina Mumford and Jennifer Zimny; "Welcome to Camp AI" (Discussion)

Assistant Superintendent, Leslie Redkey, introduced Ms. Mumford and Ms. Zimny, who presented a shortened version of their keynote on AI. They explained that as AI becomes more common, students must learn when it is appropriate to use it. They emphasized the importance of students completing the learning process rather than relying on shortcuts. They also shared employer data showing how core skills needed today will differ from those needed by 2030.

The presenters outlined what AI can and cannot do and noted that by 2030 about one third of tasks may be automated, allowing people to focus on higher level skills. They stressed that AI should support learning, not replace it, and introduced the idea of cognitive offloading to help determine when to use AI and when to encourage productive struggle. They advised against using generative AI with

freshmen and sophomores, recommending that use begin in junior year when students have greater maturity and foundational skills. They shared strategies for promoting ethical use through clear guidelines, instruction, and monitoring.

Tim Cary commented on the importance of explaining the reasons behind instructional choices and expressed concern about students relying too heavily on shortcuts. Mr. Whittenberg described next steps for the district, including forming an AI guiding coalition made up of classified staff, administrators, parents, students, and representatives from every school. The coalition will meet throughout the year and present a final AI framework to the board by June for use in the 26/27 school year.

Superintendent Kuhlman added that the district is still developing its approach and emphasized the importance of working closely with staff to ensure policies are practical and supportive. The district will bring updates to the board throughout the process to ensure shared understanding and collaboration.

2. <u>El Dorado Union High School District and Los Rios Community College District Data Sharing</u> Agreement (Discussion)

Director of Educational Options Janiene Langford and Folsom Lake College CIO Manveer Bola outlined a proposed FERPA compliant data sharing agreement between EDUHSD and the Los Rios district. Ms. Langford explained that an MOU will define which limited data elements may be shared, such as student IDs, GPA, A-G status, dual enrollment and CTE participation, and graduation status, to support smoother transitions for students.

Mr. Bola reviewed the cybersecurity and legal safeguards in place, noting that all users complete FERPA training, the district retains full rights to its data, and parents keep all existing protections. There is no cost to the district, and the MOU will be brought forward for approval in December.

3. EDUHSD California Assessment of Student Performance and Progress Results (Discussion)

Assistant Superintendent Leslie Redkey presented the Spring 2025 CAASPP report and noted that next year the performance descriptors will shift from met or exceeded to proficient or advanced. She reviewed ten years of ELA results showing steady improvement and a return to pre-covid levels, along with four years of comparable data with similar districts.

For math, she shared that junior results continue to grow incrementally and have also rebounded from covid, with the district performing well compared to peers. She highlighted subgroup progress over four years, including data for socioeconomically disadvantaged students and students with disabilities.

Ms. Redkey also reviewed CAST results, ELPAC Summative results, and key areas for growth and celebration. She noted ongoing discussions about standardizing grade validation practices across the district, since sites currently approach these incentives differently.

H. BUSINESS SERVICES – ACTION/DISCUSSION ITEMS

1. Architect Presentation: Proposed Mello-Roos Projects at Oak Ridge High School (Discussion)

Assistant Superintendent Bob Whittenberg introduced two representatives from California Design West to present early concepts for Oak Ridge High School projects funded through Mello Roos dollars. They noted the cafeteria urgently needs expansion since it was built for 1600 students and now serves about 2500. The project would take about two to two and a half years, with portions potentially starting in summer 2026.

They also shared concepts for a performing arts center, offering both a fully equipped option and a simpler version, and estimated about twelve months to reach groundbreaking. A proposed PE multipurpose building would take 18 months to two years and could be built alongside the cafeteria shade structure.

The board agreed the cafeteria expansion is the priority, with the other projects needing further discussion.

Motion 1 - Authorize and direct moving forward with Cafeteria Expansion project at Oak Ridge High School.

- Develop detailed funding estimates for project construction and financing.
- Plan a phased construction pathway that commences at least some phase of the construction projects by summer, 2026.

The board confirmed they were in consensus.

Mrs. Rodgers also asked the board to consider making some of the portable buildings permanent structures.

2. OES Purchase Agreement

Mr. Whittenberg explained that the District will front the cost for a new scoreboard at Ponderosa High School, and an MOU is being developed for the school to fundraise and reimburse the District.

1. Project Wayfinder Agreement (Action)

Senior Director of Student Services, Chuck Palmer, noted the alignment between Wayfinder and the earlier AI presentation, emphasizing the need to prepare students with the soft skills required in the modern workforce.

Logan Taxdal and Chelsea Collins shared how Wayfinder was used during the pilot at Union Mine, describing its curated staff resources, weekly lessons, and discussion based activities, including an example lesson on understanding taxes. They explained that the program offers anticipated outcomes such as increased student confidence, improved school culture, fewer repeated behavior concerns, and ongoing growth. They added that Wayfinder aligns with the district's portrait of a graduate and learner profile, allowing the district to target priority skills and track progress toward those goals.

Mrs. Van Komen moved to approve the project Wayfinder agreement. Mrs. Rodgers seconded. Motion carried (4-0).
