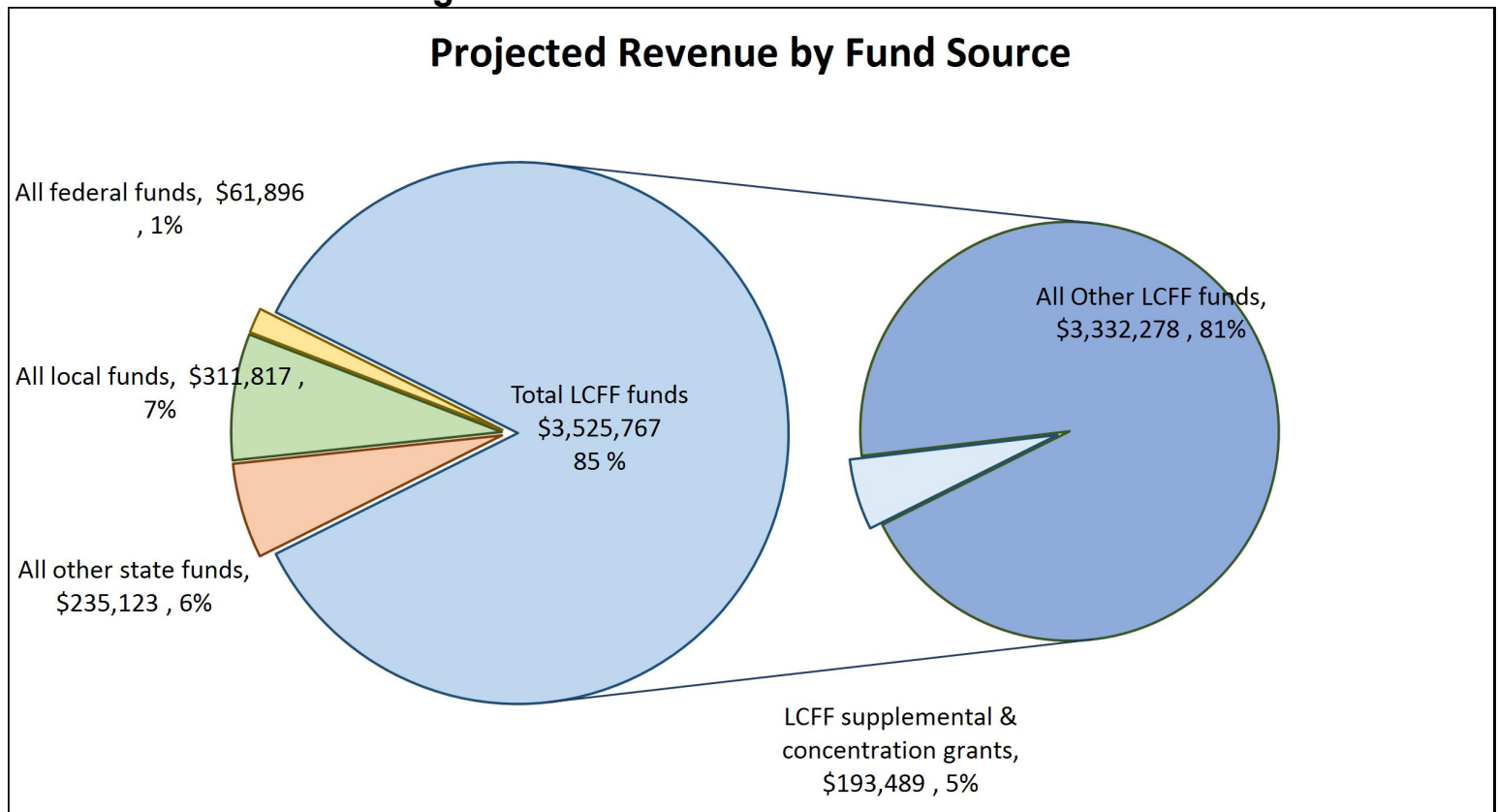

Budget Overview for the 2025-26 School Year

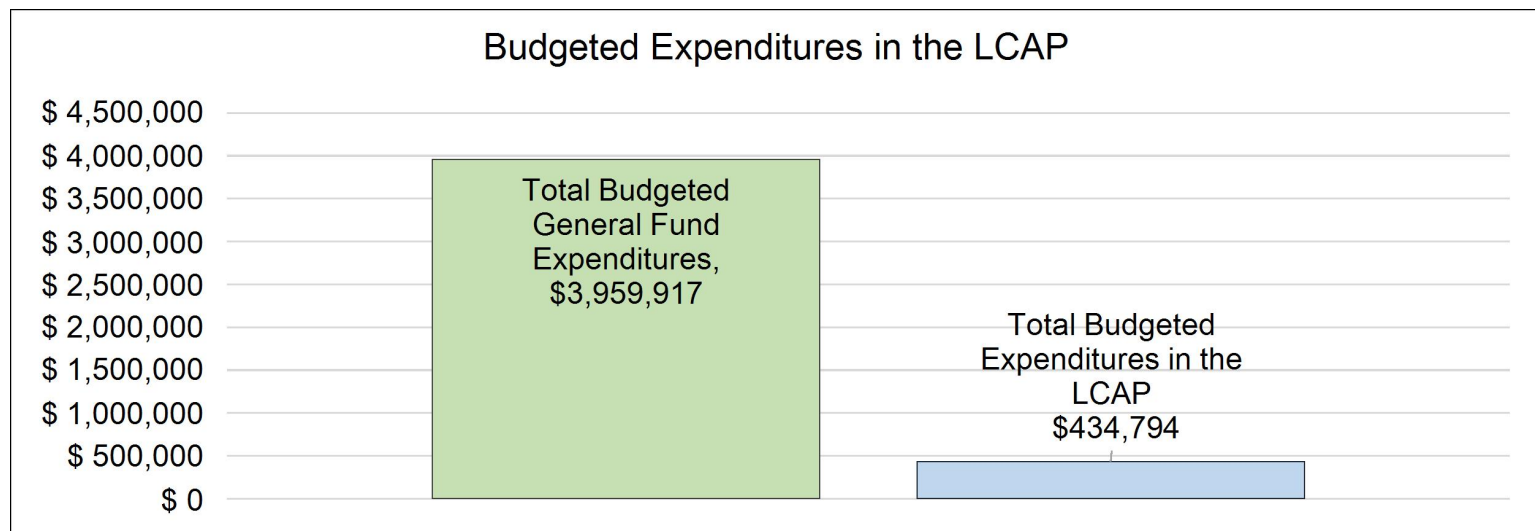


This chart shows the total general purpose revenue Cottonwood Creek Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Cottonwood Creek Charter School is \$4,134,603, of which \$3525767 is Local Control Funding Formula (LCFF), \$235123 is other state funds, \$311817 is local funds, and \$61896 is federal funds. Of the \$3525767 in LCFF Funds, \$193489 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

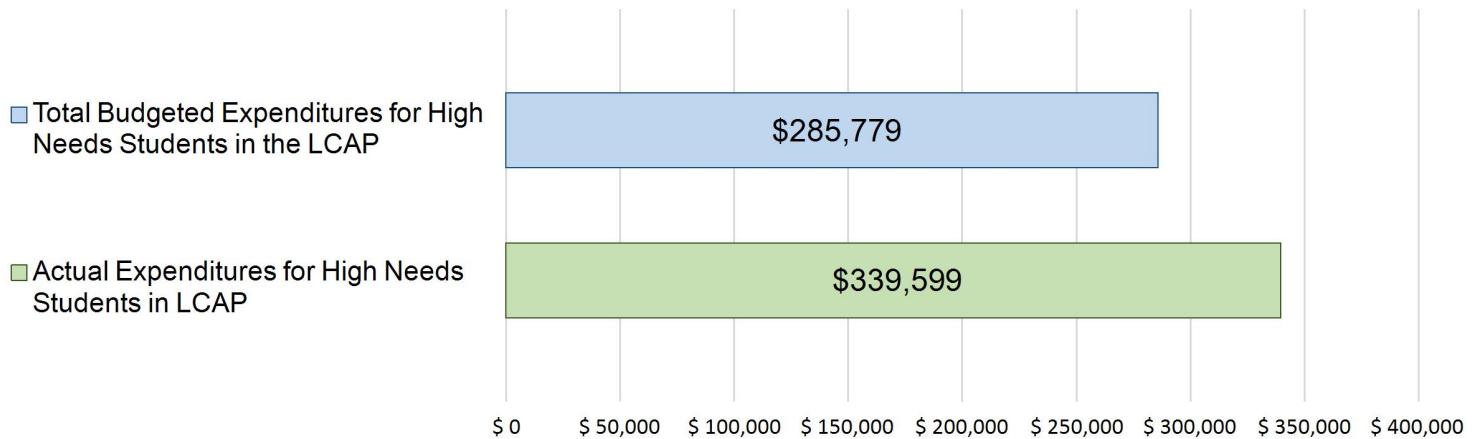
Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year

In 2025-26, Cottonwood Creek Charter School is projecting it will receive \$193,489 based on the enrollment of foster youth, English learner, and low-income students. Cottonwood Creek Charter School is an independent charter school within the Cottonwood Union School District. Cottonwood Creek is a Kindergarten through eighth grade non-classroom based charter school that offers site based classes (4 days a week) as well as a traditional homeschool program. Cottonwood Creek Charter School will be in its 16th year of operation during the 2025/26 school year. The Cottonwood Creek Charter School is located in downtown Cottonwood, a rural, northern California town with a population of just over 3,000 inhabitants. Cottonwood Creek Charter serves students living in Cottonwood, Anderson, Redding, Red Bluff and throughout the Shasta and Tehama counties. Cottonwood Creek has established a strong record of high academic standards as well as award-winning enrichment and technology programs. Cottonwood Creek Charter School is open to all students who go through the application and lottery process. The students, parents, and staff form a community of individuals identified primarily by their common goals of high academic standards, maintaining highly qualified teachers, and promoting quality enrichment and elective classes. It is the belief of the school that small class sizes and an overall small school size allow students greater opportunities to achieve their academic and enrichment goals within a supportive community.

Cottonwood Creek Charter School continues to be one of the highest performing public schools in Shasta County. The latest data from the California School Dashboard is from 2024. The data from the 2024 Dashboard indicated that Cottonwood Creek was performing at the

highest level for English Language Arts. This performance is 54.6 points above standard. For math, The data from the 2024 Dashboard indicated that Cottonwood Creek was also performing at the highest level. The math performance is 49.5 points above standard. Also, the CAASPP Scores from 2024 showed Cottonwood Creek Charter with a Proficiency Rate of 75% for ELA and a Proficiency Rate of 74% for Math.
