### **WELCOME AND INTRODUCTIONS**

#### **BACKGROUND**

BCAG is required to prepare and adopt a Regional Transportation Improvement Program (RTIP) by December 15, 2025 for the 2026 State Transportation Improvement Program (STIP).

The purpose of the RTIP is to identify programming recommendations for the State Transportation Improvement Program (STIP). The STIP is adopted by the California Transportation Commission (CTC) and is comprised of two components including the Regional Improvement Program and Interregional Improvement Program.

## **STIP Components**

- 75% <u>Regional Improvement Program (RIP)</u>. Projects nominated by the Regional Transportation Planning Agencies (RTPAs) like BCAG as part of the Regional Transportation Improvement Program (RTIP Document)
- 2) 25% <u>Interregional Improvement Program (IIP)</u>. Projects nominated by Caltrans as part of their Interregional Transportation Improvement Program (ITIP).

RELATIONSHIP OF THE RTIP TO BCAG'S LONG RANGE REGIONAL TRNASPORTATION PLAN / SUSTAINABLE COMMUNITIES STRATEGY (RTP/SCS)

RTP/SCS - Long Range "Planning" Document. The RTP/SCS is developed over a three-year period to serve as the foundation for future short-range "programming" documents including the RTIP and FTIP.

#### **FUNDING & PRIORITIES**

The CTC has made available the draft Fund Estimate for new programming. BCAG's share for the 2026 RTIP/STIP Period is \$3.603 million. This figure includes funds that would be directed to support BCAG's Planning, Programming and Monitoring efforts for the allowable 5% of regional share funds. The Fund Estimate breakdown is as follows:

Total Regional Target Share - \$ 3,603,000 Planning Programming and Monitoring - \$ - 339,000 New Programming Capacity - \$ 3,264,00 Project priorities begin with existing projects currently programmed in the State Transportation Improvement Program (STIP). Priority is given to ensure successful project delivery of existing commitments with the California Transportation Commission (CTC). New projects are required to be included in the adopted RTP/SCS and must be consistent with the Climate Action Plan for Transportation Infrastructure (CAPTI) built from the Governor's Executive Orders (EO) EO N-19-19 and N-79-20. These Executive Orders and the CAPTI are the basis for which ALL transportation funding is programmed thru BCAG. Additionally, BCAG is required to report progress on the Federal Performance Measures to FHWA and to California Air Resources Board (CARB) under SB 375 for achieved GHG reductions.

In an effort to meet the various existing state and federal goals including reporting requirements, RTIP project evaluation criteria are expected to focus on:

- Green House Gas (GHG) reduction
- Vehicle Miles Travel (VMT) reduction
- Development and integration of public transit with multimodal rail, bicycle, and pedestrian infrastructure (Mode Shift)
- Significant expansion of equitable transportation opportunities to underserved communities
- Safety
