

**PROGRAM:** EDUHSD Online. The El Dorado Union High School District (EDUHSD) offers an online instructional model including live interaction classroom-style instruction, and/or designated small group or one-on-one instruction delivered in the form of internet or telephonic communications involving two-way communication between the teacher and pupil. Students are assessed by the teacher through assignments, projects, and exams. In addition, teachers may assess students via the Learning Management System and Google Classroom. Electives are assessed in APEX.

EDUHSD Online is an optional educational alternative in which no student may be required to participate. In the case of a student who is referred or assigned pursuant to Education Code 48915 or 48917, an alternative classroom has been offered and is available during the period of this agreement. Students with existing individual education programs ("IEP") may only participate in the EDUHSD Online program if their most current IEP provides for placement in the program. Any questions regarding special education eligibility in relation to independent study should be addressed to the Senior Director of Student Success.

Students who participate in EDUHSD Online shall do so on a voluntary basis and have the option to return to a traditional in-person school setting within five (5) instructional days. Students enrolled in EDUHSD Online for less than 15 school days who submit a written request to their school counselor prior to the 15<sup>th</sup> day may return to in-person instruction at their school of residence.

Students who have three (3) absences, fail to achieve a satisfactory level of educational progress, miss five (5) assignments, or are in violation of the written agreement will be required to participate in a pupil/parent/educator conference where an evaluation will be conducted to determine whether it is in the best interest of the pupil to remain in EDUHSD Online, or be referred to an alternative program which may include, but is not limited to a traditional in-person school program.

**AGREEMENT DURATION:** Academic Year: 8/10/26 – 5/28/27, Fall Semester: 8/10/26 – 12/18/26, Spring Semester: 1/5/27 – 5/28/27

### **STUDENT AGREEMENT:**

- Manner, time, frequency and place for submitting a pupil's assignments: Students will submit assignments via Google Classroom according to the specified due dates. The maximum length of time allowed between the assignment and the completion of the assignment work is one week, or as identified in the assignment instructions or due dates posted in Google Classroom or Apex. Student agrees to submit work on a regular and timely basis and understands that five (5) missed assignments per class will result in a reevaluation of the student's placement in EDUHSD Online. Student will complete a minimum of the equivalent of 4 hours of work per day. It is expected that students make weekly progress in all classes, including independent study courses such as Apex. EDUHSD Online courses through Apex should progress according to the due dates within each class (approximately 1 hour/day) and work should be submitted in the platform or according to specific instructions posted in Google Classroom. Assignments must be completed and submitted before the end of the current grading period and in no case after the termination date of the EDUHSD Online Master Agreement.
- Student will comply with the District's rules and regulations and return all books and materials at the end of the assignment contract.
- Student will participate in all assessment/testing; physical education, hearing, and California state assessments as requested. This may be required in person.

### **Program Information and Expectations:**

- Independent Study is an optional educational alternative in which no pupil may be required to participate. The student has not waived any rights by entering Independent Study.
- Specific resources, including materials and personnel to be made available to students: highly qualified certificated teachers, board-adopted curriculum, textbooks (online and print copies available), audio-visual materials, Chromebooks for school use and home check-out, supplementary materials, wellness services, and confirmation of access to the connectivity and devices adequate to participate in the educational program and complete assigned work.
- Additional academic and other supports will be provided to address the needs of students who are not performing satisfactorily, or need support in other areas, such as English learners, individuals with exceptional needs in order to be consistent with the pupil's individualized education program or plan, pursuant to section 504 of the Federal Rehabilitation Act of 1973 (29 U.S.C. Sec 794), students in foster care or experiencing homelessness, and students requiring mental health support. These supports include, but are not limited to: Wellness Center access, accommodations and modifications designated in IEP or 504 plans, academic intervention with teachers during Office Hours, school and community-based supports to connect with additional resources
- Objectives and methods of study and the methods used to evaluate that work: All course objectives will be consistent with the guidelines established in the El Dorado Union High School District Schedule of Classes and Directory resources. All courses use board-adopted curriculum and the districtwide course of study. The courses of study can be found at: <https://www.eduhsd.k12.ca.us/Educational-Services/Course-Information/>. The class syllabus for each course will include additional descriptions of the major objectives and activities of the course of study covered by the agreement and the methods of evaluating the student's work, and is a supplemental component of this agreement. Specific course work and activities will be listed on the class syllabus and/or available in Google Classroom. Evaluation will be conducted by the teacher of record and based on formalized projects, assignments, pre-and post-tests, teacher-student discussion, and finals.
- Satisfactory academic progress shall be determined based on all of the following indicators:
  - o The student's achievement and engagement in the EDUHSD Online program, as indicated by the student's performance on applicable student-level measures of student achievement and engagement specified in Education Code 52060.
  - o The completion of assignments, assessments, or other indicators that evidence that the student is working on assignments.
  - o Learning required concepts as determined by the supervising teacher.
  - o Progress towards successful completion of the course of study or individual course, as determined by the teacher of record
  - o Progressing/on-track to meet EDUHSD graduation requirements.
- Communicating with a pupil's parent or guardian regarding a pupil's academic progress: Student's academic progress may be monitored by student and parent/guardian via the parent portal in Aeries. Progress reports are distributed to parent/guardian approximately once every 4-5 weeks. Report cards are distributed at the end of each semester. Communication with parents/guardians will be conducted by District staff via email, Google meet/Zoom meeting, and telephone contact. Teachers provide daily office hours and respond to emails within one (1) business day.
- Although the District will attempt to offer all of the courses of the District, some courses, such as Lab Science, Foreign Language and Vocational Education, may not be available through EDUHSD Online.

**COURSES ENROLLED:** The student will be scheduled according to the course request. To make any subsequent changes to a student's courses, there will be email communication between student, parent, teacher, counselor/administrator.

The number of credits to be earned: Each semester of a course earns 5 credits for successful completion. Credits will be issued by the teacher at the end of each semester. Students' individual course requests and schedules in Aeries detail this information and are supplemental documents to this agreement. The student's academic program (course schedule and credits attempted) are visible through the Aeries Student and Parent portal throughout the school year.

**SIGNATURES AND DATES:** We acknowledge that we have read the entire agreement and hereby agree to all the conditions set forth within. Failure to comply with the terms of this agreement and/or make satisfactory academic progress will trigger a parent-pupil educator conference to renew participation and/or plan to return to in-person instruction with another program within 5 days.
