

# WHAT IS GUARDIANSHIP?

- A relationship created by state law, in which the Probate Court gives one person (the guardian) the duty and power to make personal decisions for another (the ward or incapacitated person).
- A guardian is appointed when a judge determines that an adult lacks the capacity to make decisions regarding his or her own life. For a vulnerable older person, guardianship can be a valuable tool in securing his/her physical safety.
- The Probate Court will appoint a legal “ **guardian** ”, after a thorough investigation and a hearing, to make decisions on the person’s behalf.
- The court will have found the person, referred to as a “ **ward** ,” incapable of managing his or her own person and/or affairs.
- **Most Restrictive and supersedes Power of Attorney**  
Guardianship For The Elderly: Protecting The Rights And Welfare of Seniors With Reduced Capacity. United States Senate; Issued By: Senators Gordon H. Smith & Herb Kohl

# History of Guardianship At Catholic Charities



**1992** - Volunteer Guardianship Program began when the Catholic Service League Executive Director, Patrick Sorohan, stepped forward to become the legal guardian to a number of needy and disabled elderly in our community.



Patrick Sorohan died in **1994** the Senior Care Network ,a consortium of Ashtabula County organizations serving the elderly, formed a community task force . Developed *The Patrick Sorohan Ashtabula County Volunteer Guardianship Program* . In partnership with Catholic Charities of Ashtabula County and the Ashtabula County Probate Court. Honorable Judge Charles Hague.



Modeled after a well-established and nationally recognized program Lutheran Metropolitan Ministry Association in Cleveland known as The Volunteer Guardianship Program.



**1996** - CC started its Guardianship serving the 60 and over population in Ashtabula County with one part-time employee, one volunteer, and one ward of the court Today the program has grown to four (4) full-time staff guardians, six (6) volunteer guardians, and currently serves over 100 wards of the court at any given time.





The Statement of Evaluation does not declare the individual competent or incompetent, but is evidence to be considered by the Court. The fee for completing this evaluation **WILL NOT** be paid by the Probate Court. Each evaluator should secure payment from the Applicant/Guardian.

The evaluation or examination shall be completed within three months prior to the date of the Report. R.C. 2111.49



# What is **NOT** an appropriate referral for the CC Guardianship Program

- Out of Ashtabula County
- Under 18 years of age
- Current Guardian in place
- Married or long-term domestic partner
- Not as an alternative to family or appropriate friend that is capable of serving as guardian
- Person's right to self- determination: homelessness/substance use/ refusal of meds/immediate medication
- Lack of protective environment
- A person with financial means
- A person who may be better served by other resources - least restrictive services
- Durable Power of Attorney - Medical
- To avoid cost of Guardianship
- Services in place and living in a protective environment
- Program to support family's that do not have funds to hire an attorney and apply.

# Responsibility of the CC Guardianship

## 1. CC Guardian makes life choices in the best interest of the ward with dignity and respect

Examples: Placing in a nursing home or assisted living, Rent agreements, home health care, pre-arranged funerals plans, advanced directives.

## 2. Make contact with providers and provide letters of guardianship

- Caseworkers
- SSA
- Representative Payee
- DJFS
- Hospitals
- Nursing Home – social worker, nurse, Director of Nursing, accounting department
- Home health aids or other agencies that are involved with your ward.
- EMT, Hospitals, senior centers
- Verify or plan existing burial plans with funeral home.
- Met with Family or friends if appropriate or applicable

## 3. Meet ward monthly to assess living conditions/care - Announced or unannounced

## 4. Meet Probate Court's annual reporting requirements and any changes to wards location and care.

## 5. Guardianship Program is responsible for maintaining your ward's daily living activities which may include some of the following:

- Ensuring basic needs are being met.
- Coordination of care to make sure personal and medical needs are met with all service providers
- Monitors Representative Payeehip decisions
- Answering to medical providers questions or provide direction of ward's care including medication changes
- If in a Nursing Home: Attend Care plan meetings, med changes, parties or other events.
- Ensure safe and adequate housing
- Family reunification
- Funeral planning

# Who can become a Volunteer Guardian



- A self motivated compassionate individual
- Training and/or experience working with the frail elderly and/or as volunteer is desired and helpful
- Time and ability to commit to being a guardian to a ward's lifetime
- Current resident of Ashtabula County
- Fill out application with 3 references
- Pass and Consent to mandatory BCI & I and/or FBI Background Check if less than 5 years as Ohio resident
- Consent to mandatory Drug Screening Test

# Once you are approved as a Volunteer Guardian and requirement

- Meeting with Program Manager Kristin Cellini
- Complete Guardianship Training
- Ohio Supreme Court Training- 6 hours Mandatory\*
- Meet potential ward(s) only up to 3 wards per person
- Guardianship application process begins
- Once guardian, monthly visits at least 1 hour.
- Monthly reporting to program
- Annual guardians report

## Program support for volunteer

- Staff is always available to answer questions or provide support
  - There is no cost or expense to the volunteer
  - All guardians must be residents of Ashtabula County

\* Sup.R. [66.06](#) and [66.07](#) describe mandatory adult guardianship education, including a one -time fundamentals course and continuing education requirements for each following year. To help meet this requirement, the Supreme Court of Ohio is offering free courses to guardians of adults.



# QCO Department

## January 2026 Waiver Changes

### Assistive Technology-

- The assistive technology definition was updated to include non-electronic items. (e.g., pencil grips, weighted pens, screen readers, and communication boards).
- **Assistive technology**—equipment may include the cost of software applications or monthly recurring fees (such as a subscription) necessary to use an item, piece of equipment, device, product system, or engineered solution
- No change to the \$5000 cap on all components of assistive technology per waiver span.
- When assistive technology—equipment—has exceeded its useful life and requires repair or replacement, the individual and team will authorize the most cost-effective approach. (repair or replacement)
- Repair costs will not exceed 25% of the cost of replacement





## January 2026 Waiver Changes

### Remote Support-

- **Updated Definition of Remote Support**
- **Changed the term “remote support vendor” to “remote support provider.”**
- **Updated Definition of Backup Support**
  - Backup support may be provided by:
    - An unpaid family member or friend selected by the individual or
    - A paid agency provider of homemaker/personal care or an agency-with-choice arrangement for participant-directed homemaker/personal care as applicable.
- **Updated Provider Requirements**
- **Updated Billing Unit - You should see new authorizations in individuals PAWs to update from 1 hour unit to 15 minute unit rate**

# QCO Department

## January 2026 Waiver Changes

### **Support Broker**

- Effective January 1, 2026, with CMS approval, the Support Broker service has been added to the IO and Level 1 waivers with some updates to the rule and service in all three of DODD's waivers—Individual Options, Level 1, and SELF.
- Service updated to allow some virtual service and travel time.
- The billing unit is changing from an hourly billing unit to a 15-minute unit.
- Support Broker training has been updated

*The Support Broker coaches and mentors an individual choosing self-directed waiver services. A support broker empowers an individual to live more independently by presenting person-centered tools and guidance that enable the individual to make informed choices about services, supports, and staff.*





## Rules in effect Changes

**DODD is transitioning from PDFs to direct links for online content to meet current Americans with Disabilities (ADA) Title II and Web Content Accessibility Guidelines (WCAG) 2.1 AA accessibility standards.**

**As part of this effort, we are directing users to the State's publication of the Ohio Administrative Code instead of PDF versions of the rules and appendices.**

**This is an evolving process, and we appreciate your patience.**



# 2025 Annual Training Deadline Approaching

***Attention: Direct Support Professionals, Independent Providers, Directors of Operations, Administrators of Licensed Residential Facilities***

If you are a direct support professional (DSP), independent provider, director of operations, or administrator of licensed residential facilities, you must complete your required annual training for the 2025 calendar year by **December 31, 2025**.

## DSP

- 2-hour department-required training, including  
National alliance for Direct support professionals, Rights of Individuals, and Empathy-Based Care
- 6 hours of training arranged or provided by the agency in
  - recognizing and reporting MUIs, health and welfare alerts, and topics selected that are relevant to services you are providing or the individuals you are supporting.

## DOO

- 2-hour department-required training  
Essential topics relevant to the agency provider's role and responsibilities, empathy-based care, Health and welfare alerts
- 4 hours of training selected by the DOO in topics relevant to services and individuals served by the agency.

# Penny Shortage

The "penny shortage" is happening because the U.S. Mint stopped producing pennies in late 2025 after costs exceeded their value, leading to hoarding and less circulation, so retailers now face low coin supplies and use rounding for cash transactions, asking for exact change or giving nickels instead, creating confusion and logistical headaches for businesses and consumers despite pennies remaining legal tender.

- **Document rounding up or down when exact change is not given**
- **Have Pennies on hand to avoid not getting exact change**



# Overtime Guidance

Rule 5123-9-03 | Home and community-based services waivers—overtime and limit on the number of hours in a workweek an independent provider may provide services.

## (C) Overtime

The department, county boards, individuals who receive services, and independent providers will work collaboratively to efficiently use available resources and to the extent possible, reduce the need for overtime. To that end, an independent provider will inform an individual's service and support administrator of the number of persons for whom the independent provider provides any medicaid-funded services as an independent provider anywhere in the state and the number of hours of services the independent provider provides in a work week for each such person:





