NOTES:

Although the 2026-2027 Instructional Calendar identifies five (5) 'floating' workdays, **all certificated employees will continue to work three (3) teacher workdays each school year** as follows, with the exception of Counselors, Social Workers, Psychologists, Special Services, and Speech Therapists (see below).

TEACHER with the exception of SPECIAL SERVICES (Health Educator, SPED Teacher, Induction TSA)

All Certificated Teachers must work one (1) teacher workday in August before the first day of school. Certificated Teachers may choose which day to work between August 3 and the first Staff Development Day of the year.

Among the four (4) remaining 'floating' workdays identified in pink on the calendar (October – June), **all certificated teachers must report to work on two (2) of these four (4) days.** Certificated teachers may choose which days to work based upon their professional needs.

COUNSELOR, SOCIAL WORKER, PSYCHOLOGIST

Certificated staff listed above will work ALL of the August 'floating' workdays as part of their regular duty year schedule.

Among the four (4) remaining 'floating' workdays identified in pink on the calendar (October-June), all certificated staff listed above **must report to work on three (3) of these four (4) days**, in order to fulfill the number of required workdays listed in the calendar chart above. Certificated staff listed above may choose which days to work based upon their professional needs.

SPEECH THERAPIST

Certificated staff listed above will work August 4-7 'floating' workdays as part of their regular duty year schedule.

Among the four (4) remaining 'floating' workdays identified in pink on the calendar (October-June), all certificated staff listed above **must report to work on three (3) of these four (4) days**, in order to fulfill the number of required workdays listed in the calendar chart above. Certificated staff listed above may choose which days to work based upon their professional needs.

SPECIAL SERVICES (Health Educator, SPED Teacher, Induction TSA)

Bargaining unit members on the Special Services Salary Schedule may complete five (5) of their work days before the work year begins, during the work year or at the end of the work year.

Among the four (4) remaining 'floating' workdays identified in pink on the calendar (October-June), all certificated staff listed above **must report to work on three (3) of these four (4) days**, in order to fulfill the number of required workdays listed in the calendar chart above. Certificated staff listed above may choose which days to work based upon their professional needs.
