IPM statement

It is the goal of Imperial Unified School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

Our pest management objective is to focus on long term prevention through education, awareness, and responsible site practices. We aim to eliminate pest related health and safety risks to students, staff, and the public, while protecting district facilities and property from damage.

Pest management contracting

- Pest management services are contracted to a licensed pest control business.

- Prior to entering into a contract, the school district has confirmed that the pest control business understands the training requirement and other requirements of the Healthy Schools Act.

Pest identification, monitoring and inspection

Pest Identification is done by: Terminix of Imperial Valley

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by Terminix of Imperial Valley Licensed Staff and results are communicated to the IPM Coordinator.

Monitoring practices include routine visual inspections, removal of conducive conditions, and the use of sticky traps to track pest activity. These methods are implemented prior to considering any pesticide use.

Chemical pest management practices

Training

- School IPM training course approved by the Department of Pesticide Regulation (Education Code Section 16714; Food & Agricultural Code Section 13186.5).

Submittal of pesticide use reports

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt¹ from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at www.cdpr.ca.gov/schoolipm. (Education Code Section 16711)

¹ These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained baits or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
