If we are to assume lead abatement it should be noted to all bidders.
 - a. HazMat Report does not list any ACBM or LEAD at portables 28-30, see attached report.
- 3. What is the anticipated start date? Are these classrooms unoccupied currently?
 - a. As soon as possible, the classrooms are unoccupied.
- 4. Can the bid date be pushed to 08/12/25 instead of 08/07/25?
 - a. Current bid date to remain as 08/07/25 at 10:00 AM.
- 5. Ceiling tile specification for the acoustical ceilings? Match existing?
 - a. Match Existing ceiling tiles.
- 6. Can you resend the sign in sheet?
 - a. See attached Pre-Bid Sign in Sheet
- 7. Does this project require skilled and trained workforce?
 - a. Skilled and Trained Workforce does not apply to this design/bid/build project.
- 8. Is contractor pre-qualification required to bid?
 - a. No, contractor pre-qualification is not required.
