

Projected Revenue by Fund Source




This chart shows the total general purpose revenue Lassen County Office of Education expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Lassen County Office of Education is 14,278,969, of which 6,589,771 is Local Control Funding Formula (LCFF), 3,097,397 is other state funds, 3,170,531 is local funds, and 1,421,270 is federal funds.

COE LCFF Budget Overview for Parents




This chart shows the LCFF revenue Lassen County Office of Education expects to receive in the coming year.

The County Office Receives \$61,246.00 in Home to School transportation funds which are expended to provide Home to School Transportation for SELPA Special Education Students



The budgeted expenditures that are not included in the LCAP will be used for the following:



Plan Summary [2025-26]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA. LEAs may also provide information about their strategic plan, vision, etc.

Lassen County spans over 4,500 square miles and serves approximately 3,500 TK–12 students across ten school districts, three charter schools, and a community college. As a rural and frontier area, its school districts face both unique opportunities and challenges. The Lassen County Office of Education (LCOE) supports local educational agencies (LEAs) without charging fees, offering shared resources like curriculum, assessments, instructional practices, and professional development.

LCOE also manages the county's Special Education Local Plan Area (SELPA), supporting students with disabilities. SELPA operates one special education classroom—9–12—with a total of eight students, located on Lassen High School campus to facilitate inclusion. No English Learner (EL) or Long-Term English Learner (LTEL) students are currently enrolled in SELPA programs.

LCOE coordinates the Countywide Expelled Youth Plan and runs the Foster Youth Services Coordinating Program (FYSCP) in partnership with local probation and child welfare departments. This program supports 37 foster youth by promoting educational stability, readiness, and long-term success.

Neither LCOE nor SELPA receives Equity Multiplier Funds.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

According to the California School Dashboard, no schools or student groups in the county performed in the red (very low) on any state indicators. LCOE receives LCFF County Operations Grant funds but no supplemental or concentration funds. It provides ongoing regional support for continuous school improvement.

Lassen County Office of Education does not have any unexpended LREBG funds.

State Priority 1 – Basic Services

Lassen COE employs and assigns fully credentialed Special Education staff to provide services in the SELPA classroom.

Every student has sufficient access to standards-aligned instructional materials aligned with their IEP goals.

The classroom is located on the Lassen High School campus and is maintained in good repair, as reported in the district's Facilities Inspection Tool (FIT) report.

State Priority 2 – Implementation of State Standards

Due to the severity of disabilities among the students served, instructional programs are highly individualized based on each student's IEP.

Emphasis is placed on communication, socialization, life skills, and academic growth.

State Priority 3 – Parent Involvement and Family Engagement

Parents are invited and encouraged to attend all educational partner meetings and IEP meetings.

They receive regular communication and are included in the decision-making process regarding their child's education.

State Priority 4 – Student Achievement

Student academic progress is addressed through specific, measurable IEP goals.

Instruction is tailored to each student's unique learning needs and monitored regularly.

State Priority 5 – Student Engagement

Engagement is supported through individualized instruction and inclusive opportunities, as appropriate, on the Lassen High School campus.

Students' goals support meaningful participation and motivation.

State Priority 6 – School Climate

A positive school climate is maintained through personalized supports and collaboration with general education peers when appropriate.

The small class size allows for a supportive and structured learning environment.

State Priority 7 – Course Access

Students have access to a broad course of study through integration into general education classes when determined appropriate by their IEP team.

State Priority 8 – Pupil Outcomes

Student progress is evaluated through IEP goal achievement, reflecting both academic and functional skill development.

Outcomes are reported to families and reviewed regularly.

State Priority 9 – Coordination of Services for Expelled Youth

The COE is actively working to address gaps in services for expelled youth.

A collaborative referral and follow-up process is in place with community partners to support alternative education options.

Staffing shortages and the county's large geographic area remain barriers to developing County Community School placements.

State Priority 10 – Coordination of Services for Foster Youth

Lassen COE employs a full-time Foster Youth Coordinator.

The coordinator collaborates with probation and social services and has access to juvenile justice and child welfare databases.

Services are targeted to ensure foster youth receive consistent educational support.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

Lassen County Office of Education (LCOE) remains committed to supporting Foster Youth and expelled students through collaborative, data-informed strategies. Teachers, probation officers, Foster Youth Service Coordinators, parents, and students have prioritized ongoing efforts to meet the needs of Foster Youth. Stakeholders emphasized the importance of identifying new opportunities for collaboration, particularly in connecting tutoring programs more directly with school sites. Surveys of Foster Youth indicate that students feel supported and connected to their schools through tutoring and other services currently in place. These efforts continue to guide LCOE's goals, metrics, actions, and expenditures to support this vulnerable population.

Community stakeholders, including district superintendents and local leaders, have also stressed the need to develop innovative and equitable educational options for Lassen County's expelled youth. The geographic size of the county, the low number of expelled students, and the wide variation in student age and grade level make it impractical to operate centralized or multiple educational sites. As a result, stakeholders have proposed solutions such as keeping expelled students at their school of attendance whenever it is safe and feasible to do so. This approach is informed by research indicating that removing students from school does not deter poor behavior, improve classroom safety, or support long-term academic or behavioral outcomes. In contrast, expulsion without interventions is linked to increased risk of arrest, incarceration, and repeated offenses.

Additionally, the county SELPA Director has verified that the actions outlined in these efforts align with the SELPA Annual Assurances Support Plan, ensuring appropriate support for students with exceptional needs. At present, no schools in Lassen County are eligible to receive Equity Multiplier Funds.

Priority 9: Expelled Pupils – COEs Only (Conditions of Learning)

An explanation of why the LEA has developed this goal.

Educational partners place a high priority on continuing to coordinated for of expelled youth. So that students may to continue to grow in the areas of self confidence, connectedness and the completion of assignments while developing a greater sense of connection at school and in their community and to develop innovative options to equitably provide high quality instruction to Lassen County's expelled youth.

In discussing the data and specific needs, conditions and circumstances of our expelled youth, educational partners identified and discussed the difficulties in offering educational options to students who have been expelled due to the broad scope of age and grade level, geographic location, and overall low numbers of expelled students. Lassen County's geographic size and comparatively small student population makes sharing a common location for the education of expelled students unfeasible, and the cost to establish and staff multiple programs to meet the needs of a handful of students is prohibitive, leading our stakeholders to explore more innovative solutions, including keeping expelled students at the school of attendance to the extent practicable and safe. Studies show that removing a student from school fails in deterring bad behavior or maintain classroom safety and decorum. Moreover, student expulsion without interventions and remediation undermines academic growth and leads to a significantly increased risk of arrest, conviction, imprisonment and probation, with a likelihood of repeated offenses.

LCOE has developed this goal to address what the research shows regarding students who are expelled and excluded from school. For many students, the behaviors leading to expulsion are indicators of needs, circumstances and conditions which can be identified and remediated within the school environment. In addition to providing counseling and other services and supports available to troubled students, school structures keep students in classrooms and off the streets, and engaging them with academic pursuits. LCOE will monitor progress of this goal through metric 1.1.

Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

LCOE made significant progress in foundational and strategic planning areas, notably in data use, gap analysis, and coordination with LEAs. However, more intensive supports and policy-level actions—such as placement options for high-risk students and formalized MOUs—are still in development or unaddressed. Continued focus on collaboration and long-term policy development will be essential to ensure educational equity and continuity for all expelled youth in the county.

There were no substantive difference in the planned actions or the implementation of these actions.

Challenges still exist in creating a Countywide option due to the large distances between LEA's.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Based on the 2023–2024 and 2024–2025 implementation data, the effectiveness of Lassen County's efforts to coordinate instruction for expelled youth has shown measurable improvement, particularly in foundational systems and inter-agency collaboration.

By 2024–2025, the county achieved full implementation in three of six key areas: data review (1a), identification of educational alternatives and strategies (1b), and coordination of the triennial plan with all LEAs (2). This indicates that LCOE has successfully built and operationalized systems to analyze expelled youth data, identify and fill service gaps, and work in partnership with school districts to ensure consistency and planning across the county.

However, progress in more complex or resource-dependent areas—such as identifying alternative placements for high-risk students (1c), ongoing policy development (3), and development of a Memorandum of Understanding (MOU) regarding partial credit (4)—has been slower. These components remain in the early stages or have yet to be addressed, limiting the system's overall responsiveness to students with higher levels of need.

In summary, Lassen County has been effective in laying a strong foundation for coordinating services for expelled youth, with robust data practices and district coordination in place. Moving forward, effectiveness will depend on deepening policy development and addressing logistical challenges like safe alternative placements and credit continuity to ensure equitable educational access for all expelled students.

LCOE developed this goal because foster youth are more likely to have been exposed to trauma, changed schools more often and are more likely to have less access to comprehensive assessments. Lassen County stakeholders place a high priority on continuing to address the academic and social-emotional needs of our Foster Youth. Recent data indicates that measures reflecting Foster Youth academic, engagement and culture gaps are closing, and LCOE is committed to continuing and improving upon this collaborative program in the coming three years. The supports and services provided in the actions below meet the individual child or youth's needs and are coordinated with local community and child welfare partners.

These actions will support LCOE in sustaining the coordination of services and progress will be monitored through metrics 2.1-8 below.

Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Lassen County made strong progress in supporting foster youth between 2023–2024 and 2024–2025. Key areas of collaboration, needs assessment, and data use (10A) advanced from ongoing to full implementation, and all components of capacity building and direct services (10B) reached full implementation. The county also fully met all juvenile court requests for education services (10C) and maintained strong systems for records transfer and postsecondary planning (10D).

However, participation in after-school tutoring (10E) declined from 54.5% to 39%, while Independent Living Program participation (10F) improved from 36.3% to 53%. Education Passports (10G) were completed for 100% of foster youth both years. FAFSA completion (10H) was low at 10% in 2023–2024 and not reported in 2024–2025. Continued focus is recommended for improving tutoring access and FAFSA support.

There were no substantive difference in the planned actions or the implementation of these actions.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There material difference between Budgeted Expenditures and Estimated Actual Expenditures or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services were due to spending more for the coordinator because we increased the coordinator to a fulltime position and we spent less on tutor's because we had less students taking advantage of the program.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Lassen County's coordinated services for foster youth have shown high overall effectiveness, with most key components reaching full implementation by 2024–2025. Strong interagency collaboration, data-driven decision-making, and responsive service delivery indicate that the county has built a solid infrastructure to support educational stability and success for foster youth. The full implementation of direct services, court coordination, and postsecondary planning further highlights the system's ability to meet complex needs efficiently.

Effectiveness is also reflected in the consistent 100% completion rate of Education Passports and the significant increase in Independent Living Program participation. However, areas needing improvement include after-school tutoring participation, which declined, and FAFSA completion, which remains low or unreported. These gaps suggest the need for targeted outreach and support strategies. Overall, the program is largely effective, with clear strengths and some opportunities for refinement.

• 10. Total Percentage to Increase or Improve Services for the Current School Year: This percentage will not be entered. The percentage is calculated based on the amounts of the Estimated Actual LCFF Base Grant (9) and the Estimated Actual LCFF Supplemental and/or Concentration Grants (6), pursuant to 5 CCR Section 15496(a)(8), plus the LCFF Carryover – Percentage from the prior year. This is the percentage by which services for unduplicated pupils must be increased or improved as compared to the services provided to all students in the current LCAP year.

Calculations in the Action Tables

• Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)

 This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).
